I. Progress Report re Fire Incident at Barangay Poblacion, Lanao del Norte (Region X)

A. SITUATION OVERVIEW

- On 12:20 PM, 29 August 2018, a fire incident occurred at a residential/commercial buildings in Purok 1A, Barangay Poblacion, Linamon, Lanao del Norte.
- The fire started at 12:20 PM, 29 August 2018 and declared fire out at 2:29 PM, same day.
- The cause of fire is yet to be determined.

B. EFFECTS

- A total of 73 families were affected due to fire incident:

- OCDRO-X provided food items good for 7 days to 73 affected families.
- DOH RO X conducted daily consultation at the evacuation center and augmented jerry cans and medications.
- A total of 55 houses were damaged, of which 54 houses were totally damaged and 1 house partially damaged.
- The estimated cost of damages amounting to PhP8,000,000.00.

C. ACTIONS TAKEN

- BFP Iligan, Bacolod, Kauswagan together with AFP, PNP, PDRRMO Lanao del Norte, MSWDO Linamon, Red Cross Tanker, Barangay Poblacion Officials and Volunteers responded to the incident.
- PDRRMC, PSWDO Lanao del Norte, MSWDO Linamon, Brgy. Poblacion, Linamon provided family packs and conducted feeding program to the affected families.

II. Incident Report re Internally Displaced Population (IDPs) in Buenavista, Agusan del Norte (CARAGA Region)

A. SITUATION OVERVIEW

- On 28 August 2018, as per report from the Municipal Social Welfare and Development Officer of Buenavista, Agusan del Norte a number of families evacuated in Molave Multi-Purpose Hall, Brgy. Molave, Buenavista, Agusan del Norte due to an ongoing military clearing operation.
- However, there was no reported armed encounter that transpired during the said operations.

B. EFFECTS

- A total of 42 families were affected due to an ongoing military clearing operation:

C. ACTIONS TAKEN

- LGU of Buenavista, Agusan del Norte provided Family Food Packs (FFP) to support the needs of the IDPs as they stay in the evacuation center.
- DSWD Field Office through the DRMD is in close coordination with the MSWDO of Buenavista, Agusan del Norte.

III. Initial Report re Fire Incident at Sea (Vicinity of Argao Port, Cebu)

A. SITUATION OVERVIEW

- On 10:15 AM, 02 September 2018, a fire incident occurred on MV Lite Ferry 28 (a passenger vessel) with 300 meters distance from the port of Argao.
- The fire started at 10:15 AM, 02 September 2018 and fire suppression is on-going as of 12:30 PM.
- The cause of fire is yet to be determined.

B. EFFECTS

- A total number of passengers is yet to be determined.

- OCDRO-VII coordinated with the Coastguard District Central Visayas, MDRRMO Argao and Cebu PDRRMO re the information regarding the fire incident occurred at the vicinity of Argao Port, Cebu and the corresponding response actions by concerned agencies/LDRRMOs.
- The estimated cost of damages is yet to determined.

C. ACTIONS TAKEN

- PCG Central Visayas, BFP Argao and Sibonga (Cebu) and MDRRMO Argao to the incident.
- Cebu PDRRMO on their way to incident area to assist in providing the needs of the passengers.

IV. Initial Report re Fire Incident at Sitio Kahapan Brgy. Poblacion, Bongao, Tawi-Tawi

A. SITUATION OVERVIEW

- At around 02:00 PM, 02 September 2018, a fire incident occurred at a residential area in Sitio Kahapan, Brgy. Poblacion, Bongao, Tawi-Tawi.
- The fire started at around 02:00 PM.
- The cause of fire is yet to be determined.

B. EFFECTS

- A total of 73 families were affected due to fire incident:

- A total of 10 houses were burned and no civilian casualties reported.
- The estimated cost of damages os yet to be determined.

C. ACTIONS TAKEN

- OCD ARMM coordinated with MDRRMO Bongao and PDRRMO Tawi-Tawi re the fire incident in the area.
