ILOCOS NORTE - particularly Bulu, Banban, Bacarra-Vintar, Laoag and Quiaoit. LA UNION - particularly Amburayan, Bararo, Lower Bauang and Aringay.

PUBLIC WARNING:

With this development and unless significant rain occurs, this is the general flood advisory for this event.

In order to better inform/warn communities, you are reminded to disseminate these through local/community leaders and through your local media, including community radio stations.
