### I. Fire Incident at Brgy. Culasi, Roxas City, Capiz

#### A. Situation Overview:

- At 12:54 PM, 21 February 2019, a residential fire occurred at Poblacion Dos, Brgy. Culasi, Roxas City, Capiz. At about 2:08 PM the fire was declared under control and declared fired out at 4:35 PM of the same day.
- Initial investigation showed that the fire started from one of the houses located in the center part of the burned area. Said house was made of light materials and owned by Ms. Teresa Panaguiton.

#### B. Effects:

- A total of **54 families** were affected
- Forty-three (43) residential houses were damaged

#### C. Actions Taken:

##### RDRRMC VI

- In close coordination with PDRRMO Capiz & Roxas City Fire Station.
- Continuous monitoring.

### II. Situation Report 2: Fire Incident at Purok 4, Isla Verde, Brgy. 23-C, Davao City

#### A. Situation Overview:

- At 1:12 PM, 20 February 2019, a fire incident occurred at Purok 4, Isla Verde, Brgy. 23-C, Davao City. The said incident declared fired out at 4:52 PM.
- Ongoing investigation still being conducted to determine the cause of the incident.

#### B. Effects:

- A total of **five hundred forty – two (542) families or two thousand five hundred eighty six (2,586) individuals** were affected
- **Eleven (11) partially and two hundred sixty- one (261)** totally damaged houses,

- Affected families are taking shelter at Brgy. 23-C Basketball Gym and others were brought at Maritime Sta. Ana Warf.

### C. Actions Taken:

- BFP with Davao Central 911 Fire Auxiliary Service and fire volunteers conducted fire suppression;
- Davao City CDRRMO indorsed to CSSDO 300 mosquito nets and 100 plastic mats as their initial assistance on the affected families;
- CSSDO conducted validation and assessment on the affected families and their situation;
- CSSDO deployed mobile kitchen for food provision in the evacuation area;
- DSWD XI conducted relief operations to the affected families;
- DSWD XI closely coordinating with the CSSDO and CDRRMO to be able to provide augmentation assistance once requested;
- OCD XI coordinated with Davao City DRRMO, BFP XI an DSWD XI for situation update.

## III. Progress Report re Fire Incident in Addition Hills, Mandaluyong City

### A. Situation Overview:

- At 1615H, 22 February 2019, a fire incident was monitored at Blk. 22 Extension, Barangay Addition Hills, Mandaluyong City. Fire reached up to 5<sup>th</sup> alarm.
- Declared fire out at 2212H 22 February 2019
- Involved residential houses (informal settlers)

### B. Effects:

#### 1. Injured

d. Annafe Malulot	Female, 32 y/o	Suffered laceration on her right foot and abrasion on her left elbow
e. Reynaldo Tumco	Male	Suffered punctured wound on his left foot; and
f. Nysol Palomeras	Female, 4 y/o	Was rescued and was pulled out of the burning house by their neighbour at the house where the fire allegedly originated.

- Estimated cost of damage is ₱2,500,000.00 more or less

## 2. Status of Families /Individuals affected

- Approximately 900 families were rendered homeless
- Families affected were temporarily sheltered at:

### C. Actions Taken:

- OCD-NCR coordinated with JTF-NCR, PAF-505<sup>th</sup>, Philippine Disaster Resilience Foundation (PDRF), Department of Transportation (DOTr), Civil Defense Action Group (CDAG) and former General Manager of MMDA Corazon Jimenez for bucket helicopter support requested by the BFP Mandaluyong Ground Commander.
- BFP Mandaluyong and fire volunteers conducted fire suppression.
- Mandaluyong City Mayor and Mandaluyong DRRMO and rescue teams were on site to manage the incident.
- Mandaluyong CDRRMO
  - Convene DRMM Council;
  - Established ICP in Blk. 6 ( in front of towing), Martinez St., Mandaluyong City;
  - Dispatched all barangays' fire volunteers and ambulances;
  - Dispatched traffic enforcers to manage the traffic situation and rerouting;
  - Dispatched PNP personnel and barangay tanods for crowd control and security in the area;
  - Requested additional responders from nearby LGUs DRMMOs;
  - Requested helibucket from OCD NCR;
  - Continuous monitoring of the situation; and
  - Ready evacuation center.
- MMDA dispatched one (1) ambulance and one (1) fire truck
- Pasig City dispatched six (6) fire trucks and thirteen (13) volunteer groups

## IV. Fire Incident Report at Delpan, Tondo, Manila

### A. Situation Overview:

- At 2317H, 22 February 2019, a fire incident was monitored at a residential area at Area 1, Balon Gate 1, Pier 2, Brgy. 20, Zone 2 District 1, Delpan, Tondo, Manila.
- Declared fire out at 0620H 23 February 2019

### B. Effects:

#### 3. Status of Families /Individuals affected

- A total of 374 families affected or equivalent to 1,417 individuals
- Delpan Evacuation Center serves as the evacuation center for the affected families.

### C. Actions Taken:

- OCD NCR coordinated with Manila Fire District 1 for the initial information and requested for Spot Investigation Report.

- Manila CDRMO submitted information on the status of affected information.
- Manila Department o Social Welfare leads in Camp Coordination and Management;
- Barangay Officials immediately assisted the affected families and secured the place to maintain peace and order in the area.

#### **IV. Fire Incident Report at BF Martinville, Barangay Manuyo Dos, Las Piñas City and Sitio San Roque, Brgy. San Isidro, Parañaque**

##### **A. Situation Overview:**

- At around 12:16PM, 22 February 2019, a fire incident was monitored at a residential area at BF, Martinville, Brgy. Manuyo Dos, Las Piñas City; Fire Under Control reported at 1:41PM;
- At 1652H, 22 February 2019, it was declared fire out.
- Cause of fore is still under investigation.

##### **B. Effects:**

- A 62 years old male was injured.
- Estimated 140 families in Las Piñas and Parañaque were affected or approximately 590 individuals.
- 30 houses were affected in Parañaque and 40 in Las Piñas

##### **C. Actions Taken:**

- Thorough assessment and validation are on-going by the City Social Welfare Department. Las Piñas Local Government opened Brgy. Manuyo Dos Covered Court as Evacuation Center to cater affected families.
  - FO-NCR is continuously coordinating with Las Piñas City Social Welfare Department for updates and request for augmentation assistance.
  - OCD-NCR coordinated with Las Piñas DRRMO, Parañaque CDRMO. Las Piñas BFP and Parañaque BFP.
