# I. Progress Report re Fire Incident in Cainta, Rizal

# A. Situation Overview:

- At around 5:05 PM, 03 February 2019, a fire incident transpired in San Buena Compound and Gruar Subdivision at Brgy. Sto. Domingo, Cainta, Rizal.
- Fire was declared under control at 9:00 PM of the same day.

#### B. Effects:

#### AFFECTED POPULATION:

- A total of 623 families / 2,504 persons were affected by the incident. Of which, 286 families/1,303 persons are currently staying in 2 evacuation centers. The other affected families opted to stay with their relatives.
- Two (2) evacuation centers are still open namely: (1) Riverside Covered Court and (2) Marick Covered Court. Evacuation Centers in Rizal Institute and Gruar Covered Court were already closed on 08 February 2019.

#### DAMAGED HOUSES:

 A total of 524 houses were damaged. Of which, 517 were totally damaged and 7 houses were partially damaged due to fire.

#### CASUALTIES:

A total of two (2) dead were reported.

# C. Actions Taken:

#### RDRRMC IV-A

 Coordinated with PDRRMO Rizal, MDRRMO Cainta, and BFB IV-A regarding the incident.

#### DSWD VI-A

- The Disaster Response Management Division (DRMD) of DSWD IV-A coordinated with Cainta, Rizal for significant reports on the status of affected families, assistance and relief efforts.
- DSWDO FO IV-A through the DRMD coordinated with MSWDO Cainta, Rizal for significant disaster response updates and assistance provided.
- Advised the Municipal Social Welfare and Development Office (MSWDO) to maintain vigilance and ensure prompt and effective delivery of basic emergency services.

# Municipal Social Welfare and Development Office (MSWDO)

- Conducted assessment to the affected families.
- Conducted profiling to determine the total number of affected families and to identify their needs;

#### RIZAL PDRRMO

 Deployed personnel on the ground to conduct validation and assessment on the needs of the affected population to determine the possible assistance to be provided.

#### **MDRRMC**

- BFP Cainta and other nearby municipalities and cities responded to the incident.
- Provided family food packs, hot meals and non-food items (folding beds) to affected families;
- · Provided construction materials to the affected families.

# II. Progress Report re Fire Incident in San Pedro City

#### A. Situation Overview:

- At around 6:45 PM, 14 February 2019, a residential fire transpired at Sitio Masayahin, Brgy. San Antonio, San Pedro City, Laguna due to electrical wire layout in one of the houses.
- Fire out was declared at 11:39 PM, 14 February 2019.

#### B. Effects:

# AFFECTED POPULATION:

 A total of 64 families / 320 persons were affected and currently staying in San Pedro Town Center Evacuation Center in Barangay San Antonio, San Pedro City.

#### C. Actions Taken:

#### RDRRMC IV-A

 Coordinated with DSWD IV-A, CDRRMO San Pedro, and BFP IV-A regarding the incident.

#### DSWD IV-A

- Coordinated with the City of San Pedro for significant reports on the status of affected families, assistance and relief efforts.
- Coordinated with City Social Welfare and Development Office (CSWDO) and City Disaster Risk Reduction Management Office (DRRMO) for the distribution of 64 family food packs amounting to P19,909.12 and 64 hygiene kits amounting to P114,422.40. A total of P34,331.52 relief goods were provided to the affected.
- Coordinated with the City of San Pedro for significant reports on the status of affected families, assistance and relief efforts
- Coordinated with CSWDO San Pedro for possible augmentation of Food and Non-Food Items.
- Disaster Response Management Division (DRMD) coordinated with CSWDO San Pedro and provided technical assistance on the management of donation in the evacuations centers.

#### **CSWDO San Pedro**

- CSWDO in partnership with CDRRMO, BHW and PNP managed the evacuation center which was provided by the International Organization for Migration and the EC 2417 on shifting basis to maintain law and order, security, and provision of needs of the survivors.
- Provided the affected families with food packs.
- City Health Office have provided the affected families with free check-up and consultation. Medicines were also provided to families needing medical assistance.

# City Government of San Pedro, Laguna

- Conducted an assessment to determine assistance that the LGU may provide such as financial assistance for Balik Probinsya and house rental.
- LGU established Internally Disabled Person committees to assist them in the maintenance of EC and other activities.
- Provided sleeping kits, hygiene kits and jerry cans to the affected families.
