### **1. Initial Report re: Vehicular Accident in Naguillian, La Union Region I**

#### **A. Situation Overview:**

- On our about 10:30 AM of 18 March 2019, a Vehicular Accident (VA) transpired at Bauang-Baguio Road, Angin, Naguilan, La Union.
- The incident involved two (2) vehicles (Leo Minibus and a dump truck), a total of 21 affected to the accident.
- Both vehicles were traversing Bauang-Baguio Road Heading west direction when the minibus bumped the truck from behind.
- The minibus then swerved to the left lane and hit an Acacia Tree.
