I. Progress Report re Fire Incident in Brgy. Damayan Lagi, Quezon City

A. Situation Overview:

- At around 1:27 PM, 20 March 2019, a fire incident happened at a three (3) storey residential house at Blk. 5, Brgy. Damayan Lagi, 205 E. Rodriguez Ave., Quezon City.
- Cause of fire is still under investigation.

B. Effects:

AFFECTED POPULATION:

- A total of **1,044 families/5,874 persons** were affected and were temporarily sheltered to the nearby basketball court of said barangay.
- Pop huts were set-up to cater affected families while others opted to stay with their relatives.

CASUALTIES:

- A total of **9 injured were reported**, of which 1 is female and 8 are male.

COST OF DAMAGES

- A total of **PhP 2,500,000.00** cost of damages were reported.

DAMAGED HOUSES

- A total of **429 houses** made of concrete and semi-concrete materials were totally damaged by the fire.

C. Actions Taken:

- OCD NCR coordinated with BFP and DRRMO Quezon City and requested for Spot Investigation Report. Also, coordinated with DSWD DROMIC NCR for assessment and validation of the affected families using Disaster Family Access Card (DAFAC).

- Quezon City Social Services Development Department (QCSSDD) provided relief items and hot meals to affected families.

II. Initial Report re Fire Incident in Mabini Boulevard, Davao City

A. Situation Overview:

- At 1:20 PM, 25 March 2019 a fire incident occurred at Purok 1&2, Brgy. 37-D, Mabini Boulevard, Davao City.
- Fire out was declared at 3:30PM of the same day.
- The cause of fire was unattended butane.

B. Effects:

AFFECTED POPULATION:

- A total of **79 families / 405 persons** were affected.

DAMAGED HOUSES

- A total of **29 houses were damaged**, of which 25 houses were totally damaged and 4 houses were partially damaged.

C. Actions Taken:

- OCD XI coordinated with BFP XI, DSWD XI, and Davao City DRRMO re the incident.
 - BFP XI, Central 911, and USAR responded to the incident.
 - CDRRM Davao City coordinated with CSSDO for further validation & assistance to the affected families.
 - CSSDO provided Family Food Packs and Non-Food Items to the affected families.
