#### I. FIRE INCIDENT AT BRGY. BAKHAW MANDURRIAO, ILOILO CITY

#### A. Situation Overview:

- On 5 March 2019 at 5:29 PM, fire gutted residential houses at Brgy. Bakhaw Mandurriao, Iloilo City. Cause of fire is still under investigation.
- The fire was declared out at 7:43 PM same day.

## B. Effects:

### 1. AFFECTED POPULATION:

 Initial number of affected families is 16 or 62 individuals. Further, 6 families or 24 individuals are in evacuation centers.

#### 2. CASUALTIES:

• The fire incident left one (1) dead and four (4) injured individuals.

### C. Action/s Taken:

#### RDRRMC VI

Continuous monitoring of the AOR.

#### **Iloilo City Fire Station**

 Responded immediately to the area together with Amity and Chamber Volunteer Fire Brigade.

#### **CDRRMC Iloilo City**

Deployment of two (2) units (Medic 9 and QRV1)

#### **CSWDO** Iloilo City

Immediate distribution of food packs for 15 days to the affected families.

• Immediate assistance for the identification of evacuation center for the affected families.

# II. BELATED REPORT RE: RAN AGROUND VESSEL M/V GRAND VENTURE IN BRGY. BAGACAY, ROMBLON, ROMBLON

# A. Situation Overview:

- On 4 March 2019 at around 2:15 AM, M/V Grand Venture ran aground at the shoreline/seawall of Brgy. Bagacay in Romblon, Romblon while maneuvering to dock at the port. The said passenger vessel skippered by Captain Villard Ramilo left the port of Batangas on 3 March at around 3:00 PM enroute the Romblon port. Onboard were 244 passengers and 34 crew members.
- One (1) passenger Alvin Mendez Martos, 35 years old, was injured and immediately brought to the Romblon General Hospital; and was later on transferred to Batangas City for medical attention.
- The vessel also rammed the MBCA of the DPWH, No reported casualty.
- Joint response teams composed of the PCG, PNP-MG, Romblon MPS, PDRRMO Sea Ambulance, MDRRMO, among others were dispatched to render necessary assistance.
- Initial inspection showed no traces of oil spill. Notwithstanding this, a meeting was conducted to check on the status of the vessel's hull and engine operation considering the degree and impact of the incident.

#### B. Action/s Taken:

 OCD MIMAROPA coordinated with Coast Guard District Southern Tagalog and Coast Guard Station Romblon regarding said incident.
