I. Initial Report re Fire Incident at Obando, Bulacan (Region III)

A. Situation Overview:

- At 8:35 PM, 03 April 2019, a fire incident occurred in Brgy. Salambao, located at the coastal area of Obando, Bulacan.
- Fire out was declared at 10:55 PM on the same date.
- The cause of fire is still under investigation.

B. Effects

AFFECTED POPULATION

- A total of **69 families / 237 persons** were affected by the fire incident.

DAMAGED HOUSES

- A total of **69 houses were damaged**. Of which, **63 houses** were totally damaged, while **6 houses** were partially damaged.

STATUS OF LIFELINES

- Electricity and Water were cut-off.

COST OF DAMAGES

- An estimated ₱9,000.00 worth of agricultural (livestock) damages were incurred.

C. Actions Taken:

OCD/RDRRMC III

- Continuously monitoring the situation and coordinated with Obando MDRRMO, Obando Fire Station, and DSWD FO III for situation updates.

DSWD III

- Conducted profiling of affected families and deployed personnel for validation and assessment on the needs of the affected population.
- In close coordination with DSWD Provincial Extension Office in Bulacan for updates and actions taken.
- Provided Emergency Assistance to the affected families based on the current needs.

MDRRMO Obando

- Assisted in the distribution of relief assistance to the affected population.
- Established Incident Command Post.

Obando Fire Station

- Provided report to OCDRO III re the incident.
- Currently conducting an investigation regarding the cause of fire.

II. Initial Report re Fire Incident at Brgy. Santa Clara, Batangas City (CALABARZON)

A. Situation Overview:

- At 5:52 PM, 06 April 2019, a fire incident occurred in a residential area in Brgy. Santa Clara, Batangas City.
- Fire was under control at 8:55 PM and was declared fire out at 11:00 PM on the same day.
- The cause of the fire is still under investigation.

B. Effects:

- There were no casualties reported.
- A total of 204 families / 945 persons were affected and evacuated at the Batangas City Stadium.

C. Actions Taken:

OCD/RDRRMC CALABARZON

- Continuously coordinating with BFP CALABARZON, Batangas PDRRMO, and Batangas CDRRMO regarding the incident.

DSWD FO CALABARZON

- Coordinated with Social Welfare and Development (SWAD) Batangas and Pantawid Pamilyang Pilipino Program (4Ps) City Link assigned in the area, and are advised to monitor and coordinate with the Batangas CDRRMC to gather reports on the effects of the incident.
- Informed the member-agencies of the response cluster to be on alert status and be ready for mobilization in case situation arises.

DSWD FO CALABARZON Disaster Response Management Division (DRMD)

- Closely coordinating with the LGU regarding their response efforts and assistance provided.
- Continuous coordination with Batangas City Social Welfare and Development Office (CSWDO) and provided technical assistance on the management of the evacuation center.

DSWD FO CALABARZON Regional Resource Operation Section (RROS)

- Ensured the availability of Family Food Packs (FFPs) and Non-Food Items (NFIs) should need arises.

CDRRMC BATANGAS

- Mobilized and deployed RDANA personnel on the ground to conduct validation and assessment on the current needs of the affected population to determine the possible assistance.

Batangas CSWDO

- Provided hot meals and conducted profiling to the affected families and packed relief goods for distribution.
