I. Initial Report: Fire Incident at Purok 9-B, Adecor Compound, Brgy. Poblacio9n, Maco, Compostella Valley

A. Situation Overview:

 On or about 18 April 2019 around 03:30 AM, a fire incident occurred at Purok 9-B, Adecor Compound, Brgy. Poblacion, Maco, Compostella Valley. Said incident was declared fire out at 04:30 AM.

B. Effects:

- Two (2) houses were damaged.
- Six (6) casualties namely:
 - 1. Carmen Bilucora
 - 2. Ian Bilucora
 - 3. Rico Bilucora
 - 4. Jane Doe
 - 5. Janjan Bilucora
 - 6. A 6 months old baby
- The estimated cost of damage is ₱300,000.00.

C. Actions Taken:

- OCDRO XI
 - coordinated with PDRRMC Compostella Valley and BFP XI for situation update
 - Closely monitoring its AOR for any untoward incident

BFP Compostella Valley

- responded and conducted fire suppression to the affected houses

II. Terminal Report re: Heavy Rainfall with Strong Wind in Tacurong City, Sultan Kudarat

A. Situation Overview:

- On the afternoon of 09 April 2019, most of the areas in SOCCSKSARGEN experienced moderate to heavy rainfall for 1-2 hours brought about by localized thunderstorms. Due to the said incident, power interruption was experienced all over Tacurong City, Sultan Kudarat.
- On 12 April 2019, OCD XII with MGB XII and PDRRMO Sultan Kudarat in coordination with the CDRRMO of Tacurong City conducted Damage Assessment and Needs Analysis (DANA) in the affected areas.

- SULKECO (Sultan Kudarat Electric Cooperative) restored the affected powerlines.
- CDRRMC Tacurong held a meeting last 12 April 2019 to discuss the prioritization of assistance to be given to affected families.

III. Belated Report re Fire Incident in Manggahan II, Brgy. Merville, Parañaque City

A. Situation Overview:

 On 06 April 2019 at around 06:54 PM, a fire broke out at Manggahan II, Merville, Parañaque City involving residential shanties. Said incident reached 2nd alarm and was declared fire out at around 09:31PM.

B. Effects:

- No reported casulaties.
- · Approximately 15 residential shanties were damaged.
- · Thirty families were affected

C. Actions Taken:

BFP NCR

• responded to the incident with 11 fire trucks and 6 ambulances.
