I. Initial Report re Vehicular Accident in Tagkawayan, Quezon (CALABARZON)

A. Situation Overview:

- On 17 May 2019, 12:30 AM, a vehicular accident occurred along Quirino Highway Brgy. San Diego, Tagkawayan, Quezon, involving a passenger bus. Said vehicle was traversing the curved portion of the road heading towards North when it lost control and subsequently collided to a garage where 2 motorcycles were temporarily parked. The victims sustained physical injuries and was rushed to the hospital for medical assistance.

B. Effects:

CASUALTIES

- A total of **nineteen (19) persons were injured** due to the incident.

C. Actions Taken:

- OCD CALABARZON monitored the incident and immediately coordinated with Tagkawayan DRRMO, PDRMO Quezon, and PRO IV-A RTOC.
- Tagkawayan DRRMO immediately responded to the incident and provided medical assistance.
- BFP Tagkawayan provided medical assistance and security measures on the damaged passenger bus.
- PNP Tagkawayan conducted investigation at the place of incident.

II. Initial Report re Vehicular Incident in Babatngon, Leyte (REGION VIII)

A. Situation Overview:

- On 17 May 2019, 6:15 AM, a vehicular accident at National Highway, Sitio Tabang, Brgy. District III, Babatngon, Leyte, was reported to the Municipal Police Station

B. Effects:

- A total of **8 dead and 14 injured** were reported due to the incident.

C. Actions Taken:

- OCD VIII coordinated with LGU Babatngon and DOH HEMS regarding the vehicular incident.
- PNP-MPS Babatngon responded to the vehicular accident and conducted investigation.
- LGU Babatngon dispatched BDERT Ambulance and RHU Personnel to the vicinity of the accident and provided medical assistance to the injured victims.
- DRRM Barugo, San Miguel, Tacloban Rescue Unit, Tacloban Delta Volunteer, BFP Babatngon, Leyco 2, and DPWH responded to the vehicular accident.

III. Progress Report re Food Poisoning in Impasog-ong, Bukidnon (REGION X)

A. Situation Overview:

- On 16 May 2019, 07:45 AM, **233** delegates from the 8th National Youth Convention held by the Seventh Day Adventist at the Center for Ecological Development and Recreation (CEDAR) in Impasog-ong, Bukidnon, experienced vomiting, and loose bowel movement with fever. LDRRMC Impasog-ong transported most of the affected delegates to the hospitals in Malaybalay City while others were treated at the CEDAR Covered Court by the Rural Health Unit of Impasog-ong and Sumilao.

B. Effects:

- A total of **233 persons** were victims of the suspected food poisoning.

C. Actions Taken:

- OCDRO10 conducted monitoring and coordination for response with concerned LGU.
 - DOH Center for Health Development-Northern Mindanao (CHD-NM) Research Epidemiology, Surveillance and Disaster Response Unit (RESDRU) coordinated with LGU Health Units of Malaybalay, Impasug-ong and Sumilao and deployed DOH 10 Response team to ensure that the victims of food poisoning are given the proper care and to investigate the cause.
 - LGU Impasug-ong activated the Incident Command System and provided transport of affected delegates to various hospitals in Malaybalay City.
 - Rural Health Units were deployed to treat delegates at CEDAR Covered Court.
 - LGU Sumilao Rural Health Unit assisted LGU Impasug-ong in treating affected delegates at the CEDAR Covered Court.
