### 1. Initial Report re Flooding incident in Maguindanao (BARMM)

#### a. Situation Overview:

- A total of three (3) municipalities in the province of Maguindanao experienced flooding due to continuous light to moderate rains.
  - On 06 June 2019, flooding incident was reported affecting twelve (12) barangays in the municipality of Sultan sa Barongis
  - On 09 June 2019, flooding incident was reported affecting nine (9) barangays in the municipality of Datu Salibo
  - At about 10:49 AM, 17 June 2019, the municipality of Datu Piang experienced flooding due to continuous light to moderate rains. Validation and assessment is still ongoing

#### b. Effects:

- A total of **8,991 families / 44,955 individuals** in 21 barangays in the municipalities of Sultan sa Barongis and Datu Salibo were affected:

### c. Actions Taken:

- OCD BARMM coordinated with MDRRMOs Sultan sa Barongis and Datu Salino re the incident, with P/MSWDO re number of affected families, and with PDRRMO Maguindanao re updates on the situation.
- PSWDO-Maguindanao and affected MDRRMCs conducted monitoring, assessment, and validation to the affected barangays.

## 2. Final Report re Maritime Collision incident in Reed Bank

### a. Situation Overview:

- On 10 June 2019, a Chinese fishing vessel collided with a Filipino fishing boat F/B GIMVER 1 at the vicinity of Reed Bank or approximately 143.38NM off long point of Brgy. Bacungan, Puerto Princesa City, Palawan.
- All twenty-two (22) Filipino fishermen onboard were rescued safely by a Vietnamese fishing vessel and were transferred to another fishing boat F/B THANKSGIVING.
- Philippine Navy PS16 carried onboard the rescued crew for transportation to San Jose, Occidental Mindoro with assistance from PCG Personnel. They arrived at Caminawit Port, San Jose, Occidental Mindoro on 14 June 2019
- BRP Tausug (LC 295) fetched the fishermen onboard PS16 and ferried them to Caminawit Port, San Jose, Occidental Mindoro.
- At about 1:30 PM, 14 June 2019, the Philippine Navy Vessel, BRP Tausug (LC 295) with Commander NAVFORSOL, the Regional Director of BFAR-MIMAROPA, personnel from the AFP, and Coast Guard Station Occidental Mindoro together with different media personnel onboard, departed from the port of Caminawit, San Jose, Occidental Mindoro enroute to BRP Ramon Alcaraz (PS-16) at the vicinity of Ambulong Island, San Jose, Occidental Mindoro to receive the fishermen.
- At 4:00 PM, LC295 docked alongside PS16 and all ships riders transferred to the latter for a press conference and for the proper turnover of the survivors from navy to BFAR. At around 5:30 PM, after the press conference and turnover, all participating agencies and media returned to LC 295 together with the fishermen
- At about 8:00 PM, LC 295 arrived at the Port of Caminawit and all ships rider and the survivors safely disembarked. All survivors were turned over



by BFAR MIMAROPA to CGS Occidental Mindoro. Part of the program conducted aboard Coast Guard Station Occidental Mindoro was the distribution of goods from San Jose LGU and BFAR to the survivors.

- At about 9:00 PM, MSCC personnel assisted by a PCG legal officer started the investigation on the incident through inquiry with the survivors. Present during the investigation were the owner of said fishing boat and one (1) CGPAO personnel who documented the whole process. At about 11:30 said investigation was concluded.

## **II. Actions Taken:**

- OCD MIMAROPA Field Officer for Palawan coordinated with Coast Guard District Palawan to gather information regarding the incident.
  - OCD MIMAROPA Field Officer for Mindoro Provinces coordinated with Occidental Mindoro LDRRMOs for updates on the status of the 22 fishermen.
  - OCD-RDRRMC MIMAROPA coordinated with PCG Southern Tagalog regarding the incident and is in close coordination with other agencies and LGUs concerned for other updates on this matter.
  - Philippine Red Cross Mindoro established first aid station and welfare desk at port.
  - DSWD MIMAROPA provided relief goods to affected families of 22 rescued fishermen
  - Municipal Health Office San Jose Occidental Mindoro provided medical assistance to rescued fishermen
