I. SITUATION OVERVIEW

01 July 2019

At 4:00 AM today, the center of Tropical Depression “EGAY” was estimated based on all available data at 195 km East Northeast of Aparri, Cagayan or 205 km East of Calayan, Cagayan (18.90°N, 123.4°E) with maximum sustained winds of 45 km/h near the center and gustiness of up to 60 km/h. It is moving Northwest at 40 km/h. Southwest Monsoon affecting Luzon and Visayas.

Rains with gusty winds due to TD Egay will be experienced over Batanes and Babuyan group of Islands. Cloudy skies with scattered rainshowers and thunderstorms is expected over the provinces of Aurora, Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Apayao, Abra, Benguet, Mt. Province, Ifugao, Kalinga, Isabela, Quirino, Nueva Vizcaya, and the rest of Cagayan caused by Southwest monsoon.

Moderate to strong winds coming from the Southwest will prevail over Northern Luzon and in Aurora Province. The coastal waters will be moderate to rough.

II. EFFECTS

A. Affected Population

1. A total of **60 families / 232 persons** were affected in **4 Barangays** in the two (2) Provinces of Region III.
2. Currently, a total of **40 families or 117 persons** were served inside and outside evacuation centers (ECs):
 - Inside **3 ECs: 35 families / 100 persons**
 - Outside ECs: **5 families / 17 persons**

III. DISASTER PREPAREDNESS

A. NATIONAL DRRM COUNCIL (NDRRMC)

1. NDRRM Operations Center (NDRRMOC)

- a. Continuous monitoring and ensure dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories to all concerned RDRRMCs/OCDROs through SMS, facsimile, and official social media websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs).

2. DOST-PAGASA

- a. Continuous weather monitoring and provision of weather updates.

3. DSWD

- a. The Disaster Response Management Bureau (DRMB) is on BLUE Alert Status and is closely coordinating with the concerned DSWD-Field Offices for significant disaster preparedness for response updates.

- b. All QRT members and emergency equipment are on standby and ready for deployment. The DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) have stockpiles and standby funds amounting to **₱1,974,755,075.16** with breakdown as follows (see Table 1):

o Standby Funds

A total of **₱1,174,771,923.28** standby funds in the CO and FOs. Of the said amount, **₱1,128,751,613.00** is the available Quick Response Fund (QRF) in the CO.

o Stockpiles

A total of **319,478 Family Food Packs (FFPs)** amounting to **₱122,137,558.80** and available **Food and Non-food Items (FNIs)** amounting to **₱677,845,593.08**.

4. DILG

- a. DILG recommended pre-emptive evacuation in areas with high to very high susceptibility to flooding and landslide as identified by PAGASA and DENR-MGB.
- b. DILG recommended that all LGUs which are not in the list of MGB's high to very high susceptibility to floods and rain-induced landslides but have recently experienced landslides, thunderstorms and heavy rainfalls be advised to take extra precautionary measures in conducting critical preparedness actions in anticipation for possible flooding, especially areas prone to landslide.
- c. CODIX continuously provided advisories and updates of TD EGAY to all DILG regional and field offices.
- d. DILG field offices relayed all advisories and updates of TD EGAY to all concerned LGUs.
- e. DILG regional and field offices recommended to all concerned LGUs the following actions.
 - Established critical preparedness actions based on the Operation

LISTO protocols and prioritize prepositioning of supplies and equipment for response.

- Activated Barangay DRRMCs for early warning measures and vigilant monitoring of areas with settlements at the base of sliding slopes or ridges with manifestations of rockslide/landslide, tension cracks, and areas identified as very high/critical landslide zones.
- Monitored and reported the impending weather disturbances and other incidents.
- Continuously inform/advise all communities thru but not limited to the local television channels and radio stations of the updates of the situation and preparedness actions of the localities.
- Monitored the levels of river water and settlements in low-lying areas or near riverbanks which have experienced recent and repeated flooding;
- Monitored the possible riverbank erosion and shift of river flow direction.
- Monitored and prepared the necessary preparedness actions for possible dam overflow and release of water that may affect the communities.
- Prepared implemented pre-emptive evacuation and forced evacuation, protocols, if necessary, in areas with high to very high susceptibility to storm surges, landslide and flood.
- Ensured communication lines are working.
- Restricted or banned tourist activities such as, but not limited to, mountaineering/hiking, surfing, and diving within their areas of jurisdiction during this period.
- Warned small-scale miners to stay in safer grounds and avoid any mining activities.

B. REGIONAL DRRM COUNCILS (RDRRMC)

RDRRMCs CAR, NCR, II, III, CALABARZON, and VI are continuously monitoring their areas of responsibility. Further, said RDRRMCs are in coordination with their respective member agencies to ensure the widest dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories through SMS, facsimile, and official social media websites.

1. RDRRMC CAR

OCD CAR

- a. Issued Cordillera RDRRMC Memo No. 31 s. 2019 to maintain the BLUE alert status of the Emergency Operations Center.
- b. Issued Cordillera RDRRMC Memo No. 27 s. 2019 alerting all P/ MDRRMOs regarding possible threats of the weather disturbance specifically to:
 - Utilize all Early Warning Systems (EWS) such as the use of Public Address Systems, Short Messaging System (SMS), social media, radio stations, and text blast systems to ensure the widest dissemination of timely weather and safety advisories.

- Ensure the implementation of pre-emptive evacuation in identified high risk areas.
- c. Issued an Advisory for public to refrain from doing outdoor activities (caving, spelunking, surfing, mountaineering and other similar activities) and avoid going to landslide and flood-prone areas.
- d. Revisit their respective Contingency Plans for Hydro-met hazards for possible activation and implementation.
- e. Continuous sending weather advisories and alert status to all stakeholders thru all means of communication.
- f. In close coordination with PAGASA Baguio Synoptic Station and continuously sending weather advisories to the public, LDRRMCs and member-agencies of the Cordillera RDRRMC.
- g. Continuous coordination with the Local Disaster Risk Reduction and Management Councils (LDRRMCs) in the region on weather status, road conditions, and reported incidents.
- h. Continuous sending of public advisories and warning alerts thru text blasts, social media accounts and in all available means of communication in partnership with PIA-CAR and local media outlets.
- i. Issued preparedness tips to prevent any possible eventualities due to the enhanced southwest monsoon and localized thunderstorms.

Department of Science and Technology CAR

- a. Continuous monitoring and maintaining of Community-Based Flood Early Warning Systems (CBFEWS) in coordination with LGUs and DOST-ASTI. Overall, DOST-CAR already installed 30 CBFEWS stations in CAR and 5 of them are defective as of reporting time (to be repaired).

PAGASA Baguio Synoptic Station

- a. Continuously monitoring the AOR and providing weather updates or forecast for dissemination.

Department of Social Welfare and Development Cordillera

- a. In close coordination with Armed Forces of the Philippines (AFP) for the utilization of their warehouses for prepositioning of various food and non-food items (NFIs) in CAR provinces.
- b. In close coordination with the PNP-PROCOR for mobility support and for the utilization of police stations as warehouses for the NFIs.
- c. Stand-by funds, prepositioned food, and Non-Food Items (NFIs) for possible response/augmentation.

Department of Public Works and Highways

- a. Continuously providing Situational Report on National Roads and Bridges.
- b. Prepositioned a total of 57 heavy equipment and 93 tools/light equipment owned by DPWH-CAR at the regional/ district engineering offices.
- c. Prepositioned 95 privately-owned heavy equipment all over CAR ready for possible augmentation.
- d. DPWH-CAR is maintaining its 24/7 monitoring of road status through the Maintenance Division.

Department Environment and Natural Resources CAR

- a. Continuously monitoring trees (dead or alive) posing danger for possible pruning/cutting.
- b. In close coordination with its local counterparts, electric cooperatives, and other stakeholder for monitoring and possible augmentation.

Commission on Higher Education CAR

- a. Continuously advising delegated safety officers in different colleges or universities to conduct safety inspection.
- b. On-stand by for possible monitoring of class suspensions.

Police Regional Office Cordillera

- a. On heightened alert and continuously monitoring the AOR.
- b. PNP-PROCOR personnel and capabilities/resources on standby for possible augmentation for response.

Bureau of Fire Protection Cordillera

- a. On heightened alert and continuously monitoring the area of responsibility.
- b. BFP-CAR personnel and capabilities/resources are on standby.
- c. On-call anytime to extend assistance or response in case of emergencies and other eventualities.

Philippine Information Agency Cordillera

- a. Continuous dissemination of public advisories and warning alerts to the public through text blasts, social media accounts, and various media outfits.

2. MMDRRMC NCR

OCD NCR

- a. Facilitated the conduct of PDRA Meeting on 26 June 2019 at the Metro Manila Crisis Management and Monitoring Center (MMCMMC) which was presided by the Senior Vice Chairperson, MMDRRMC and Regional Director, OCD-NCR.
- b. Continuous monitoring the situation.

DILG NCR

- a. Issued a Memorandum to all DILG NCR City Directors for the submission of preparedness measures within AOR.

DSWD NCR

- a. Prepositioned stockpile of commodities such as 6084 family food packs, 700 sacks of NFA rice, 8653 plastic mats, 6044 blankets, 12608 mosquito nets, 5072 family kits, 5221 dignity kits, 7759 hygiene kits, 5345 malong in Legarda and NROC.
- b. Standby funds of Php 3292543.50 emergency purchase.
- c. Conducts regular monitoring of weather conditions.
- d. Consolidates monitored reports gathered 24/7.
- e. Continuous provision of disaster assistance to LGUs.

- f. Four (4) standby vehicles for response operations.
- g. Placed on standby their Quick Response Teams.
- h. Standby riders.

Metro Manila Development Authority (MMDA)

- a. Continuous monitoring of the flooding situations in Metro Manila.

CDRRMC Mandaluyong

- a. Held a council meeting on 20 June 2019 and discussed the rainy season and its effects in Mandaluyong City.
- b. CDRRM Office Operations Center to continue monitoring the weather situation and disseminate information of weather updates and flooded areas thru various channels as necessary.
- c. All Barangay and City responders are on standby alert due to the enhanced Southwest Monsoon.
- d. REACT Mandaluyong Tiger Group to provide situation reports.
- e. Barangay Volunteer Groups are on standby alert for possible deployments.

CDRRMC NAVOTAS

- a. Conducts trainings or workshop to volunteers and the community.
- b. Develops comprehensive planning processes between public and private sectors.
- c. Ensures complete interoperable communications capabilities between all responder and the Barangays.
- d. Provides relevant weather information to the barangay level.
- e. On 24/7 monitoring and placed response team on standby.

CDRRMC Parañaque

- a. CDRRMO, Emergency Operation Center (EOC) on white status, normal operations and monitoring of AOR, will raise alert whenever necessary. Continuous coordination with 16 Barangay DRRM Committees and CDRRM Council member agencies, disseminated information about current situation and possible flooding secondary to heavy rain through all communication platforms. Prepared water rescue assets for possible WaSAR operations.
- b. BFP Parañaque prepared standby teams to augment possible WaSAR operations.
- c. DILG Parañaque coordinated with DRRMO regarding preparedness measures ICOW Habagat and closely monitoring the situation in the AOR.
- d. CENRO / DPWH conducted declogging of drainages in the main thoroughfare and major roads to mitigate flooding in some areas in the AOR, desilting and dredging of water ways and clean up drive in the coastal area.

CDRRMC Pasig

- a. 24/7 monitoring through the City Command Center.
- b. Monitoring of weather forecast.
- c. Coordinated with barangays and school on the status of their AOR.
- d. Dissemination of weather advisory via quad media.

MDRRMC Pateros

- a. Pateros DRRM Office – Rescue Unit on Code White status.
- b. Alert status may be raised whenever necessary.
- c. On 24/7 continuous weather monitoring.
- d. Emergency First Responders Personnel of Pateros Rescue Unit will be on standby and on-call status.
- e. Pateros Business District Administration Office and Traffic Enforcement Unit personnel to augment on the monitoring of flooded areas and response operations.
- f. Two (2) wooden boats and One (1) fiber plastic Urban Search and Rescue boats and personal protective gears are readily available and trained flood rescuers are on standby when needed.
- g. Volunteer groups are also on standby.
- h. Should flooding be observed Emergency Response Teams shall be deployed accordingly for assistance purposes.
- i. Municipal Social Welfare and Development Office (MSWDO) and Pateros Health Department – Health Emergency Management Staff on standby in case of eventualities.

CDRRMC San Juan

- a. Disseminates Alert Notices, Warnings, and Advisories.
- b. San Juan DRRM Office is on blue alert from 25 June 2019 and continuously disseminating advisories to all BDRRMC.

CDRRMC Taguig

- a. Prepositioned response/rescue teams, EMS, transport and response vehicles.
- b. Prepositioned EMS medical supplies.
- c. Emergency Operations Center on alert status.
- d. All personnel on – alert status on – call 24/7.
- e. Checked readiness of evacuation area and facilities.
- f. Prepositioned aluminium boats.
- g. Regularly monitor of flooding on all low-lying areas in the city especially 15 barangays in District 1.
- h. Social Services Department (DDS) stockpiling and prepositioning of 1,000 family food packs and makes sure that status of commodities and standby funds.
- i. City Health Office prepositioned medical supplies, equipment's and ambulances, Barangay Health Centers on – alert status and inventory of Medical Supplies.

CDRRMC Valenzuela

- a. Conducted PDRA meeting.
- b. Continuous monitoring on weather and flood situations within AOR.
- c. Prepositioning of rescue and water equipment in satellite stations / 3S Centers.
- d. Deployment of amphibious vehicles especially in low lying areas.

- c. Continuous redundant dissemination of weather bulletins and other warnings to all stakeholders.
- d. Continuous monitoring of AOR and close coordination with RDRRMC1 Member Agencies and Provincial DRRM Councils.

DOST

- a. Close coordination with PAGASA for the monitoring of Hydromet Stations established within the region.

DILG

- a. Disseminated advisories of TO Egay to all provinces
- b. Disseminated advisories activating DILG disaster monitoring and reporting
- c. Informed concerned LGUs to activate their LDRRMCs following the Operation Listo (Alpha).

DSWD

- a. Disaster Response Management Division (DRMD) is continuously monitoring the possible effects of the weather disturbance.
- b. Provincial Operations Offices (POOs) are in close coordination with OCD and different ProvinciaVCity/Municipal DRRM Councils.
- c. Available Quick Response Fund amounting to PHP 2,379, 275.00.

BFP

- a. Activation of Alert in connection with TD EGAY standby personnel and ready for deployment.
- b. Ready HAZMAT Team.
