PRESENT WEATHER:

AT 3:00 AM TODAY, THE CENTER OF TROPICAL STORM "QUIEL" (NAKRI) WAS ESTIMATED BASED ON ALL AVAILABLE DATA AT 400 KM WEST NORTHWEST OF CORON, PALAWAN (13.4°N, 116.8°E) WITH MAXIMUM SUSTAINED WINDS OF 85 KM/H NEAR THE CENTER AND GUSTINESS OF UP TO 105 KM/H. IT IS MOVING EAST SOUTHEAST SLOWLY. TAIL-END OF A COLD FRONT AFFECTING NORTHERN LUZON.

Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.
