<b>THE EASTERN AND WESTERN SEABOARDS OF SOUTHERN LUZON</b> (Camarines provinces, Catanduanes, Eastern coast of Albay, Eastern coast of Sorsogon, Eastern coast of Quezon including Polillo Island and Occidental Mindoro)	Partly cloudy to cloudy skies with isolated rains	(52 - 63 / (28 - 34)	Rough to very rough	3.4 to 4.5
<b>THE EASTERN AND WESTERN SEABOARDS OF VISAYAS</b> (Northern Samar, Eastern Samar and Antique)	Cloudy skies with scattered rainshowers and thunderstorms	(52 - 63 / (28 - 34)	Rough to very rough	3.4 to 4.5
