## STRONG TO NEAR-GALE FORCE WINDS ARE EXPECTED TO AFFECT THE FOLLOWING AREAS:

THE SOUTHERN SEABORD OF SOUTHERN LUZON (Southern coast of Mindoro)	Partly cloudy to cloudy skies with isolated light rains	45-63 / 24-24	Rough	2.8 – 4.5
