STRONG TO GALE FORCE WINDS ARE EXPECTED TO AFFECT THE FOLLOWING AREAS:

THE EASTERN SEABOARDS OF SOUTHERN LUZON AND VISAYAS (The Coast of Extreme Northern Quezon, General Nakar, Northern Coast of Polillo Islands Panukulan and Burdeos, Northern and Eastern Coasts of Catanduanes, Eastern Coast of Rapu-rapu Islands, Eastern Coast of Sorsogon Prieto Diaz, Gubat, and Barcelona, Northern and Eastern Coasts of Northern Samar, and Eastern Coast of Eastern Samar)	Mostly cloudy skies with scattered rainshowers and thunderstorms	41 - 59 / 22 - 32	Rough to very rough	2.6 to 4.1
THE SEABOARDS OF NORTHERN LUZON (Batanes, Calayan, Babuyan, Ilocos Norte, Cagayan, and Isabela)	Partly cloudy to cloudy skies with isolated light rains	41 - 59 / 22 - 32	Rough to very rough	2.6 to 4.1
