I. Fire Incident in San Nicolas, Cebu City (Region VII)

A. Situation Overview

On 05 March 2020, at 01:37 AM, a fire incident occurred at Sitio Ipil, Brgy. Basak, San Nicolas, Cebu City involving residential houses. The fire reached 3rd alarm at 02:19 AM and was declared fire out at 03:48 AM of the same day. Investigation revealed that the fire started in ancestral home which was made out of light materials.

B. Effects

- **One (1) injured person** who suffered from 2nd degree burn on the arms and face.
- A total of **120 families or 438 persons** were reported displaced.
- A total of **73 houses (71-totally; 2-Partially)** were reported damaged. Displaced families stayed the Brgy. Alumnos Gymnasium.
- A total of **₱600,000.00** worth of damages was reported due to incident.

C. Actions Taken

- OCD VII coordinated with Bureau of Fire Protection VII.
- LGU Cebu City set-up modular tents to the affected families.
- DSWD assisted in the distribution of relief and financial assistance.
- DROMIC of the DSWD-DRMB is closely coordinating with DSWD-FO VII for significant reports on the status of affected families, assistance, and relief efforts.
- A total of ₱587,000.00 worth of assistance was provided by DSWD (₱97,000.00) and others (₱490,000.00)

II. Progress Report re Fire Incident in Butuan City (Region Caraga)

A. Situation Overview

On 9 March 2020, at 04:13 PM, a fire incident occurred in Brgy. Ong Yiu and Brgy. San Ignacio, Butuan City. The fire quickly spread to the adjacent houses made of light and combustible materials. The incident was declared fire out by 09:20 PM of the same day. The origin and cause of the fire is still under investigation. No casualty reported.

B. Effects

- A total of **439 families or 1,746 individuals** were reported displaced and currently staying in Ong Yiu Covered Court (305 families; 1,268 individuals) and San Ignacio Covered Court (134 families; 478 individuals).

C. Actions Taken

- LGU Butuan provided food and non-food items for the affected families amounting to ₱214,856.00.
 - DSWD-FO Caraga provided food and non-food items to the affected families consisting of 600 FFPs, 300 hygiene kits and 300 sleeping kits amounting to ₱854,660.00.
 - OCDRO Caraga continues to monitor the incident for any further updates.
