#### I. SITUATION OVERVIEW

- On 31 December 2019, a clustering of pneumonia cases of unknown etiology was reported in Wuhan, China. The outbreak was later determined to be caused by a new coronavirus strain that has not been previously identified in humans.
- On 30 January 2020, the Department of Health (DOH) confirmed the first case in the Philippines when a 38-year-old female Chinese patient under investigation (PUI) tested positive for the COVID-19.
- In light of the confirmation of localized transmission in the country and in anticipation of possible sustained community transmission, DOH has raised the COVID-19 Alert System to Code Red Sublevel 1 on 07 March 2020.
- On 8 March 2020, with the recommendation of the DOH, the Office of the President declared a State of Public Health Emergency. This will facilitate mobilization of resources, ease processes including procurement of critical logistics and supplies, and intensify reporting.
- On 12 March 2020, 9:00 PM, a Presidential Press conference was conducted announcing the raising of the Philippine's COVID-19 Alert Level System to Code Red Sublevel 2. The Chief Executive approved the imposition of Stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days, effective 15 March 2020.

#### II. EFFECTS

#### A. Suspected and Confirmed Cases

- As of 12 March 2020, there are 68 Patients Under Investigation (PUIs) who are currently admitted in different facilities in Regions I, II, CALABARZON, VII, X, XII, CAR, and NCR.
- A total of fifty-two (52) cases have been confirmed. Of which, five (5) were reported dead.

#### B. Suspension of Classes

Classes in all levels for private and public schools in Metro Manila were initially suspended from 10 March to 14 March 2020. The suspension is extended until 12 April 2020 as declared by President Rodrigo Roa Duterte on 12 March 2020.

## C. Suspension of Domestic Travel

Land, domestic air, and domestic sea travel to and from Metro Manila is suspended from 15 March to 14 April 2020 as declared by President Rodrigo Roa Duterte on 12 March 2020.

#### **III.DISASTER PREPAREDNESS and RESPONSE**

## A. National Disaster Risk Reduction and Management Council (NDRRMC)

## 1. NDRRM Operations Center (NDRRMOC)

- a. The NDRRMOC raised its alert status to BLUE on 13 March 2020, 8:00 AM for the continuous monitoring of COVID-19. Likewise, the NDRRMOC ensures maximized coordination with concerned agencies and RDRRMCs / OCD Regional Offices.
- b. Facilitated the conduct of the Emergency Meeting on 05 February 2020, 3:00 PM at the 3<sup>rd</sup> Floor, New NDRRMC Building, Camp General Emilio Aguinaldo, Quezon City.
- c. Facilitated the conduct of the Emergency Full Council Meeting on 07 February 2020, at DND Building, Camp General Emilio Aguinaldo, Quezon City.

## 2. Department of Health (DOH)

- a. Updated the Interim Guidelines on the Preparedness and Response to Novel Coronavirus (COVID-19) to be used by DOH health facilities and others.
- b. Created a dedicated webpage for the COVID-19 Health Event.
- Continuous provision of accurate and understandable information about COVID-19 using infographics and advisories through various social media platforms.
- d. Convened a Command Conference attended by DOH Executive Committee and Regional Directors across the country to further coordinate the Department's Efforts on the COVID-19 Health Event.
- e. Recommended the issuance of temporary travel ban covering all travelers from Hubei Province of China.
- f. Admitted and isolated PUIs. Likewise, implemented stricter infection control measures in hospitals with PUIs.
- g. Close coordination with Bureau of Quarantine in the conduct of contact tracing.
- h. Assures the public that all measures needed to contain the spread of the virus is strictly being implemented and followed. San Lazaro Hospital has implemented rigorous infection control protocols while caring for patients.
- i. Isolated the confirmed cases following strict isolation standards, and all health personnel who came in with them practiced stringent infection control measures and wore appropriated personal protective equipment.
- j. Coordinated with the Chinese Embassy to ensure the dignified management of the remains of the 2<sup>nd</sup> confirmed case.
- k. Epidemiology Bureau secured the manifestos of the flights and is in close coordination with the concerned airlines. Contact tracing activities are ongoing in Cebu and Dumaguete, and in other places where the patients stayed and traveled to.
- I. The Interagency Task Force (IATF) for the Management of Emerging Infectious Diseases convened on 03 February 2020 with the Philippine President, other

- government agencies, and resource persons to discuss developments and next steps on the management of COVID-19 ARD in the country.
- m. Equipped and implemented strict protocols to DOH hospitals in managing PUIs.
- n. Epidemiology Bureau assessed 203 contacts and home quarantined 188 contacts from the 1<sup>st</sup> and 2<sup>nd</sup> confirmed cases.
- o. Continuous coordination with other concerned agencies to expedite the contact tracing process.
- p. Advised the passengers from Cebu Pacific flight 5J241 from Hongkong to Cebu on 20-21 January 2020; Cebu Pacific flight DG6519 from Cebu to Dumaguete on 21 January 2020; and Philippine Airlines flight PR2542 from Dumaguete to Manila on 25 January 2020 to cooperate with DOH representatives who will coordinate with them for assessment.
- q. The Interagency Task Force on Emerging Infectious Diseases finalized the protocols and procedure to be implemented for the repatriation of Overseas Filipinos (OFs) coming from Hubei Province, China.
- r. The IATF has repatriated a total of 32 Filipinos from Wuhan, China. The said repatriates are considered PUIs and are currently being observed and isolated.

- b. Attended the Senate Hearing on 04 February 2020 re updates from DOH and its ways forward in reducing cases of COVID-19 in the country.
