

I. SITUATION OVERVIEW



A. Suspension of Work

Suspension of Work

- 1. Per Memorandum from the Executive Secretary, starting 17 March 2020, a work from home arrangement will be implemented in the Executive branch, except PNP, AFP, PCG, and health and emergency frontline services, border control and other critical services, which shall ensure a skeletal work force.
- 2. Work in all government offices in the Provinces of Ilocos Norte and La Union were declared suspended on 14 March 2020 and 16 March 2020, respectively.
- 3. Work suspension at the Provincial Government of Occidental Mindoro and Oriental Mindoro effective 17 March 2020.

- 4. Work of Municipal Government of Pinamalayan, Oriental Mindoro was suspended effective 17 March 2020 except the frontline offices.

B. Suspension of Domestic and International Travel

On 17 March 2020, all mass transport system was suspended until 12 April 2020 due to the Luzon-wide "enhanced community quarantine" to control the COVID-19 outbreak.

Department of Health (DOH)

- a. Ensured continuous monitoring of the situation.
- b. Conducted contact tracing and disease surveillance.
- c. Facilitated the delivery of COVID-19 test kits to the following Sub-National Laboratories and Center for Health Development with the assistance of the OCD and AFP PAF:
 - 100 Testing Kits for Southern Philippines Medical Center Davao
 - 100 Testing Kits for Vicente Sotto Memorial Medical Center Cebu
 - 100 Testing Kits for Northern Mindanao Center for Health Development
- d. Facilitated the transportation of specimens for testing at the Research Institute for Tropical Medicine from:
 - Eastern Visayas Regional Medical Center
 - Western Visavas Center for Health Development
- e. Provision of different health commodities:
 - Personal Protective Equipment Kits Rizal Medical Center and Eastern Visayas Medical Center
 - Surgical Mask and Gloves PNP and BFP
 - Tents National Kidney and Transplant Institute, Amang Rodriquez Memorial Medical Center and Philippine General Hospital

DOH MIMAROPA

- a. Coordinated with DOH and EB regarding assistance to transport PUI from Lubang District Hospital going to any available health facility.

- a. Issued Regional Memorandum to FOs for DOTr request for LGU Assistance in Ferrying Health Workers to existing terminals in conjunction to their deployment of buses.
- b. Issued Regional Memorandum Circular on Work Arrangement in light of the Enhance Community Quarantine.
- c. Issued Regional Memorandum regarding Accomplishment of online DILG Health Monitoring Form.

DILG X

Issued Regional order for the activation of provincial operations center and division order for the designation of regional office personnel to man the operations center.

OCD MIMAROPA

- a. Issued Memorandum No. 025 series of 2020 to All OCD MIMAROPA Regional Office Employees re Compliance to PRRD Directives on Enhanced Community Quarantine and Stringent Social Distancing Measures.
- b. OCD MIMAROPA Regional Office adopted the skeletal workforce during the course of the said enhance quarantine. All employees who are not On-Duty in the skeletal work force are considered as "On Work from Home Status" and are advised to continuously monitor the COVID-19 situation thru social media, radio stations, and other forms of media communication system and be ready for the immediate RECALL in case that there is an escalation of emergency situation in MIMAROPA AOR.

Issued Memorandum No. 01 series 2020 to all Officials, Employees of the Provincial Government and Local Chief Executives re Compliance to Memorandum issued by the Executive Secretary on 16 March 2020, pursuant to Presidential Proclamation Nos. 929 and 922 series 2020 and RA 1132.

RDRRMC XII

- a. Passed the following resolutions:
 - A Resolution Enjoining all LGUs in Region XII to adopt Coordination Mechanism to Abate the Treat of COVID-19
 - A Resolution Creating the Region XII COVID-19 Task Force to Implement and Carry-out Approaches Across All LGUs of the Region to contain the Spread of the Infection
 - A Resolution Strongly Urging the LGUs in Region 12 to Implement General Community Quarantine in their Respective Jurisdiction to Prevent the Threat or Further Spreading of the COVID-19 effective 23 March 2020.

LGU Tupi, South Cotabato

Issued Executive Order No. 21, imposing curfew hours within the jurisdiction of the Municipality of Tupi to combat the spread of the Coronavirus Disease 2019.

Issued Executive Order no. 50 imposing Pre-emptive lockdown in the Municipality of Pigcawayan, Province of Cotabato.

PDRRMC GUIMARAS

- a. Issued Executive Order No. 29, an order for the temporary ban of commercial and private buses and vehicles from Metro Manila entering the Province of Guimaras.
- b. Issued Executive Order No. 32, an order temporarily suspending the entry and/or tours of guests from Metro Manila and those from other areas in the Philippines with localized COVID-19 transmission.
- c. Issued Executive Order No. 34, an executive order restricting and regulating the entry of persons in the Province of Guimaras by reasons of 2019 Novel Corona Virus acute respiratory disease (COVID-19) effective 17 March 2020 and for other purposes.
- d. Issued Executive Order No. 35, an order for the suspension of classes in all levels in the Province of Guimaras starting March 18, 2020 until further notice.

PDRRMC ANTIQUE

Issued Executive Order No. 13, s. 2020, an executive order establishing border security and quarantine protocols in the city of Roxas as a preventive measure against Corona Virus Disease 2019 (COVID-19).

CDRRMC MANILA

- a. Issued an urgent appeal to lessors of commercial establishments that were closed for one month, to waive their rental fees.
- b. Coordinated with BJMP on limiting visiting hours of relatives to inmates.

CDRRMC QUEZON

- a. Ensured that all LGU personnel regardless of the nature of tenure (regular, contractual) will continue to receive their compensation since the HRMD personnel were tasked to process the corresponding documentary requirements.
- b. Provided free transportation service to ferry health workers and LGU frontline personnel.

CDRRMC MUNTINLUPA

- a. NBI Temporarily Suspended the clearance processing operations nationwide from 12:00 AM, 18 March 2020 until 12:00 AM, 13 April 2020.
- b. Ensured the implementation of Health Protocols and Safety Guidelines amid Enhanced Community Quarantine.

CDRRMC MALABON

- a. Implemented skeletal workforce on selected offices such as Office of the Mayor, Treasury (although no public transactions should be made), City Engineering, Accounting Office, Budget Office, City Resources Development Office, and General Service Department. Offices that were not mentioned are closed during the period of enhanced community quarantine.
- b. City Engineering issued a notice to all construction providers and strongly advised to stop all ongoing construction activities (Private and Public) including minor repairs, renovations and rehabilitations effective 17 March 2020 to 14 April 2020.
- c. Issued an Executive Order re: Guidelines on Enhanced Community Quarantine in the City effective immediately.

CDRRMC TAGUIG

Issued its implementing guidelines on social distancing and enhanced community quarantine on 17 March 2020.

CDRRMC KIDAPAWAN

Issued Executive Order No. 026, s. 2020 effective 18 March 2020, an order instituting additional guideline for the effective implementation of Community Quarantine within the City.

C. Law and Order Cluster

Department of the Interior and Local Government (DILG)

- a. Continuous monitoring of reports from all DILG regional offices and LGUs of preparedness and response actions for COVID-19 operations.
- b. Continuous monitoring of LGU's actions as well as the number of PUIs in the AOR thru the activation of OpCen.
- c. Continuous monitoring of people arrival in public places and in barangay through mandatory accomplishment of a "Health Declaration Form".

- d. Imposed Curfew Ordinance through monitoring of Mobile Patrol and Foot Patrol of PNP with tanods of different barangays.
- e. Installed mobile toilets or portalets for PNP frontliners deployed in the LGUs.

Philippine National Police (PNP)

- a. Installed checkpoints and Quarantine Assistance Stations in strategic areas in Metro Manila and other areas in Luzon.
- b. Continuously manning the quarantine control points within Metro Manila in support and cooperation with other concerned agencies
- c. Conducted regular inspection of border controls and Quarantine Assistance Stations.
- d. Issued National Headquarters Special Order No. 103 dated March 17, 2020 creating a Reactionary Standby Support Force (RSSF) that comprised 115 personnel prepared for any possible deployment within Metro Manila and nearby regions re COVID-19.
- e. Police Community Affairs and Development Group (PCADG) conducted fumigation operation at Emergency Room, Central Dispensary Center, Dental Section PNPGH, and 3 Quarantine Assistance Stations (QAS),
- f. Activated the hotline numbers that shall response to queries of concerned citizens on the procedures and guidelines with regards the entry and exit of commuters/passersby, private and public utility vehicles at 59 Quarantine Assistance Stations manned by the personnel of NCRPO.
- g. Marinduque PPO and PMFP conducted Red Teaming in established Quarantine Assistance Stations conducted by selected MPS re Enhanced Community Quarantine COVID 19.

PNP VI

Facilitated the daily monitoring on the Checkpoint Operations re General Community Quarantine

Armed Forces of the Philippines (AFP)

- a. Provided security/escorts during area visit of President Duterte at checkpoint area, Boundary of Valenzuela-Meycauayan along MacArthur Highway, Malanday, Valenzuela City.
- b. Facilitated a dialogue with the troops and gave instruction to block civilian populace and vehicle from entering/exit of road before the final implementation of Enhanced Community Quarantine.

areas to include troops information on algorithm for COVID-19 infected patient in ports.

Philippine Coast Guard District Southern Tagalog

Conducted seaborne patrol in their respective areas of responsibilities to prohibit the arrival/entry of any inbound vessels/motorbancas with onboard passengers in compliance with Executive Order no. 22, series of 2020, which mandates the PCG to restrict the entry of people into Province Of Oriental Mindoro effective 12:00 PM, 14 March 2020 until 11:59 PM, 25 March 2020.

Checked and prepositioned aluminum boat re tightening security in Gasan, Marinduque Municipal waters.

Bureau of Fire Protection (BFP)

Conducted checkpoint operations together with COVID-19 inter agency task force.

BFP II

- a. Attended the CVDRRMC Task Force Meeting on COVID-19 regarding the finalization of the IMPLAN.
- b. Assisted in the conduct of checkpoints in different entry/exit point in every municipalities.
- c. BFP Isabela are in full operation status, and conducted precautionary measures on COVID-19. Deployment also at Entrance and Exit COVID-19 checkpoints.
- d. Crafted, implemented and disseminated the BFP Contingency Plan on COVID-19 to the lower units on 16 March 2020.

BFP III

- a. Participated in the joint inspection and checkpoint in different designated posting area in the province of Aurora together with LGU, MHO, PDRRMO/MDRRMO, PNP, MENRO, Tourism, and other agencies.
- b. Attended meeting with the LGUs and other concerned agencies regarding COVID-19

- a. Continuous checking of identification in Muntinlupa Tunasan San Pedro boundary and Susana Heights.
- b. Facilitated the deployment of Police personnel for checkpoint in Victoria Daang Hari.

D. Economy Cluster

DTI X

a. Conducted price monitoring on basic necessities and medical supplies to ensure compliance of business establishments to the price freeze.

Department of Tourism

- a. Coordinated with PNP with regards to the dissemination of information to tourists aboard a P2P bus en route to Manila. Per coordination, IATF released a decision allowing P2Ps with tourists with international tickets within 24 hours be allowed to travel to airports.
- b. Coordinated with DOTr, OWWA, and the Provincial Government of Pampanga for the availability of transportation for 252 Overseas Filipino Workers stranded in Clark, Pampanga due to closure of flights in connection with the implementation of the stringent community quarantine.
- c. Provided information to tourists who wish to be transported from Clark to NAIA. As advised by DOT, since there are limited transport vehicles that could ferry the said tourists, DOT-accredited transport providers could be used for this purpose, provided that the driver has a copy of the tourists' tickets that proves the flight will be within 24 hours and proper safety procedures are observed by both the driver and tourists.
- d. Coordinated with DOTr for the identification of alternate transport providers that could provide transportation to two foreign nationals who will travel to NAIA.

E. Logistics Cluster

(Lead: OCD; Members: DOH, DOTr, DND, DPWH, AFP, PNP, DILG, DSWD, DFA, PCG, BFP, DTI, DA, NFA, PPA, CAAP, Other private sector, and CSOs)

Office of Civil Defense (OCD)

- Provided 3,000 pieces of N95 masks to AFP dedicated for their deployed personnel on 14 March 2020.
- Monitored and followed-up the status of transportation of COVID-19 PUIs samples to RITM, Muntinlupa City, and medical supplies from Manila to Region VIII. Transportation was completed.
- Coordinated with DOH-HEMB re stranded passengers in Batangas port who wants clearance to enter Manila. Passengers could travel to Manila provided they will be allowed to pass through checkpoints. Thus, PDRRMO Batangas is advised to prepare an endorsement letter to be presented in checkpoints.
- Sent advance copy of letter to OJ3 requesting transport of the COVID-19 PUIs samples from Bancasi Airport Butuan City to Manila via CJVAB.
- Received 10,000 bottles of 350ml drinking water donated by Crystal Clear Drinking Water intended for the frontline service providers.
- OCD MIMAROPA facilitated coordination with the transport of tourist (Canadian, French and Estoninan from Puerto Galera to Manila.
- OCD VIII conducted a Logistics Cluster Meeting.

Armed Forces of the Philippines (AFP)

- a. Delivered one thousand (1,000) food packs to Quirino Memorial Medical Center, Lung Center of the Philippines, East Avenue Medical Center, Philippine Heart Center, National Kidney Center, and AFP.
- b. Deployed military vehicles along EDSA to provide transportation to stranded civilians
- c. Provided aircraft for the transportation and delivery of specimen from Manila to Tacloban and Iloilo.
