

I. SITUATION OVERVIEW



A. Suspension of Work

Suspension of Work

- 1. Per Memorandum from the Executive Secretary, starting 17 March 2020, a work from home arrangement will be implemented in the Executive branch, except PNP, AFP, PCG, and health and emergency frontline services, border control and other critical services, which shall ensure a skeletal work force.
- 2. Work in all government offices in the Provinces of Ilocos Norte and La Union were declared suspended on 14 March 2020 and 16 March 2020, respectively.

B. Suspension of Domestic and International Travel

On 17 March 2020, all mass transport system was suspended until 12 April 2020 due to the Luzon-wide "enhanced community quarantine" to control the COVID-19 outbreak.

II. DISASTER RESPONSE ACTIONS

A. National Disaster Risk Reduction and Management Council (NDRRMC)

- a. The NDRRMOC raised its alert status to BLUE on 13 March 2020, 8:00 AM for the continuous monitoring of COVID-19. Likewise, the NDRRMOC ensures maximized coordination with concerned agencies and RDRRMCs / OCD Regional Offices.
- Facilitated the conduct of the Emergency Meeting on 05 February 2020, 3:00 PM at the 3rd Floor, New NDRRMC Building, Camp General Emilio Aguinaldo, Quezon City.

- c. Facilitated the conduct of the Emergency Full Council Meeting on 07 February 2020, at DND Building, Camp General Emilio Aguinaldo, Quezon City.
- d. Attended the 11th Inter-Agency Task Force for the Management of Emerging Infectious Disease on COVID-19 (IATF-EID) on 12 March 2020 at the Department of National Defense.
- e. Conducted a meeting re Updates on COVID-19 Situation and Response on 14 March 2020, 10:00 AM at the 3rd Floor, New NDRRMC Building, Camp General Emilio Aguinaldo, Quezon City.
- f. Attended the IATF EID TWG Meeting on 19 March 2020, 2:00 PM at Tejeros Hall, AFPCOC, Camp General Emilio Aguinaldo, Quezon City.

DIRECTIVES AND RESOLUTIONS:

- a. On 08 March 2020, with the recommendation of the DOH, the Office of the President declared a State of Public Health Emergency through Proclamation No. 922, s. 2020. This will facilitate mobilization of resources, ease processes including procurement of critical logistics and supplies, and intensify reporting.
- b. On 12 March 2020, 9:00 PM, a Presidential Press conference was conducted announcing the raising of the Philippine's COVID-19 Alert Level System to Code Red Sublevel 2. The Chief Executive approved the imposition of Stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days, effective 15 March 2020.
- c. On 16 March 2020, a Memorandum from the Executive Secretary was issued placing the entire Luzon under Enhanced Community Quarantine.
- d. The entire Philippines was declared under State of Calamity due to Corona Virus Disease 2019 as per Presidential Proclamation No. 929 dated 16 March 2020.
