#### **I. SITUATION OVERVIEW**

- On 31 December 2019, a clustering of pneumonia cases of unknown etiology was reported in Wuhan, China. The outbreak was later determined to be caused by a new coronavirus strain that has not been previously identified in humans.
- On 30 January 2020, the Department of Health (DOH) confirmed the first case in the Philippines when a 38-year-old female Chinese patient under investigation (PUI) tested positive for the COVID-19.
- In light of the confirmation of localized transmission in the country and in anticipation of possible sustained community transmission, DOH has raised the COVID-19 Alert System to Code Red Sublevel 1 on 07 March 2020.
- On 08 March 2020, with the recommendation of the DOH, the Office of the President declared a State of Public Health Emergency through Proclamation No. 922, s. 2020. This will facilitate mobilization of resources, ease processes including procurement of critical logistics and supplies, and intensify reporting.
- On 12 March 2020, 9:00 PM, a Presidential Press Conference was conducted announcing the raising of the Philippine's COVID-19 Alert Level System to Code Red Sublevel 2. The Chief Executive approved the imposition of Stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days, effective 15 March 2020.
- On 16 March 2020, a Memorandum from the Executive Secretary was issued re Community Quarantine Over the Entire Luzon and Further Guidelines for the Management of the Coronavirus Disease 2019 (COVID-19) Situation.

#### **II. EFFECTS**

##### **A. Patients Under Investigation (PUI) and Confirmed Cases**

As of **17 March 2020**, **259 Patients Under Investigation (PUIs)** (previous report: 214 PUIs) are currently admitted in the different facilities in Regions I, II, III, CALABARZON, VI, VII, VIII, X, XI, XII, CARAGA, BARMM, CAR, and NCR.

A total of **187 cases** (previous report: 142 cases) were confirmed in **Regions I, III, CALABARZON, VII, X, XI, BARMM**, and NCR. Of which, **14 were reported dead** (previous report: 12), and **4** have recovered (previous report: 3).

## B. Suspension of Classes and Work

### Suspension of Classes (TAB A)

A total of **1,016 cities/municipalities** in Regions I, II, III, CALABARZON, MIMAROPA, V, VI, VII, IX, X, XI, XII, CARAGA, CAR, and NCR declared suspension of classes.

1. Per Memorandum from the Executive Secretary, starting 17 March 2020, a work from home arrangement will be implemented in the Executive branch, except PNP, AFP, PCG, and health and emergency frontline services, border control and other critical services, which shall ensure a skeletal work force.
2. Work in all government offices in the Provinces of Ilocos Norte and La Union were declared suspended on 14 March 2020 and 16 March 2020, respectively.
