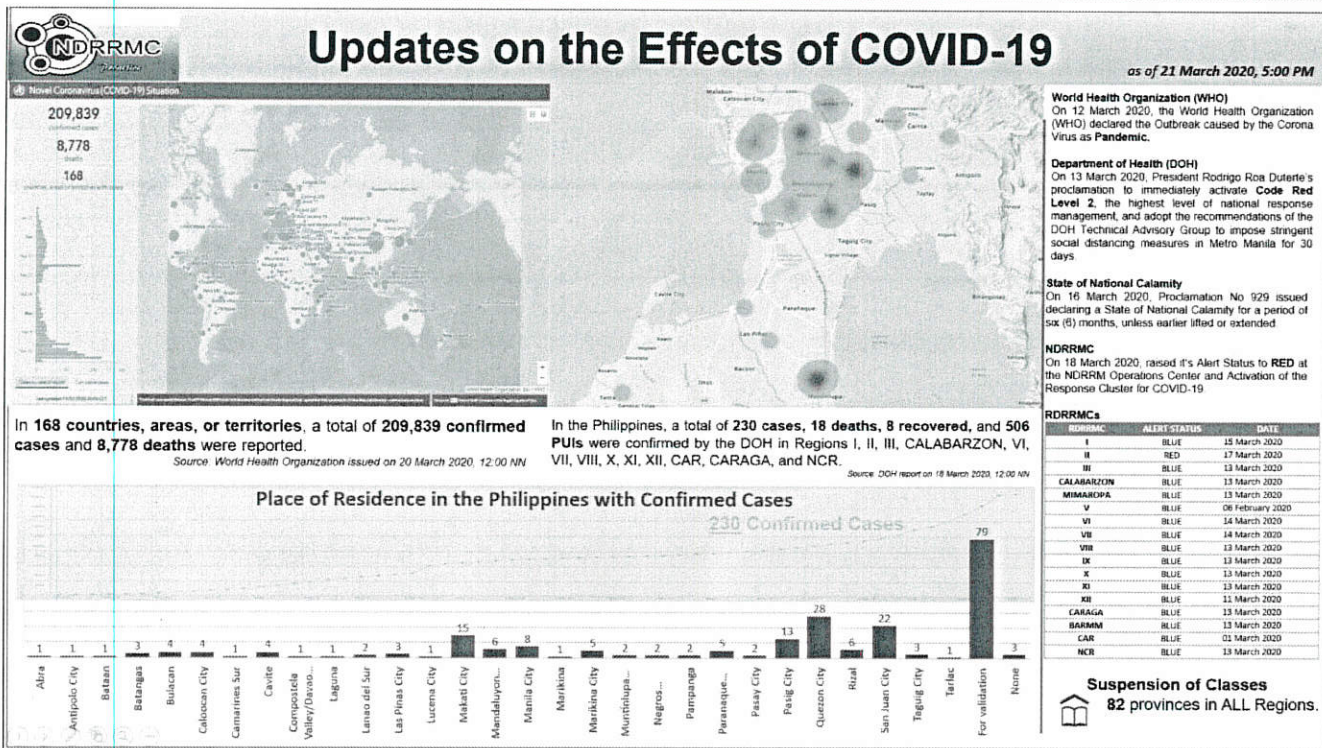

## I. SITUATION OVERVIEW



### A. Suspension of Work

## Suspension of Work

1. Per Memorandum from the Executive Secretary, starting 17 March 2020, a work from home arrangement will be implemented in the Executive branch, except PNP, AFP, PCG, and health and emergency frontline services, border control and other critical services, which shall ensure a skeletal work force.



2. Work in all government offices in the Provinces of Ilocos Norte and La Union were declared suspended on 14 March 2020 and 16 March 2020, respectively.

4. Work of Municipal Government of Pinamalayan, Oriental Mindoro was suspended effective 17 March 2020 except the frontline offices.

## B. Suspension of Domestic and International Travel

On 17 March 2020, all mass transport system was suspended until 12 April 2020 due to the Luzon-wide “enhanced community quarantine” to control the COVID-19 outbreak.

## II. DISASTER RESPONSE ACTIONS

### DIRECTIVES AND RESOLUTIONS:

- a. On 08 March 2020, with the recommendation of the DOH, the Office of the President declared a State of Public Health Emergency through Proclamation No. 922, s. 2020. This will facilitate mobilization of resources, ease processes including procurement of critical logistics and supplies, and intensify reporting.



- b. On 12 March 2020, 9:00 PM, a Presidential Press conference was conducted announcing the raising of the Philippine's COVID-19 Alert Level System to Code Red Sublevel 2. The Chief Executive approved the imposition of Stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days, effective 15 March 2020.
- c. On 16 March 2020, a Memorandum from the Executive Secretary was issued placing the entire Luzon under Enhanced Community Quarantine.
- d. The entire Philippines was declared under State of Calamity due to Corona Virus Disease 2019 as per Presidential Proclamation No. 929 dated 16 March 2020.

## **A. Health Cluster**

*(Lead: DOH; Members: PRC, PHICNA, PHA, PMA, PSMID, PNA, PIDSP, PHICS, NRL(RITM), DOST, DA, DSWD, PPA, PAP, PSA, Other private sector, and CSOs)*

- a. Intensified risk communication and community engagement with support from AmeriCares with focus on hand washing, social distancing and Mental Health and Psychosocial Support (MHPSS)
- b. Strengthened surveillance activities through an online system to speed up data collection on confirmed and suspected cases as well as contacts from Epidemiological Surveillance Units (ESU) at municipal, city, provincial and regional level.
- c. Enhanced the national laboratory system to test for COVID-19 with RITM being supported by the 4 sub national laboratories (Cebu, Davao, Baguio and Manila), soon to be followed by the University of the Philippines National Institute for Health (UP-NIH).
- d. Private hospital laboratory assessment ongoing Global shortage of key supplies is resulting in serious delays with delivery of reagents, primers, probes, extraction kits and transport media. WHO and the Asian Development Bank (ADB) are supporting DOH with the sourcing of urgently required laboratory supplies.
- e. Compliance to infection prevention and control practices through the release of guidelines IPC, training manuals will be adapted into online modules for public and private hospital focal points as well as for community health workers, focused on rational use of PPE, hygiene and waste management, supported by USAID's Medicines, Technologies, and Pharmaceutical Services (MTaPs), UNICEF and WHO.
- f. Facilitated the delivery of 100 COVID-19 Universal Transport Medium (UTM) Center for Health Development 8 in Tacloban City and specimen from CARAGA CHD to RITM with the assistance of the OCD and AFP – PAF.

## **DOH VI**

- a. Conducted press conferences on 28 January 2020 and on 3, 12, and 19 February 2020; and facilitated 38 media interviews.
- b. Responded 76 queries from the public through social media messages and phone calls.
- c. Conducted 108 social mobilization and community engagements activities supported by the Provincial and City Health Offices.
- d. Posted 211 social media cards and 9 videos through Health Promotion Cluster.
- e. Facilitated the request of DOH VI to PCG for the transport of commodities for COVID-19 in Negros Occidental.

## **DOH XI**

- a. Provided logistical Personnel Protective Equipment (PPE) support to provinces, cities, and hospitals in the region.

- b. Conducted ICS–EOC Meeting for COVID-19 with DOH-DCHD and briefing with ICS Rapid Response Team.
- c. Deployed RRT for Decontamination, Contact Tracing, and Case Investigation to augment Davao City Team.
- d. Established Psychosocial Hotline for COVID.
- e. Continuous preparation of PUI Facility at Malagos Treatment and Rehabilitation Center.
- f. Conducted orientation for additional Operation Center EODs.
- g. Coordinated with SPMC-Sub national laboratories.
- h. Facilitated all concern from other provincial/city operation center/COVID hotlines.
- i. Attended RDRRMC XI Emergency Meeting at OCD XI.

Conducted disinfection in schools, barangay, and municipal hall.

### **BFP Bulacan**

Participated in the sanitation of schools, city hall, and public places; wearing of face masks; and giving information to public on how to prevent the disease from spreading.

### **BFP Pampanga**

Conducted sanitation of schools, barangay hall, churches, covered court, establishments, and terminals.

### **BFP Tarlac**

Conducted disinfection within its AOR.

## **PDRRMC Pangasinan**

- a. Ongoing disinfection of Borderline checkpoints (TPLEX Exit Checkpoints and Bayambang-Mangatarem Exit Checkpoints).
- b. Provincial Health Office (PHO) coordinated with Mayors and Municipal Health Officers and DepEd for coordination.
- c. Conducted disinfection and decontamination routine to PDRRMO personnel and facility.

### **CDRRMC Alaminos, Pangasinan**

Conducted misting, disinfection, and flushing of government offices, public plaza, and public markets.

### **MDRRMC Mapandan, Pangasinan**

- a. Conducted disinfection of government facilities and buildings, and flushing/disinfection of main thoroughfares.
- b. Conducted house to house disinfection of 15 Barangays.

### **MDRRMC Sta. Barbara, Pangasinan**

Distributed alcohol and bleach (sodium hypochlorite) in all Departments within its Local Government Unit.



**MDRRMC Rosales, Pangasinan**

Started the disinfection of schools.

**MDRRMC Basista, Pangasinan**

a. Disinfected the following areas/facilities.

- All LGU premises, offices and municipal grounds, Barangay Halls, parks, basketball court, and auditorium.
- All schools both public and private including Day Care Centers.
- Multi-purpose halls and churches.

b. Distributed disinfectant in all barangays and alcohol in all schools and barangay hall.

a. Conducted disinfection on both public and private schools.

b. Conducted mandatory clean-up and sanitation to all business establishments.

Conducted disinfection of public places such as the municipal hall, market, and plaza.

**MDRRMC Bani, Pangasinan**

Distributed and prepositioned disinfectants in all entry points of the Municipal Hall, and in all Government Offices.

**PDRRMC Nueva Ecija****MDRRMC Aliaga**

Continuous active surveillance and monitoring with MHO on possible PUIs and PUMs within AOR.

**MDRRMC Cuyapo**

Continuous monitoring of PUMs in 51 Barangays and instructed BHERT to implement strict home quarantine for 14 days.

**MDRRMC Guimba**

Strictly monitored the PUMs and PUIs under the 14-day home quarantine.

**MDRRMC Cuyapo**

- a. Closely monitored PUIs and PUMs within AOR.
- b. Distributed hygiene kits to possible affected individuals.
- c. Conducted disinfection in public market and Tulod Elementary School.
- d. Dispatched personnel with corresponding unit ambulance and transported PUIs to Dr. Paulino J. Garcia Memorial Research and Medical Center (PJGMMC).
- e. Conducted disinfection within the LGU compound and barangay halls.
- f. Distributed hygiene kits to possible affected individuals.
- g. Disinfected the municipal building and all offices, and public market.

**MDRRMC Nampicuan and San Isidro**

Conducted disinfection in various places and buildings.

**MDRRMC Sto. Domingo**

Continuous monitoring of PUMs.



**MDRRMC Zaragosa**

- a. Continuous monitoring of PUMs and PUIs under home quarantine.
- b. Conducted disinfection of public places.

**MDRRMC Gapan**

- a. Conducted disinfection in various public places and buildings.

**PDRRMC Pampanga**

- a. Identified isolation facilities for possible containment of PUIs.
- b. Conducted contact tracing and surveillance on PUMs, PUIs, and confirmed cases in LGUs and Barangays with DOH authorized personnel.
- c. Conducted LGU clean-up drives, disinfection, sanitation of government facilities, public and private buildings, national offices, national park, and public market.

**CDRRMC Iloilo****PNP Iloilo**

Conducted inspection and distributed disinfectant alcohol and gloves to the three (3) operational wharves in Iloilo City namely: Parola, Ortiz, and Lapuz wharves; and conducted thermal scanning on passengers from Guimaras Province at Parola Wharf.

**MDRRMC Pinamalayan, Oriental Mindoro**

Conducted disinfection of major highways in the municipality through the MDRRMO and BFP Pinamalayan.

**MDRRMC Magsaysay, Occidental Mindoro**

Conducted disinfection of primary establishments and major highways.

**PDRRMC Davao de Oro**

Facilitated transport of PUIs to referral hospital in collaboration with PHO from 9 March 2020 to present.

**PDRRMC Davao del Norte**

- a. Released Public Health Advisory No. 8 to place Panabo City under community quarantine.
- b. Panabo City Health Office conducted misting at different government offices and public infrastructures.

**PDRRMC Davao del Sur**

- a. Conducted disinfection of capitol building and provincial buses on 18 March 2020.

  - Daily monitoring of PUM and taking vital signs every morning and afternoon.
  - Conducted thrice a day monitoring of instructed PUI to do self-quarantine.
  - Observed social distancing and disinfection of different establishments.

- a. Implemented close monitoring of checkpoints/border patrol at the different points of entry in cities and municipalities to determine possible PUMs.
- b. Adopted the declaration of state of calamity as approved by the SB.
- c. Prepositioned goods at the operation centers.
- d. Partnered with local radio stations to disseminate helpful facts on COVID 19.
- e. Utilized and strengthened existing checkpoints for purposes of ASF Quarantine for Security and COVID-19.
- f. Conducted bandilyo to surrounding barangays to rectify the panic caused previously by the erroneous bandilyo.
- g. Issued citation tickets for PUMs who violated the quarantine.
- h. Issued Executive Order which temporarily suspend the entry of all ambulant vendors/ peddlers.
- i. Created fast lanes for cargos/delivery trucks for food and basic necessities.
- j. Issued an advisory prohibiting senior citizens and children below 18 years old in public markets.
- k. Provided quarantine pass to all barangays for distribution to its constituents and issued certification to frontline service providers in going to work.
- l. Provided alcohol, sanitizer, and thermometer to frontline service providers.
- m. Strict monitoring and implementation of the Community Quarantine and enforcement of National Issuances as well as Executive Order/s issued by the LCE.
- n. Conducted continuous meetings to discuss distribution of food, accreditation of transport vehicles, budget and procurement of food for distribution, and other COVID-19 concerns.
- o. Facilitated the continuous production of facemasks and disinfectants.
- p. Allowed entry of vehicles to checkpoints carrying animal feeds after showing complete documents.
- q. Provided a service vehicle to employees/workers in view of Enhanced Community Quarantine.
- r. Local officials conduct night duty along the shorelines to check all incoming and outgoing vessels.
- s. Provided accommodation to all health emergency responders.
- t. Activated the Incident Management Team and Emergency Operations Center.
- u. Operationalized the CDRRMC-IMT of Cagayan De Oro City for consequence management.
- v. Continuous coordination of offices regarding Contingency Preparedness and Response Plan and the activation of the Cagayan De Oro City IMT.



- w. Cagayan De Oro City conducted a meeting with Oro Chamber and Filipino-Chinese Chamber.
- x. Cagayan De Oro City identified quarantine areas to be utilized for possible surge.
- y. Deployed non-contact scanners at City Hall, hotels, malls, restaurants and other establishments in Cagayan De Oro City.
- z. Deployed health workers of Misamis Oriental, PNP, and disaster responders in the various checkpoints.
- aa. Established checkpoints at the municipal ground/hall to check body temperature and sanitized clients and visitors before entry.
- bb. Implemented home quarantine for PUMs which are currently monitored by the MHO and Barangay Health Workers.
- cc. Conducted Local School Board meetings to ensure that students and teachers stay at their homes and supported schools in disinfecting its area.
- dd. Informed and encouraged the residents to avoid posting fake news on social media so as not to cause panic and avoid penalty of imprisonment or hefty fine.
- ee. Removed all basketball courts rings' to stop the youth from playing.
- ff. Distributed COVID-19 Preparedness Manual in Cantilan, Surigao Del Sur.
- gg. Government buses were provided to call center agents and stranded passengers.
- hh. BLGUs conducted house to house distribution of IEC Materials.
- ii. Barangay Tanod patrols within its AOR.
- jj. Packed relief goods to be distributed to affected families with daily wage earners.
- kk. Posted tarpaulins in all barangays regarding ECQ and COVID 19.
- ll. Disseminated other issuances and submitted proof of service.
- mm. Provided technical assistance during meetings.
- nn. Posted and shared COVID-19 information via social media.
- oo. Monitored and coordinated with MHO re COVID 19 PUM, PUI, and confirmed cases.
- pp. Monitored and coordinated with LCEs, PNP, BFP, MHO, and MDRRMO re COVID-19 situation.
