## I. SITUATION OVERVIEW

 On 31 December 2019, a clustering of pneumonia cases of unknown etiology was reported in Wuhan, China. The outbreak was later determined to be caused by a new coronavirus strain that has not been previously identified in humans.

 On 30 January 2020, the Department of Health (DOH) confirmed the first case in the Philippines when a 38-year-old female Chinese patient under investigation (PUI) tested positive for the COVID-19.

 In light of the confirmation of localized transmission in the country and in anticipation of possible sustained community transmission, DOH has raised the COVID-19 Alert System to Code Red Sublevel 1 on 07 March 2020.

 On 08 March 2020, with the recommendation of the DOH, the Office of the President declared a State of Public Health Emergency through Proclamation No. 922, s. 2020. This will facilitate mobilization of resources, ease processes including procurement of critical logistics and supplies, and intensify reporting.

 On 12 March 2020, 9:00 PM, a Presidential Press Conference was conducted announcing the raising of the Philippine's COVID-19 Alert Level System to Code Red Sublevel 2. The Chief Executive approved the imposition of Stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days, effective 15 March 2020.

#### II. EFFECTS

## A. Suspected and Confirmed Cases

- As of 14 March 2020, there are 153 Patients Under Investigation (PUIs) (previous report: 68 PUIs) who are currently admitted in different facilities in Regions I, II, III, CALABARZON, VI, VII, VIII, X, XI, XII, CARAGA, BARMM, CAR, and NCR.
- A total of <u>sixty-four (64) cases</u> (previous report: 52 cases) were confirmed in Regions III, CALABARZON, VII, X, and NCR. Of which, <u>six (6) were reported dead</u> (previous report: 5), <u>five (5) have recovered</u>, and <u>53 are currently admitted</u>.

## B. Suspension of Classes

A total of 135 cities/municipalities in Regions III, MIMAROPA, VII, XII, and NCR declared suspension of classes.

Land, domestic air, and domestic sea travel to and from Metro Manila is suspended from 15 March to 14 April 2020 as declared by President Rodrigo Roa Duterte during the Presidential Press conference conducted on 12 March 2020.
