

#### I. SITUATION OVERVIEW



#### 12 June 2020

"BUTCHOY" INTENSIFIES INTO A TROPICAL STORM AND IS NOW OUTSIDE THE PHILIPPINE AREA OF RESPONSIBILITY (PAR).

At 10:00 PM, the center of Tropical Storm "BUTCHOY" was estimated at 415 km West Northwest of Dagupan City, Pangasinan or 380 km West of Sinait, Ilocos Sur (OUTSIDE PAR (17.6 °N, 116.8 °E) moving Northwestward at 20 km/h with maximum sustained winds of 65 km/h near the center and gustiness of up to 80 km/h.

At 10:00 AM, the center of Tropical Depression "BUTCHOY" was estimated at 140 km West Northwest of Iba, Zambales or 165 km West of Dagupan City, Pangasinan (15.9 °N, 118.8 °E) moving West Northwestward at 25 km/h with maximum sustained winds of 55 km/h near the center and gustiness of up to 70 km/h

All tropical cyclone wind signals have been lifted. However, occasional gusts associated with the Southwest Monsoon may still be experienced over most of Northern and Central Luzon and the western section of Southern Luzon and Visayas.

## 11 June 2020

The Low-Pressure Area (LPA) east of Quezon Province has developed into Tropical Depression "Butchoy"

At 4:00 PM, the center of Tropical Depression "BUTCHOY" was estimated at 75 km Northwest of Daet, Camarines Norte (14.6 °N, 122.5 °E) moving West Northwest at 20 km/h with maximum sustained winds of 45 km/h near the center and gustiness of up to 55 km/h.

TCWS No. 01 was raised over Pangasinan, Zambales, Bataan, Tarlac, Pampanga, Nueva Ecija, Bulacan, the southern portion of Aurora (Dingalan, San Luis), Metro Manila, Rizal, Laguna, Cavite, the northern and central portion of Quezon (General Nakar, Infanta, Real, Panukulan, Burdeos, Polillo, Patnanungan, Jomalig), Mauban, Sampaloc, Lucban, San Antonio, Tiaong, Dolores, Candelaria, Sariaya, Tayabas City, Lucena City, Pagbilao, Atimonan, Padre Burgos, Agdangan, Unisan, Plaridel, Gumaca, Pitogo, Macalelon, Lopez, Guinayangan, Tagkawayan, Calauag, Quezon, Alabat, Perez), and Camarines Norte.

By evening, Tropical Depression "BUTCHOY" has made landfall over Polillo and Infanta, Quezon. At 10:00 PM, it was located within the vicinity of Baliuag, Bulacan and is moving towards Pampanga-Tarlac area.

#### II. EFFECTS

#### A. INCIDENT MONITORED

#### Rockslide Incident

A rockslide were reported along Camp 5, Kennon Tuba, Benguet around 7:30 AM, 12 June 2020 and was immediately cleared by workers of Balintugan Construction and PNP Tuba.

#### **B. STATUS OF ROADS**

A total of one (1) road section were closed to traffic in Cordillera Administrative Region (CAR) due to possible occurrence of landslide caused by continuous rains. As of 6:00 PM, 12 June 2020, the road has limited access and only open to local residents. An alternate route was diverted to Marcos Highway, Asin-Nangalisan-San Pascual-Rizal-Anduyan Road and Baguio Bauang Road.

## III. DISASTER PREPAREDNESS

## A. NATIONAL DRRM COUNCIL (NDRRMC)

- b. Continuous weather monitoring and provision of weather updates.

## 3. Department of Interior and Local Government (DILG)

- a. Provide constant updates, advisories & information to all DILG ROs regarding the development of the LPA thru texts and emails.
- b. Provide constant updates on other weather systems to all ROs and FOs.
- c. Remind all concerned LDRRMCs to ensure that all ECs are configured to comply with minimum public health standards.

## 4. Department of Social Welfare and Development (DSWD)

- a. DSWD-Central Office Operations Center is placed on standby to coordinate and respond to any eventualities.
- b. All transport logistics assets are ready for handling/hauling of relief resources
- c. Replenishment of standby funds of all Field Offices for utilization on disaster response operations.
- d. The DSWD Central Office (CO), Field Offices (FOs), and the National Resource Operations Center (NROC) have prepositioned the following resources:
  - Total stockpiles and standby funds: ₱2,025,468,103.12
    - ➤ Standby Funds: A total of ₱1,117,167,973.13 standby funds in the CO and FOs.
    - ➤ <u>Stockpiles</u>: A total of 350,332 family food packs (FFPs) amounting to ₱162,983,262.72 other food and non-food items amounting to ₱745,316,867.14

#### 5. DENR-MGB

- a. Presented updates/list of regions, provinces, municipalities and barangays susceptible landslide and flood during the PDRA Meeting on 11 June 2020
- b. Regular reporting of barangay list susceptible to landslide and flood to NDRRMOC and other concerned agencies/offices

#### 6. Department of Agriculture (DA)

- a. Advises farmers to harvest mature crops and mobilize post--harvest facilities; secure seed reserves, planting materials and other farm inputs, as well as feed and water for livestock; relocate farm machineries and equipment to higher ground; and clear drainage in irrigation and rice paddies from obstructions to prevent flooding.
- b. Constantly monitoring the situation.

## 7. Department of Public Works and Highways (DPWH)

a. Activated the Regional and District Disaster Risk Reduction Management Teams (R/DDRRMTs).

- b. District Maintenance Engineers (DMEs) and Maintenance Point Persons (MPPs) are continuously monitoring their respective Areas of Responsibilities (AORs).
- c. Prepositioned Quick Response Assets (QRAs) for any eventualities.
- d. The Regional Offices (ROs) and District Engineering Offices (DEOs) were coordinated with the Local Government Units (LGUs) and National Disaster Risk Reduction Management Council (NDRRMC).

## B. REGIONAL DRRM COUNCILS (RDRRMC)

RDRRMCs I, II, III, CALABARZON, MIMAROPA, V, VI, VII, VIII, NCR, and CAR are continuously monitoring their areas of responsibility. Further, said RDRRMCs are in coordination with their respective member agencies to ensure the widest dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories through SMS, facsimile, and official social media websites.
