I. Progress Report on Maritime Incident re Collision of MV Vienna Wood and Fishing Boat "Liberty 5" in Mamburao, Occidental Mindoro (MIMAROPA)

A. Situation Overview

28 June 2020

- At 1:00 AM, the "Liberty 5", a fishing vessel owned by Irma Fishing Trading Inc. based in Dagat-Dagatan, Malabon City with 14 crews and passengers onboard, allegedly collided with MV Vienna Wood (a cargo ship registered in Hongkong with Chinese crew) causing Liberty 5 boat to capsize. The incident happened approximately 15 nautical miles from the shorelines of Mamburao, Occidental Mindoro. The cause of collision is yet to determine as the investigation of the Philippine Coast Guard is still on-going.
- The management of Irma Fishing Trading only learned of the incident when one of its fishing boats, FB Wacky, arrived in the vicinity of Cape Calavite in Mamburao where the collision occurred and noticed a floating broken piece of wood with "Liberty 5" written on it.

1 July 2020

- At 12:00 PM, BRP Malapascua was positioned at latitude 13 degrees 24.424 N, longitude 120 degrees 24.142 E or at vicinity 600 yards S off Paluan Bay shoreline, Occidental Mindoro. Anchored at vicinity waters off Paluan Bay, Occidental Mindoro and conducting coastal search at Paluan Bay using workboat.
- At 2:00 PM, Coast Guard Mobile Post Mamburao Search and Rescue Team onboard borrowed motorbanca CARMEN-ED 3 continues conduct of SAR operation.
- At 3:50 PM, MCI Team headed by Captain Belesario PCG boarded MV Vienna Woods for follow up inquiry on the said vessel's collision with MFB "Liberty 5".

4 July 2020

- **At 12:00PM, the following SAR Operations were conducted on the missing crews of Fishing Boat "Liberty 5" through joint efforts of LGU and SAR teams:**
 - a. **Coast Guard Mobile Post Mamburao conducted SAR Operations at Paluan, Occidental Mindoro onboard borrowed FBCA CARMEN—ED.**
 - b. **Coast Guard Sub-Station Sablayan terminated foot patrol operations on their respective area.**
 - c. **Coast Guard Sub-Station Lubang conducted SAR Operations at the vicinity waters of Lubang to Looc, Occidental Mindoro and Binakas, Lubang.**
 - d. **PNP-MG and PDRRMO Occidental Mindoro conducted SAR Operations on board high speed tactical watercraft at the vicinity of Mamburao to Calavite.**
 - e. **C-208 conducted aerial survey at Calavite to Lubang, Occidental Mindoro.**
 - f. **PAF-0948H Huey 2 terminated their aerial survey at Calavite to Lubang Occidental Mindoro.**
 - g. **BRP Boracay 2401 conducted 1-2 meters swell along the shoreline of Paluan and Cape Calavite.**
- **Update on investigation is on-going.**

B. Effects

- On 1 July 2020, a total of 17 persons were onboard (14 crew members with chief mate and two passengers) of Liberty 5 were reported missing. Most of the crews were from Cuyo, Magsaysay and Araceli, Palawan and the chiefmate was from Aklan while 2 passengers were from Cuyo, Palawan.
- No survivor has been found.

C. Actions Taken

OCD MIMAROPA

- **Continuously coordinating with PCG Southern Tagalog, PDRRMO Occidental Mindoro, and PCG Station Mamburao re the updates on the Search and Rescue Operations.**
- Deployed the Rigid Hull Inflatable Boat to support the on-going SAR operations for the missing crews.

PCG and 505th Search and Rescue Group, PAF

- Conducted continuous Search and Rescue operations together with local response teams.

OCD Field Office Palawan

- Facilitated the check-in of 505th Search and Rescue Group, PAF as Search and Rescue Team for the said incident with PDRRMO Occidental Mindoro.

- Coordinated with PDRRMO Palawan for actions taken regarding the incident.
- Coordinated with PCG Palawan for incident report.
- Submitted initial report to Regional Director, OCD MIMAROPA.

PDRRMO PALAWAN

- Verified the incident with the Philippine Coast Guard District, Palawan.
- Informed and coordinated the MDRRMOs Magsaysay, Araceli and Cuyo about the incident involving their constituents.
- Closely monitored and coordinated with PCG Palawan re ongoing search and rescue operations.

II. Initial Report re Oil Spill Incident due to Barge Explosion in Bo. Obrero, Iloilo City (Region VI)

A. Situation Overview

- On 3 July 2020, 2:24 PM, an explosion incident transpired at Zone 3 Bo. Obrero, Lapuz, Iloilo City involving a power barge 102 Starboards owned by AC Energy Corp. The tank has the capacity of 320,000L of bunker oil and currently contains 200,000L bunker of oil. The cause of explosion was due to the welding works on the hull.
- BFP immediately deployed fire trucks, personnel ambulance to address the fire. However, the explosion caused the barge to leak and the spillage was contained by the personnel of the power barge but a small amount of oil leaked from the cordon. The same was attended by the BFP in coordination with PCG.
- As of this report, an estimated 48,000 liters of oil spill covering around 1,200 square meters.

B. Effects

- A total of 91 families / 321 persons were evacuated at Bo. Obrero Elementary School, Brgy. Obrero Lapuz, Iloilo City due to strong odor from the oil spill.

C. Actions Taken

RDRRMC VI

- Activated the Regional IMT and established ICP at Coast Guard Station Iloilo in Bo. Obrero, Iloilo City on 4 July 2020.
- Conducted series of coordination and small group meetings with Iloilo City DRRM Council on 4 July 2020.
- Distributed 250 pcs of face masks to the affected families and 150 pcs to PCG.
- Closely coordinated with Iloilo City DRRM Office, CGDWW and concerned member agencies.
- Conducted emergency meeting via zoom on 3 July 2020, 10:00PM
- Continuously monitoring the AOR.

PCG VI

- Deployed District Deployable Response Team (DRT), DF-347, Rubber Boats of MCS-3004 and 3006, Aluminum Boats 065 and 063 assisted MEPU WW in laying 25 segments spill boom, spreading of absorbent pads and started collecting oil by means of scooping.
- Deployed personnel and assets in responding to the incident.

DOH VI

Provided medical supplies to Iloilo City Health Office.

DSWD VI

Provided sleeping kits and hot meals to affected individuals in the evacuation center.

BFP VI

- Deployed personnel and fire trucks and other equipment to suppress the fire and to contain the spill.
- Conducted mapping of the affected area and maintained infection control protocols.

CDRRMC ILOILO CITY

- Convened together with CENRO, BFP, PCG, BDRRMC Barrio Obrero, Petron and Shell to assess the current situation.
- CENRO Iloilo assisted in assessing the necessary protocols to reduce hazard in the environment and community.
- Iloilo City Health Office provided medical needs of 43 patients who complained of difficulty of breathing, sore throat, and nasal congestion.
- PSTMO facilitated the hauling and installation of tents at the evacuation center.

BDRRMC Barrio Obrero

- Deployed local assets to assist in containing the oil spill.

III. Progress Report on the Effects of Localized Thunderstorms in Davao del Sur Province (Region XI)

A. Situation Overview

- On 28 June 2020, Davao del Sur experienced moderate to heavy rains due localized thunderstorms which resulted to flooding in some barangays in Digos City and in the municipality of Sta. Cruz with inundation reaching up to an approximate height of 2 meters.
- On 30 June 2020 the following incidents were reported:
 - a. A flooding incident occurred in six (6) barangays within the Municipality of Hagonoy. A sudden rise of water level in Balutakay River was observed on the evening of 28 June 2020. Thus, constant monitoring was conducted. The continuous heavy rains ensued an evacuation followed by relief operations to the affected residents.
 - b. A mudslide incident in Sitio Baras, Brgy. Kapatagan, Digos City was reported by the Digos CDRRMC. As per report, the affected area was delineated as highly susceptible to mass-wasting (landslide). The

consecutive heavy rains from the local thunderstorms saturated the soil and its underlying materials. This caused the instability of the surrounding slopes which resulted to a mudslide. Furthermore, two hundred meters from the aforementioned, a translational slide was also observed. This resulted to manifestation of multiple large tension cracks and one (1) house was partially covered.

B. Effects

- As of **3 July 2020**, there are no casualties reported.
- A total of **2,745 families / 9,005 persons** were affected due to the incident.
- A total of **98 damaged houses (44 totally, 54 partially)** in Sta. Cruz, Hagonoy, and Digos City, Davao del Sur were reported with **an estimated cost of damage amounting to P1,546,000.00**.
- A total of **4 local infrastructures** (2 river dikes, **1 footbridge and 1 hanging bridge**) were damaged due to the incident while **2 national infrastructures (Flood Control Digos River Revetment and Bansalan-Mt. Apo National Park Road)** were damaged with **an estimated cost of damage amounting to P55,870,000.00**.

C. Actions Taken

OCD MIMAROPA

- Continuously monitoring the AOR for any incident caused by heavy rains due to Localized Thunderstorms.

DSWD XI

- Coordinated with Disaster Response Operation Management Information Center (DROMIC) and the City Social Welfare Development Office.
- Conducted profiling and assessment of the affected families.
- Provided 89 sleeping kits, hot meals, blankets, drinking water, facemasks, biscuits, coffee, and milk to the residents currently staying in the evacuation areas.

MGB XI

Conducted ocular inspection at Brgy. Kapatagan, Digos City, Davao del Sur re the incident on 30 June 2020.

DOH XI

- **Coordinated with Provincial Health Office (PHO) Davao del Sur for any additional logistics assistance.**
- **Prepositioned collapsible water container mobilized by the PHO Davao del Sur.**
- **Augmented 600 pieces of aqua tablets and 6 boxes of doxycycline.**

PNP Hagonoy

- Assisted in the conduct of Search and Rescue Operations.
- Provided security and safety for the evacuees.
- Provided Municipal PNP Patrol car to rescue the affected individuals.

MDRRMC Sta. Cruz and Hagonoy

- Conducted Response Operation and pre-emptive evacuation of the affected families.

- Gathered additional data from the BDRRMC for validation and dissemination.
- Conducted strict implementation on crowd control management and order at headquarters.
- Dispatched all MDRRMO Personnel at the different areas within the AOR and conducted routine monitoring at identified flooded areas.

IV. Report on Effects of African Swine Fever in Davao (Region XI)

A. Situation Overview

- On June 1, 2020, the Municipal Agriculture Office of Bansalan, Davao del Sur received a report from a caller, a certain Dexter Bajao informing the office on the sudden death of his pigs in Barangay Buenavista of said town. After receiving the report, the Municipal. Agriculturist and the Livestock Inspector immediately proceeded to the area to assess the situation. They observed that the swine were weak and as per report from the owner, some had already expired.
- On June 3, 2020, the Provincial Veterinarian, assessed the situation in the area by obtaining blood sample. The blood sample was then forwarded to the Office of the Municipal Agriculture which determined that the swine were positive for African Swine Fever (ASF), recorded as the first case in this municipality.
- On June 17, 2020, the Office of Civil Defense XI received a report from Department of Agriculture XI stating that on or about May 18, 2020, their office received a report from a certain Mr. Edrito Pelaris regarding the mortalities amongst their swine in Sitio Laho, Marilog Proper, Marilog District. After receiving the report, a team from DA XI and Davao City Veterinary Office went to the area to conduct investigation and sample collection to the affected swine.
- ***On July 1, 2020, the Office of Civil Defense XI received an African Swine Fever (ASF) update report from Department of Agriculture XI which states that Brgy. Pongpong, Sta. Maria, Davao Occidental, Brgy. Tuban and Brgy.Tagabull, all in Sta. Cruz, Davao del Sur are now included in the areas affected by African Swine Fever.***

B. Effects

- As of 30 June 2020, A total of **679 hogs were culled**. An additional **25 hogs were to be culled**.
- A total of **42 individuals** were affected due to the incident.

C. Actions Taken

OCD-RDRRMC XI

Continuous monitoring of the situation and follow up updates from Department of Agriculture XI (DA XI) on 01 July 2020.

Department of Agriculture XI

- Teams from DA XI and Davao City Veterinarian Office went to the affected area to conduct disease investigation and sample collection.
- Received laboratory result that the sample collection was tested positive for ASF in Marilog, Davao City.

- Conducted disinfection and decontamination for 30 days, and culling by Davao City Veterinarians Office.
- Conducted culling activities, disinfection and decontamination of premises were conducted in collaboration with LGUs of Davao del Sur and Municipality of Bansalan. Disease surveillance activities were also conducted in the surrounding area of barangay Buenavista including the neighboring barangays, where laboratory results were turned out to be NEGATIVE of ASF.
- **Conducted containment measures which involves depopulation of affected animals and proper disposal of carcasses on 30 June 2020.**
- **Conducted disinfection of affected areas, strict quarantine measures and continuous animal disease investigation and surveillance on 30 June 2020.**
- **Provided logistics needed in culling, surveillance and quarantine activities such as PPEs, disinfectants, power sprayers, laboratory supplies and PCR test kits on 30 June 2020.**

MDRRMO Bansalan, Davao Del Sur

- Conducted emergency meeting with MDRRMO, MAO, CSU, MEO, PNP and the Local Chief Executive re: ASF on 5 June 2020.
- Visited the owner of the pig farm infected with ASF.
- Conducted continuous road quarantines, and imposed checkpoints to control the spread of the virus.
- Conducted meeting with all BVAWs and AEWs in different barangays with the Municipal Agriculturist and the Local Chief Executive re: ASF Monitoring and Implementation of the Guidelines with the Municipal Agriculturist with the Local Chief Executive.
- Surveyed the number of hog raisers along 1 km radius and strictly implement no entry and exit of live meat and meat by-products.
- Conducted blood sampling by Provincial Veterinary Office and DA Livestock Section.
- Conducted continuous road quarantines, and imposed checkpoints to control the spread of the virus.
- Attended radio interviews and announcements.
- Conducted meeting among all hog businesses including agents, meat vendors, vet/feeds company technicians, online sellers, and the like.
- Established checkpoints (entrance and exit roads) along 1 km radius.
- Attended/Entertained DA and attached agencies like BAI and others.
- Coordinated with LGUs of nearby municipalities towards the establishment of the 7 km and 10 km radius areas.
- Conducted meeting among all Barangay Chairmen with the Provincial veterinarian.
- Conducted culling of the livestock with the assistance of MEO and MDRRMO.
- Barangay officials in their respective barangays conducted public announcement about the situation on what to do especially to the hog raisers.
- Issued Executive Order No. 30, "An order implementing the 1 KM Radius Protection Ground Zero and Reiterating Executive Order No. 4 or the Municipal Task Force to Prevent the Entry of the African Swine Fever and Other Livestock Diseases in the Municipality of Bansalan, Davao del Sur.
- Conducted road quarantines and established checkpoints to control the virus.
- Conducted meeting among meat vendors, hog raisers, PNP and

- Conducted continuous road quarantines, and imposed checkpoints to control the said virus.
 - ***Conducted continuous monitoring of swine, in and out within 500-meter radius from the affected Barangay by the barangay volunteers and MAO personnel on 29 June 2020 and conducted disinfection at the affected area within the barangay.***
