## I. SITUATION OVERVIEW:

At 10:00 AM today, the Low Pressure Area (LPA) was estimated based on all available data at 710 km East of Tuguegarao City, Cagayan (17.5 °N, 128.4 °E). This weather disturbance may develop into a Tropical Depression in the next 48 hours. The public and Local Disaster Risk Disaster and Management Offices (LDRRMOs) concerned are advised to continue monitoring for updates regarding the potential development of this weather disturbance. Due to its proximity to land, Tropical Cyclone Wind Signals (TCWS) may be hoisted immediately in the initial Severe Weather Bulletin once this LPA develops into a Tropical Depression.

24-Hour Rainfall Forecast: This LPA will bring scattered light to moderate with at times heavy rains over Cagayan Valley, Bicol Region and the provinces of Aurora and Quezon. Floodings and rain-induced landslides may occur during heavy or prolonged rainfall especially in areas that are highly or very highly susceptible to these hazards. The public and LDRRMOs concerned are advised to take appropriate measures and monitor the Rainfall/Thunderstorm Advisories and Heavy Rainfall Warnings from PAGASA Regional Services Divisions.

Coastal Water Conditions: Fisherfolks and those using small seacrafts are advised to take precaution when venturing over the eastern seaboards of Luzon and Visayas.

The next update on this weather disturbance will be incorporated in the 24-hour Public Weather Forecast to be issued at 4:00 PM today and 4:00 AM tomorrow.

The next Weather Advisory will be issued at 11:00 AM tomorrow.

You are hereby directed to monitor the situation and undertake precautionary measures in your area of responsibility (AOR). Likewise, the public and the DRRMCs are advised to take appropriate actions as necessary.

In order to better inform/warn communities, you are reminded to disseminate these through local/community leaders and through your local media, including community radio stations. Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.

Moreover, you are hereby directed to reiterate the guidelines on personal protection and hygiene such as respiratory etiquette and hand hygiene, social distancing, environmental, and food safety measures.

Let's untiringly aim for zero casualties.
