STRONG TO GALE FORCE WINDS ARE EXPECTED TO AFFECT THE FOLLOWING AREAS:

SEABOARDS	WEATHER	WIND FORCE (KPH /KNOTS)	SEA CONDITION	WAVE HEIGHT (meters)
THE NORTHERN SEABOARD OF NORTHERN LUZON (Batanes, Babuyan Islands, and northern coast of Ilocos Norte)	Cloudy skies with scattered rains and thunderstorms	41 - 63 / 22 - 34	Rough to very rough	2.5 to 4.5
THE WESTERN SEABOARD OF LUZON (Western coast of Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Zambales, Bataan, western coast of Occidental Mindoro, and of Palawan)	Monsoon rains	41-63 / 22-34	Rough to very rough	2.5 to 4.5

Fishing boats and other small seacrafts are advised not to venture out into the sea while larger sea vessels are alerted against big waves.

You are hereby directed to still undertake precautionary measures and monitor the situation in your AOR. Likewise, the Public, and Local Disaster Risk Reduction and Management Councils (LDRRMCs) concerned are still advised to take precautions and appropriate actions.

In order to better inform/warn communities, you are reminded to disseminate this advisory through local/community leaders and through your local media, including community radio stations. Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions.

Moreover, you are hereby directed to reiterate the guidelines on personal protection and hygiene such as respiratory etiquette and hand hygiene, social distancing, environmental, and food safety measures.

Let's untiringly aim for zero casualty.
