STRONG TO GALE FORCE WINDS ARE EXPECTED TO AFFECT THE FOLLOWING AREAS:

SEABOARDS	WEATHER	WIND FORCE (KPH /KNOTS)	SEA CONDITION	WAVE HEIGHT (meters)
THE WESTERN SEABOARD OF LUZON (Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Zambales, and Bataan,)	Monsoon rains	45 - 63 / 24 – 34	Rough to very rough	2.8 to 4.5
THE NORTHERN AND EASTERN SEABOARDS OF NORTHERN LUZON (Batanes, Isabela, and Cagayan including Babuyan Islands)	Occasional rains	45 - <mark>63</mark> / 24 – 34	Rough to very rough	2.8 to 4.5

Fishing boats and other small seacrafts are advised not to venture out into the sea while large sea vessels are alerted against big waves.

Conduct press briefings as often as needed. This local effort will complement and reinforce efforts at the national level. Emphasis should be on proactive actions.

Moreover, you are hereby directed to reiterate the guidelines on personal protection and hygiene such as respiratory etiquette and hand hygiene, social distancing, environmental, and food safety measures. Let's untiringly aim for zero casualty.
