	Residents and the Local Disaster Risk Reduction And Management Councils (LDRRMCs) adjacent to and/or along the above-mentioned areas of concern are still advised to maintain their vigilance and take appropriate precautionary measures to mitigate impacts of possible flashfloods, landslides, and river floods within Davao River Basin, and to continue monitor the updates particularly Thunderstorm Advisory issued by Mindanao PAGASA Regional Services Division.	

You are directed to monitor the situation and undertake precautionary measures in your area of responsibility (AOR). Likewise, the public and the DRRMCs are advised to take appropriate actions, as necessary.

In order to better inform/warn communities, you are reminded to disseminate these through local/community leaders and through your local media, including community radio stations. Conduct press briefings as often as needed. This local effort will complement and

reinforce efforts at the national level. Emphasis should be on proactive actions – evacuation rather than rescue.

Moreover, you are hereby directed to reiterate the guidelines on personal protection and hygiene such as respiratory etiquette and hand hygiene, social distancing, environmental, and food safety measures.

Let's untiringly aim for zero casualty.
