NDRRMC RESOLUTION NO. 01, s. 2021

**RESOLUTION INSTITUTIONALIZING THE SENDAI FRAMEWORK FOR
DISASTER RISK REDUCTION (SFDRR) REPORTING AND MONITORING**

WHEREAS, the Sendai Framework for Disaster Risk Reduction (SFDRR) 2015-2030 was adopted at the Third UN World Conference in Sendai, Japan on March 18, 2015;

WHEREAS, 187 UN Member Countries, including the Philippines have adopted the SFDRR;

WHEREAS, the Sendai Framework is the successor instrument to the Hyogo Framework for Action (HFA) 2005-2015: Building the Resilience of Nations and Communities to Disasters;

WHEREAS, for purposes of global and country-level monitoring of the progress of attainment of disaster-related indicators of the sustainable development goals and targets, the Sendai Framework seven (7) global targets and 38 indicators were recommended by an open-ended intergovernmental expert working group;

WHEREAS, the Sendai Framework Monitor was launched in March 2018 to monitor the progress against the seven (7) global targets, four (4) priorities and 38 indicators of the SFDRR;

WHEREAS, the National Disaster Risk Reduction and Management Plan (NDRRMP) 2020-2030, anchored with the SFDRR, was adopted and approved by the National Disaster Risk Reduction and Management Council (NDRRMC) last 30 October 2020;

WHEREAS, Outcome 1 of the NDRRMP 2020-2030 highlights Priority Action 1 of the SFDRR on understanding risk through outputs and activities that increase understanding of disaster and climate risk including the collection and reporting of Disaster Risk Reduction (DRR) - related statistics;

WHEREAS, in recognition of the need to generate quality data to implement the SFDRR and inform DRRM plans, policies and programs, the institutionalization of SFDRR reporting was recommended. This will facilitate data generation, enhancement, and support for the SFDRR indicators, among others;

WHEREAS, the NDRRMC Chairperson serves as the national focal point for the SFDRR;

WHEREAS, the Office of Civil Defense, as the implementing arm and the repository of disaster loss and damage data of the NDRRMC, is designated as the primary contributor of data to the Sendai Framework Monitor;

WHEREAS, in 25 June 2019, during the 2nd Quarter NDRRMC Full Council Meeting, the NDRRMC has approved the institutionalization of the Sendai Framework monitoring and reporting.

NOW, THEREFORE, the NDRRMC **RESOLVES** as it is hereby **RESOLVED**, to:

1. Enjoin all members of the NDRRMC, Regional and Local DRRMCs, heads of national agencies, constitutional offices, State Universities and Colleges (SUCs), Government Owned and Controlled Corporations (GOCCs), Provincial Governors, City and Municipal Mayors, other concerned agencies, and to the extent necessary, community leaders, Civil Society Organizations (CSOs) and/or Peoples Organizations, to provide data support to the Sendai Framework targets and indicators for monitoring and reporting in the Philippines;
2. Establish a SFDRR Technical Working Group (TWG) that will serve as a forum to address data gaps and propose measures to streamline available data, including relevant sex-disaggregated data and gender-related information for SFDRR Reporting;
3. Draft and implement data-sharing protocols to facilitate access to information among the members of the NDRRMC, regional and local stakeholders, national government institutions and entities while ensuring the integrity and confidentiality of data; and
4. Ensure that the National Loss and Damage Registry is fully functional and updated to facilitate the reporting to the Sendai Framework Monitor.
