NDRRMC RESOLUTION NO. 11, s. 2022

**RESOLUTION ADOPTING THE NATIONAL DISASTER RISK REDUCTION AND
MANAGEMENT RESULTS-BASED MONITORING AND EVALUATION FRAMEWORK
AND PLAN**

WHEREAS, on 30 October 2020, the National Disaster Risk Reduction and Management Council (NDRMC) approved the National Disaster Risk Reduction and Management Plan (NDRRMP) 2020 – 2030;

WHEREAS, the NDRRMC recognized the gaps in monitoring and evaluation (M&E), hence the approval of NDRRMP 2020 - 2030, which sets a clear mandate and direction toward establishing a functional Results-Based Monitoring and Evaluation System (RBMES);

WHEREAS, on 28 September 2021, the NDRRMC adopted the Disaster Risk Reduction and Management (DRRM) M&E Situational Analysis and Gaps Assessment Study Findings and Recommendations, which identified the strengths and weaknesses in the Philippines' DRRM M&E system and practice and agreed on the actions needed to enhance its M&E system performance, including the development of the NDRRM Results-Based Monitoring And Evaluation Framework and Plan;

WHEREAS, the National DRRM Results-Based Monitoring and Evaluation Framework and Plan intends to strengthen and address the gaps in the DRRM M&E system and practice in the country by establishing a functional and standard DRRM M&E system at all levels, standardizing the DRRM reporting tools, approaches, and data capture and reporting guidelines and establishing a centralized and digital platform for collecting, reporting, and sharing DRRM M&E-related data needs.

WHEREAS, on 29 June 2022, during the 2nd Quarter NDRRMC Full Council Meeting (FCM), the NDRRMC approved the adoption of the National DRRM Results-Based Monitoring And Evaluation Framework and Plan, including the Pilot Testing of the Results-Based Monitoring and Evaluation Web-based System;

NOW, THEREFORE, the NDRRMC **RESOLVES**, as it is hereby **RESOLVED**, to adopt and adhere to the National DRRM Results-Based Monitoring and Evaluation Framework and Plan, including the Pilot Testing of the Results-Based Monitoring and Evaluation Web-based System as enclosed in this Resolution.

RESOLVED FINALLY, that the Chairperson of the NDRRMC shall be duly authorized to sign this Resolution for and on behalf of the four (4) NDRRMC Vice-Chairpersons and all its members.
