**NDRRMC RESOLUTION NO. 12, s. 2022**

**RESOLUTION CONFIRMING AND ADOPTING THE REHABILITATION AND RECOVERY PROGRAMS (RRPs) FOR AREAS AFFECTED BY TYPHOON ODETTE**

**WHEREAS**, from 16 to 19 December 2021, Typhoon ODETTE hit the country, affecting Region IV-B (MIMAROPA), Region VI (Western Visayas Region), Region VII (Central Visayas), Region VIII (Eastern Visayas Region), Region X (Northern Mindanao), and Region XIII (CARAGA);

**WHEREAS**, the extent of disaster effects of TY Odette triggered the issuance by the NDRRMC of a declaration of State of Calamity in the affected regions;

**WHEREAS**, NDRRMC Resolution No. 12, s.2021, dated 20 December 2021, directed all concerned agencies, led by the Office of Civil Defense (OCD), to conduct the Post-Disaster Needs Assessment (PDNA) for TY Odette;

**WHEREAS**, the concerned Regional Disaster Risk Reduction and Management Councils (RDRRMCs) completed the conduct of PDNA in March 2022 and subsequently submitted the PDNA Report to the Office of Civil Defense (OCD) Rehabilitation and Recovery Management Service (RRMS);

**WHEREAS**, the concerned NEDA Regional Offices led the RDRRMCs in the formulation of the Rehabilitation and Recovery Programs (RRPs);

**WHEREAS**, the PDNA results for TY Odette were the bases in the formulation of the RRPs, particularly the interventions to build back better the areas affected;

**WHEREAS**, the NEDA chaired the NDRRMC Rehabilitation and Recovery pillar meetings on the vetting by the concerned agency central offices of the list of priority programs, projects, and activities (PPAs) in the regional RRPs;

**WHEREAS**, the respective RDRRMCs approved their RRPs on the following dates:

MIMAROPA	-	16 February 2022
Region VI	-	16 March 2022
Region VII	-	11 February 2022
Region VIII	-	26 January 2022
Region X	-	11 February 2022
Caraga	-	09 February 2022

**WHEREAS**, the PPAs included in the RRPs shall be given priority in accessing the NDRRM Fund subject to the review by OCD of the submitted requirements as per NDRRMC Memorandum No. 110 s.2021;

**NOW, THEREFORE**, the Council **RESOLVES** as it is hereby **RESOLVED**, to confirm and adopt the RRP's for the typhoon Odette affected areas of Region IV-B (MIMAROPA), Region VI (Western Visayas Region), Region VII (Central Visayas), Region VIII (Eastern Visayas Region), Region X (Northern Mindanao), and Region XIII (CARAGA);

**RESOLVED FURTHER**, to endorse the RRP's to the Department of Finance for fund sourcing;

**RESOLVED FINALLY**, that the Chairperson of the NDRRMC shall be duly authorized to sign this Resolution for and on behalf of the four (4) NDRRMC Vice-Chairpersons and all its members.
