#### I. SITUATION OVERVIEW

# 17 February 2021

At 10:00 AM, Tropical Depression (TD) southeast of Hinatuan, Surigao del Sur has entered the Philippine Area of Responsibility (PAR) and was named "AURING" with maximum sustained winds of 45 km/h near the center and gustiness of up to 55 km/h.

At 10:00 PM, **TD "AURING" continued to maintain strength while moving westward**. It was estimated at 755 km East Southeast of Hinatuan, Surigao del Sur with maximum sustained winds of 55 km/h near the center and gustiness of up to 70 km/h moving Westward at 10 km/h.

# 18 February 2021

"AURING" intensified into a Tropical Storm (TS) while moving slowly northwestward over the Philippine sea. At 10:00 AM, the center of TS "AURING" was estimated at 685 km East Southeast of Hinatuan, Surigao del Sur with maximum sustained winds of 65 km/h near the center and gustiness of up to 80 km/h moving Northwestward slowly.

At 11:00 PM, **TS "AURING" continued to intensify while moving slowly westward.** Tropical Cyclone Wind Signal (TCWS) No. 1 was hoisted in Davao Oriental and the eastern portion of Davao de Oro (Pantukan, Maragusan, Compostela, New Bataan).

#### 19 February 2021

At 10:00 AM, "AURING" intensified into a Severe Tropical Storm (STS) as it moves slowly over the Philippine Sea East of Mindanao. STS "AURING" was estimated based on all available data at 535 km East Southeast of Hinatuan, Surigao del Sur, with maximum sustained winds of 95 km/h near the center and gustiness of up to 115 km/h.

At 2:00 PM, "AURING" weakened into a Tropical Storm and moved westwards.

# 20 February 2021

At 4:00 AM, **TS "AURING" slightly weakened over the Philippine Sea.** It has maximum sustained winds of 75 km/h near the center and gustiness of up to 90 km/h.

At 10:00 AM, the center of "AURING" was estimated at 595 km East Southeast of Hinatuan, Surigao del Sur.

# 21 February 2021

At 4:00 AM, TS "AURING" was estimated at 395 km East of Hinatuan, Surigao del Sur.

"AURING" slightly decelerated while moving towards the west-northwest. At 7:00 AM, the center of TS "AURING" was estimated at 370 km East of Hinatuan, Surigao del Sur.

At 7:00 PM, "AURING" maintained its strength as it continues to move towards eastern Visayas-CARAGA area. It has maximum sustained winds of 65 km/h near the center and gustiness of up to 80 km/h.

At 10:00 PM, "AURING" weakened into a Tropical Depression. All TCWS No. 2 were lifted. TCWS No. 1 was raised over Sorsogon, Masbate including Ticao and Burias Islands, Albay, Catanduanes, and the eastern portion of Camarines Sur, Northern Samar, Eastern Samar, Samar, Biliran, Leyte, Southern Leyte, Bohol, Cebu, Siquijor, the northern and eastern portions of Negros Oriental, the northern and central portions of Negros Occidental, the eastern portion of Iloilo, and the eastern portion of Capiz, Dinagat Islands, Surigao del Norte, the northern portion of Surigao del Sur, Agusan del Norte, the northern portion of Agusan del Sur, the eastern portion of Misamis Oriental, and Camiquin.

# **22 February 2021**

At 4:00 AM, TD "AURING" continues to weaken as it approaches Dinagat Islands-Homonhon Island area. It has maximum sustained winds of 45 km/h near the center and gustiness of up to 55 km/h, moving West Northwestward at 15 km/h.

At 9:00 AM, **TD "AURING" made landfall over Batag Island** and headed towards the Albay-Sorsogon Area.

"AURING" weakened into a Low Pressure Area at 11:00 AM. TCWS was lifted.

#### II. EFFECTS

# A. Affected Population (TAB A)

A total of 73,395 families or 272,451 persons were affected in 606 barangays in Regions V, VIII, X, XI and CARAGA. Of which, 33 families or 142 persons are currently taking temporary shelter inside 3 evacuation centers and 1 family or 4 persons sought shelter with their relatives and/or friends.

# B. Incidents Monitored (TAB B)

- 1. Nine (9) landslide/ rock slide incidents and one (1) mudflow incident were reported in Regions V, VIII, and XI.
- 2. A total of **65 areas were reported flooded** in Regions V, VI, VII, and CARAGA. Of which, **flood water in 48 areas have already subsided.**

#### C. Casualties

A total of **1 dead**, **2 injured**, and **4 missing persons** were reported in CARAGA. *Note: For validation* 

# D. Status of Lifelines

# 1. Roads and bridges (TAB C)

A total of **12 roads** and **2 bridges** were reported not passable or one lane passable in Regions V, VI, VIII, XI, and CARAGA. Of which, all **12** roads and **1** bridge are already passable.

# 2. Power Supply

Six (6) provinces in Regions VII, X, XI, and BARMM experienced power interruption.

# III. DISASTER PREPAREDNESS AND RESPONSE (TAB G)

# 1. NDRRM Operations Center (NDRRMOC)

- a. Maintained RED ALERT status since COVID-19 response operations.
- b. Continuous monitoring and ensure dissemination of Weather Advisories, and General Flood Advisories to all concerned RDRRMCs/OCDROs through SMS, NDRRMC website, and official social media websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs).
- c. Conducted PDRA meeting re TD "AURING" on 17 February 2021, 1:30 PM and convened on 19 February 2021, 2:00 PM for Weather Updates.
- d. Prepared 16 Emergency Alert and Warning Messages (EAWM) and sent the same to Telecommunication Companies for dissemination to affected areas.

# 2. National Response Cluster

- a. Issued NDRRMC Memorandum dated 19 February 2021 advising select clusters (Food and Non-Food Items, Camp Coordination and Camp Management, Internally Displaced Persons Protection, Health, Logistics, Emergency Telecommunication, and Search, Rescue and Retrieval) to prepare and place its resources on standby for possible augmentation to areas to be affected.
- b. Facilitated the request of DSWD for the delivery of essential food and non-food items bound for Surigao.
- c. OCD coordinated with the members of the Logistics Cluster for the identification of logistics needs and delivery of response requirements.
- d. Convened the Logistics Cluster on 21 February 2021.

# A. Pre-emptive Evacuation (TAB H)

A total of **18,993 families or 69,656 persons were pre-emptively evacuated** in Regions VI, VII, VIII, X, XI, and CARAGA.

# **B.** Cost of Assistance

A total of **P23,808,868.63** worth of assistance was provided by the DSWD and LGUs to the affected families in the Regions X and CARAGA.

- d. Placed city, barangay, and volunteer response units on standby alert for possible deployment.
- e. Conducted tree trimming operations in coordination with MERALCO and barangays personnel

## **CDRRMC Quezon City**

- a. Released Yellow Alert Status and placed all clusters, IMT, and BDRRMCs on standby alert for possible deployment on 19 February 2021.
- b. Released localized weather forecast, tropical cyclone advisory, and 5-day localized weather outlook thru QCDRRMC FB Page.
- c. Alerted all low-lying, flood-prone, and landslide-prone barangays for the possible effects of "AURING.
- d. Monitored rainfall, all flooded areas per district, and river water levels.
- e. Inspected prepositioned assets in Apolonio Samson, Tatalon, Sto. Domingo and Del Monte.
