I. SITUATION OVERVIEW

The Lenten Season or *Semana Santa* is a significant annual observance of the majority of the Roman Catholics to go to places of worship to reflect and for some it is an opportunity for families to spend time together during the long holiday. It begins on Palm Sunday and continues on through Easter Sunday. During this season, people go to churches to attend mass to reflect and offer prayers.

Moreover, Catholics observe Spanish-influenced rituals such as processions, passion plays (*senakulo*), and *pagbasa*. It is also an opportunity for families to spend time together.

Easter Sunday culminates the celebration of *Semana Santa*, viewed as the greatest feast of the Church every year. It is one of the most festive events, a day of joy and celebration for the faithful commemorating Jesus Christ's resurrection from the dead.

II. SPECIAL WEATHER OUTLOOK FOR THE LENTEN SEASON (25 – 31 March 2018)

The provinces of Albay, Sorsogon, Masbate, and the regions of eastern Visayas, CARAGA, and Davao experienced cloudy skies with scattered rainshowers and isolated thunderstorms due to the Tail-end of a Cold Front and the trough of the approaching tropical disturbance from Sunday (March 25) until Tuesday (March 27) while Metro Manila and the rest of the country had warm and dry weather conditions associated with sunny weather, with chances of some isolated rainshowers or thunderstorms. On Wednesday (March 28) until the duration of the forecast period (March 31), generally good weather condition apart from some isolated rainshowers or thunderstorms prevailed over the entire archipelago.

The coastal waters over the eastern section of the country was moderate to rough throughout the outlook period while slight to moderate prevailed over the rest of the archipelago except during thunderstorms.

III. EFFECTS

A. Incidents Monitored (TAB A)

 A total of <u>19 water related incidents</u> were reported in Regions I, II, CALABARZON, MIMAROPA, XI, and CAR. Meanwhile, a total of <u>22 vehicular accidents</u> were reported in Regions I, CALABARZON, CAR, and NCR.

B. Casualties (TAB B)

1. A total of <u>32 dead and 80 injured</u> were reported in Regions I, II, CALABARZON, MIMAROPA, X, CAR, and NCR.

IV. DISASTER PREPAREDNESS

A. National Disaster Risk Reduction and Management Council

1. NDRRM Operations Center (NDRRMOC)

- a. Issued a Memorandum on 22 March 2018 to all Chairpersons, RDRRMCs/OCD Regional Directors to raise the alert status of its respective operations centers to BLUE, and continuously monitor its areas of responsibilities (AORs).
- b. Issued memorandum and sent text message to NDRRMC Member Agencies and RDRRMCs / OCDROs to monitor, record, document, consolidate, and report all related incidents with various activities and actions taken by their agency and local offices in its respective AORs and to submit their preparedness measures report and the corresponding situational report/update thereon.

2. Department of Social Welfare and Development (DSWD)

a. The DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) prepositioned stockpiles and standby funds amounting to ₱917,314,569.02 with breakdown as follows:

Standby Funds:

A total of **₱279,237,850.00** standby funds in the CO and FOs. Of which, **₱234,823,860.00** was made available out of the Quick Response Fund in the CO.

Stockpiles:

A total of **392,274** Family Food Packs (FFPs) amounting to **₱138,904,165.86** and available Food and Non-food Items (FNIs) amounting to **₱499,172,553.16**.

B. Regional / Local Disaster Risk Reduction and Management Councils (R/LDRRMCs)

- Disseminated NDRRMC Memorandum No. 28, s.2018 was issued to all Regional DRRMCs regarding raising its alert status to BLUE Alert to maximize coordination, monitoring and undertake precautionary measures relative to the observance of Holy Week 2018.
- Disseminated advisories to the local DRRMCs (Provincial, City and Municipal levels) through SMS and facsimile; advised local DRRMCs to undertake precautionary measures if necessary; preposition respective assets in strategic areas; closely coordinate with response agencies; and continuously monitor the situation in their respective areas of responsibility.

Office of Civil Defense (OCD) I

- a. Conducted PDRA on 26 March 2018 at the OCDRO Conference Hall.
- b. Consolidated and disseminated contact information of response agencies to all RDRRMC member agencies for faster and efficient communication and coordination on incidents monitored.
- c. Updated inventory of response resources and directories to concerned offices in all levels of government.
- d. Disseminated weather bulletins and other warnings to all stakeholders.

Department of the Interior and Local Government (DILG) I

- a. Convened the Local Peace and Order Councils and Barangay Peace and Order Committee and planned for the heavy movement of people from various places to ensure adequate transportation, medical emergency services, and public safety.
- b. Directed Local Chief Executives to establish close coordination with security and safety authorities.
- c. Deployed law and traffic enforcers, barangay tanods, Barangay Peacekeeping Action Teams (BPATs), public safety officers, and force multipliers visible in local and national roads to assist the public.
- d. Deployed patrols at crime prone areas to ensure safety and security in churches, pilgrimages, and other travel destinations.
- e. Mobilized all resources in garbage collection and disposal, and clean-up operations of public places.
- f. Ensured close coordination to all LGUs.

DSWD Field Office (DSWD-FO) 1

- b. Coordinated with concerned Local Disaster Risk Reduction and Management Offices and local units for needed assistance related to Semana Santa.

Department of Public Works and Highways (DPWH) I

- a. Activated the Regional and District Disaster Risk Reduction and Management Team and emergency Brigade Team.
- b. Installed proper signage and warning signs within clear and safe sight distance to all ongoing construction projects.
- c. Installed legible, informational, and directional signs on conspicuous locations along national roads.
- d. Ensured that well-maintained road sections are free of potholes.
- e. Implemented issuances on removal of obstructions along the right of way of national roads and bridges.
- f. Ensured proper coordination with concerned government agencies for any assistance that may be required.
- g. Assigned field personnel for an around-the-clock shift to provide personal and prompt assistance on normal and emergency situations.

- a. Activated all coverage teams from four (4) provincial infocenters.
- b. Disseminated relevant and vital information to social media and various media to inform the public.

Police Regional Office (PRO) I

a. Dispatched Red Team to monitor actions and operational gaps of police stations.

- b. Intensified the conduct of foot and mobile patrols in various areas.
- c. Implemented Oplan Sinulid to ensure smooth flow of traffic and avoid traffic congestions.
- d. Established Public Assistance Hubs in coordination with concerned government agencies.
- e. Provided security assistance along the highways and major thoroughfares.
- f. Established Police Assistance Desks in resorts and placed SAR team on standby, ready for deployment.

- e. Enforced 6:00 PM "No Swimming Policy" at Lingayen Gulf.
- f. Raised Alert Status on 29 March 2018.
- g. Implemented the Preparedness Plan re "Oplan Semana Santa 2018" from 29 March to 01 April 2018.

PDRRMC llocos Sur

- a. Activated the 24/7 Emergency Operations Center.
- b. Established medical stations on crowded and high-risk areas.
- c. Stationed two (2) separate PDRRM rescue teams on coastal areas in Districts 1 and 2.
- d. Placed rescue boats on standby in areas with high risk of drowning incidents.
- e. Placed PDRRM Emergency Response Team was on standby for possible deployment.

- c. Conducted frequent mobile/foot patrol especially in areas holding the SINAKULO/PABASA.

DPWH CALABARZON

- a. Activated the *"Lakbay Alalay"* Program and deployed their respective District Motorists' Assistance Team in strategic locations along national highway with assigned personnel on a round-the-clock shift to provide assistance on normal and emergency situation.
- b. Installed proper signage and warning signs in a clear and safe sight distance of all ongoing construction projects.
- c. Installed legible informational and directional signs on conspicuous locations along national roads.
- d. Coordinated with concerned government entities such as LTO, PNP, and LGUs for provision of any related assistance.
- e. Ensured maintenance of road sections and pavement markings.

Land Transportation Office (LTO) CALABARZON

- a. Conducted pre-departure inspection of buses and its accessories at terminals for road-worthiness and markings/signage requirements.

Philippine Ports Authority (PPA) Batangas
