I. SITUATION OVERVIEW

The synchronized 2018 Barangay and *Sangguniang Kabataan* (SK) Elections were held on 14 May 2018. The election shall elect the Punong Barangay, more commonly known as "Barangay Captains", and members of the Sangguniang Barangay, or Barangay Council, in 41,948 Barangays throughout the country.

II. WEATHER SITUATION

SYNOPSIS: Ridge of High Pressure Area affecting Northern Luzon. Easterlies affecting the country.

Metro Manila and the rest of the country experienced partly cloudy to cloudy skies with isolated rainshowers caused by localized thunderstorms. No significant impact.

III. MONITORED INCIDENTS

A. CASUALTIES (TAB A)

A total of four (4) persons were reported dead. Meanwhile, thirteen (13) persons were reported injured.

B. INCIDENTS MONITORED

A total of **thirteen (13) incidents** were reported in Regions I, MIMAROPA, VI, VIII, X, ARMM and CAR during the conduct of the elections. Of which, seven (7) were shooting incidents, two (2) were vehicular accidents, two (2) were political harassment incident, one (1) was physical injury incident, and one (1) was vote-buying incident:

Further states that said suspect attempted to draw his unknown short firearm tucked in his waist. The victim was advised to have medical treatment. V. DISASTER PREPAREDNESS

A. National Disaster Risk Reduction and Management Council

1. NDRRM Operations Center (NDRRMOC)

- a. Raised the alert status to **BLUE ALERT Status** effective at 8:00 AM, 13 May 2018 per NDRRMC Memorandum No. 44, s. 2018 issued on 09 May 2018 directing all Chairpersons, RDRRMCs/OCD Regional Directors to raise the alert status of their respective Operations Center to BLUE ALERT effective 13 May to 15 May 2018, and to continuously monitor their respective areas of responsibility (AORs), report untoward incidents, and undertake precautionary measures if situation warrants.
