# I. SITUATION OVERVIEW

# A. Chronology and Tracking

#### 13 April 2017


 The monitored Low Pressure Area (LPA) was estimated based on all available data at 900 km East of Hinatuan, Surigao del Sur (8.0°N, 134.5°E).

# 14 April 2017

- At 4:00 AM, the LPA developed into a Tropical Depression (TD) and was named "CRISING".
- The LPA was estimated based on all available data at 615 km East of Surigao City, Surigao del Sur (9.8°N, 131.0°E) at 10:00 AM.

(TCWS) No. 1 is raised in Sorsogon, Albay, and Masbate including Ticao Island in Luzon and Northern Samar, Eastern Samar, Samar, Biliran, and northern portion of Leyte in Visayas.

# 15 April 2017

 At 4:00 AM, the center of TD "CRISING" was estimated at 220 km East of Guiuan, Eastern Samar (10.9°N, 127.7°E) with maximum winds of up to 55 kph near the center and gustiness of up to 68 kph. It was forecasted to move West Northwest at 22 kph.

- At 5:00 PM, TCWS No. 1 was raised in Sorsogon, Burias Island, Romblon, Masbate, Ticao Island, Aklan, Antique, Iloilo, Capiz, Cebu, Negros Occidental, Northern Samar, Samar, Eastern Samar, Biliran, Leyte, and Southern Leyte.
- TD "CRISING" continued to move in a West Northwest direction closer to Eastern Visayas. At 6:30 PM, TD "CRISING" made landfall over Hernani, Eastern Samar, and weakened into an LPA. All TCWS were subsequently lifted.
- The initial rainfall observations from the PAGASA Regional Services Division (PRSD) Stations, moderate to occasionally heavy rains and thunderstorms were recorded in some parts of Visayas and Mindanao. Light to moderate rains was expected over Visayas and Regions V and CARAGA.


#### 16 April 2017

- At 4:00 AM, the LPA (formerly "CRISING") was estimated based on all available data at 85 km east southeast of Roxas City.
- At 10:00 AM, the LPA was estimated based on all available data at 70 km East Northeast of Iloilo City, Iloilo.
- At 4:00 PM, the LPA was estimated based on all available data in the vicinity of Roxas, Oriental Mindoro.

# 17 April 2017

- At 4:00 AM, the LPA was estimated based on all available data at 175 km Northwest of Coron, Palawan. Easterlies affecting the eastern section of the country.
- At 10:00 AM, the LPA (remnant of "CRISING") was estimated based on all available data at 370 km West Nortwest of Coron, Palawan (13.0<sup>o</sup>N, 117.0<sup>o</sup>E). The LPA is no longer directly affecting any part of the country.

# **B. Tropical Cyclone Analysis**



During the stay of TD "CRISING", the estimated highest maximum sustained winds attained was 55 kph near the center and gustiness of up to 68 kph with a central pressure of 1,000 hPa. TD "CRISING" was known internationally as TD 02W and was formed over Palau.

TD "CRISING" was the third Tropical Cyclone for the year 2017 after TD "AURING" and TD "BISING". The period of occurrence of TD "CRISING" inside the PAR was from 14 April (5:00 PM) – 15 April (8:00 PM). Its occurrence/stay inside the PAR was normal in terms of track and rainfall distribution in the country.

#### **B. CASUALTIES (TAB A)**

• A total of **10 persons were reported dead and 19 were injured** in Regions VII and VIII.

#### **D. STATUS OF PORTS**

- 1. At the height of "CRISING" on 15 April 2017, a total of **4,851 passengers**, **384 rolling cargoes**, **34 vessels**, and **14 motor bancas** were stranded in Central Visayas, Bicol, Easter Visayas, and Western Visayas ports.
- 2. On 16 April 2017, 6:00 AM there were no more stranded passengers, vessels, rolling cargoes, and motor bancas in all ports nationwide. All shipping and fishing companies had resumed their normal operations.

#### E. FLOODED AREAS

1. A total of **10 cities/municipalities** in Region VII were reported flooded due to heavy rains.

1. Carmen, Cebu was declared under the state of calamity through Sanguniang Bayan Resolution No. 2017-063 on 17 April 2017.

#### III. DISASTER PREPAREDNESS

#### A. National Disaster Risk Reduction and Management Council

#### 1. NDRRM Operations Center (NDRRMOC)

- a. The NDRRM Operations Center maintained its Blue Alert Status with representatives from AFP, PNP, BFP, and PCG who rendered duty for prompt coordination and monitoring of possible effects of the LPA "CRISING".
- b. Disseminated Severe Weather Bulletins, Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories to all RDRRMCs/OCDROs through short message service (SMS), facsimile, and websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs) from the provincial down to the municipal level.
- c. Conducted Pre-Disaster Risk Assessment (PDRA) Meeting on 14 April 2017, 2:00 PM at the NDRRM Operations Center, Camp General Emilio Aguinaldo, Quezon City.

#### 2. Department of Science and Technology (DOST)

Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA)

a. Provided regular weather updates and severe weather bulletins to all concerned member agencies and LGUs.

#### 3. Department of Interior and Local Government (DILG)

- a. Provided information/advisories to all concerned DILG Regional Offices (ROs) regarding the development of the LPA thru emails and text blasts.
- b. Instructed all concerned DILG ROs to take proactive measures in the impending disaster.
- c. Provided constant updates on weather alerts/advisories to all ROs.
- d. Issued an advisory to all concerned Regions on the LPA on 14 April 2017.
- e. Coordinates with PAGASA and MGB in monitoring updates.
- f. Advised and directed all concerned LGUs on the following to:
  - i. Monitor all PAGASA weather advisories and typhoon bulletins as well as the Project NOAH via website.
  - ii. Establish critical preparedness actions based on the Operations Listo protocols, and prioritize prepositioning of supplies and equipment for response.
  - iii. Visit the MGB Geo-Hazard Web Portal for additional information.
  - iv. Observe existing protocols, including Proof of Service.
  - v. Activate disaster monitoring and reporting systems.
  - vi. Implement evacuation protocol in areas with high susceptibility of landslide and flooding, if necessary.
  - vii. Restrict or ban tourist activities such as, but not limited to, mountaineering/hiking, surfing, diving, and spelunking within area of jurisdiction.
  - viii. Warn small scale miners to stay in safer ground and avoid mining activities.

#### 4. Department of Social Welfare and Development (DSWD)

a. Prepositioned a total of ₱1,042,441,049.12 standby funds, 351,779.00 family food packs (FFPs), and ₱688,313,962.43 worth of food and non-food items available at the Field Offices in Regions CAR, NCR, I, II, III, CALABARZON, MIMAROPA, V, VI, NIR, VII, VIII, IX, X, XI, XII, CARAGA, and National Resource Operations Center (NROC) as of 14 April 2017:

- b. Made available 30,000 FFPs for prepositioning to 18 DSWD Regional Warehouses.
- c. Undertook forward stockpiling at the Local Government Units (LGUs).
- d. 2 Disaster Response Center Hubs (NROC in Pasay City and Visayas Disaster Response Center in Cebu) augmented the provision of FFPs in Luzon, Visayas, and Mindanao.
- e. Disaster Response Operations Monitoring and Information Center (DROMIC) at the Central Office and Disaster Response Units (DRUs) in 18 regions were on standby for regional PDRA monitoring, and data information management.
- f. 597 National Level Quick Response Team (QRT) members were placed on standby, ready for mobilization anytime.
- g. A total of 1,544 staff in 18 regions comprised the QRTs including Social Welfare and Development Teams (SWADTs) and Provincial/Municipal Action Teams (P/MATs).
- h. Trained 135 personnel on Psychosocial Support Processing; 4 batches of Family Evacuation Preparedness and Camp Coordination and Camp Management training for 262 personnel; 2 batches of Inventory and Warehouse Management involving 150 DSWD CO and regional staff; and 2 batches of Disaster Response Communications and Information Management involving 70 DSWD CO and FO (3 per region) staff with support coming from OCD's ICT and ERIC's teams.
- i. DSWD RETTs at central and regional levels were placed on standby and ready for mobilization and deployment;

- j. Organized and trained private volunteers on Evacuation/Camp Management, Relief Distribution, and FFPs repackers, were on standby and ready for mobilization and deployment;
- k. Organized trained volunteers through the DSWD Bayanihang Bayan Registry of Volunteers on rapid assessment, relief distribution, camp management, and stress debriefing.
- I. Parent leaders of Pantawid Pamilya and Community Driven Development (CDD) leaders, nationwide (except Batanes) were ready as force multipliers on humanitarian response operations.

- a. Activated Code Alert.
- b. Issued memorandum to all Regional Offices to actively monitor the weather disturbance and on preparations such as Activation of Code Alert, Activation of Operations, Preposition of Human Resource and stockpiling of medicines and medical supplies.
