I. SITUATION OVERVIEW

- a. In the afternoon of 23 May 2017, an armed conflict between the government troops and Maute Group transpired in Brgy. Basak Malutlut, Marawi City when the Maute Group trespassed, roamed and raised an ISIS flag at the Amai Pakpak Medical Center.
- b. Pursuant to Presidential Proclamation No. 216, on 23 May 2017, at around 10:00 PM, President Rodrigo Roa Duterte declared a State of Martial Law and suspended the Privilege of the Writ of Habeas Corpus in Mindanao.
- c. On 24 May 2017, 10:00 AM, residents of Marawi City sought refuge in the following identified safe areas: Mindanao State University Campus, Lanao del Sur Provincial Capitol, and to the nearby Municipality of Saguiaran (Municipal Gym, Multi-Purpose Hall) and other nearby Municipalities and Cities (Iligan and Cagayan de Oro). Tents were established at the municipal highway of Saguiaran to function as the community kitchen to cater the displaced families and individuals.
- d. On 25 May 2017, 6:30 AM, the situation in Marawi City was unstable due to the presence of lawless elements. Civilians affected took refuge by going to Iligan City. Stores, business establishments, and offices were closed. The conduct of actual assessment and validation in Marawi City was not possible.
- e. On 25 May 2017, 6:03 PM, a firefight erupted at the gate of Lanao del Sur Provincial Capitol. PNP PRO ARMM reported an offensive operation against Lawless Elements in Marawi City, Lanao del Sur.
- f. On 25 May 2017, 9:20 PM, Saguiaran Municipality was on heightened alert status since reports received that lawless elements planned to blow up the Rorogagus Bridge connecting Marawi City and Iligan City.
- g. On 02 June 2017, 15-20% of civilians were reportedly trapped in Marawi City. Government troops and rescuers cannot penetrate due to the presence of lawless elements.
- h. On 13 June 2017, five (5) PNP Personnel and five (5) civilians were rescued in Bangolo Bridge, Marawi City by the Joint Team from PNP and AFP.

II. EFFECTS

A. CASUALTIES

1. A total of **128 dead persons and 336 missing persons** were recovered/reported due to the armed conflict:

B. DAMAGES

- 1. The Amai Pakpak Medical Center (APMC) sustained damages to its facilities and medical equipment which amounted to ₱5,034,675.00.
- 2. Residential houses and the following establishments were burned:
 - St. Mary's Church,
 - Shia Masjid Moncado Colony
 - Ninoy Aquino School
 - Marawi City Jail, Ninoy Aquino School
 - Teachers Quarters of Dansalan College
 - Pacasum Square in Commercial District
 - Philippine Muslim Teachers College

C. AFFECTED/DISPLACED POPULATION (TAB A)

- As of 03 April 2018, a total of 119,153 families/540,582 persons were affected in Regions VI, VII, IX, X, XI, XII, ARMM, and Caraga. Of which, 8,803 families/43,276 persons were being served inside 57 evacuation centers and 110,350 families/497,306 persons were being served outside evacuations.
- Among the displaced population, 77,170 families/353,921 persons were verified and profiled based on the Disaster Assistance Family Access Cards (DAFAC). At that, there are 857 families/3,648 persons undergoing validation. The effect of this unrest has displaced families/persons coming from Marawi City and neighboring municipalities.

D. DAMAGED HOUSES

A total of **eight (8) houses** were totally damaged in Marawi City, Lanao del Sur, Autonomous Region in Muslim Mindanao (ARMM).

E. STATUS OF LIFELINES

1. POWER

- On the evening of 23 May 2017, a power black-out was experienced in Marawi City. Power was operational during night-time.
- As of 25 May 2017, at 9:30 PM, power blackouts were experienced in the Municipalities of Saguiaran and Ditsain Ramain, Lanao del Sur.
- As of 02 June 2017, 2:00 PM, Mindanao State University (MSU) Marawi acquired electricity from LASURECO.
- As of 18 June 2017, 30% of the power in Marawi City was restored.

2. ROADS and BRIDGES

• Bonggolo and Malaya Bridge in Marawi City was cleared by the Military personnel, but civilians were not yet allowed to access the area.

F. DECLARATION OF STATE OF CALAMITY

- 1. Marawi City was declared under State of Calamity on 25 May 2017 per Sangguniang Panglungsod Resolution No. 60, s. 2017.
- 2. Province of Lanao del Sur was declared under the State of Calamity on 24 May 2017 per Sangguniang Panlalawigan Resolution No. 61, s. 2017.

III. DISASTER PREPAREDNESS FOR RESPONSE (TAB B)

A. National Disaster Risk Reduction and Management Council (NDRRMC)

1. NDRRM Operations Center (NDRRMOC)

- a. Raised the alert status of the National Disaster Risk Reduction and Management Operations Center (NDRRMOC), Camp Aguinaldo, Quezon City to BLUE effective 24 May 2017, 3:00 PM, to closely monitor the situation and maintain continuous coordination with the concerned member-agencies and offices.
- b. Issued NDRRMC Memo No. 071, s. 2017 regarding Alert Activation and directive to all OCD Regional Offices and RDRRMCs in Mindanao to raise its alert status to RED effective 24 May 2017.
- c. Drafted the Implementation Plan for Martial Law which was subsequently approved and signed by USec. Ricardo B. Jalad, Executive Director, NDRRMC and Administrator, OCD.

2. Department of National Defense (DND)

a. Issued DND Guidance on Presidential Declaration of Martial Law in the Entire Island of Mindanao.

3. National Incident Management Team (NIMT)

- a. Conducted a NIMT meeting which was facilitated by the Incident Commander.
- b. Conducted a briefing for the Executive Director and Office of Civil Defense, Administrator regarding the situation.

B. Regional / Local Disaster Risk Reduction and Management Councils (R/LDRRMCs)

- OCD Regional Offices IX, X, XI, XII, CARAGA, and ARMM raised its alert status to RED in compliance with Memo No. 071, s. 2017 regarding Alert Activation and directed to all OCD Regional Offices and RDRRMCs in Mindanao to raise their alert status to RED ALERT effective 24 May 2017.
- Regional Command and Coordination Center (RCCC) of Regions X and ARMM on the Crisis Situation in Marawi City was established on 27 May 2017 at Frosty Bites, National Highway, Brgy. Tubod, Iligan City.

IV. DISASTER RESPONSE (TAB C)

- Activated the NDRRMC Response Cluster for the Marawi Crisis effective 15 June 2017, 9:00 AM.
- Activated the Task Group on Emergency Preparedness and Response on the Marawi Crisis and National Incident Management Team.
- Conducted Response Cluster Meetings daily at 4:00 PM.

- OCD-Operations Service deployed personnel at the Field-based NDRRMC National Emergency Operations Center (NEOC) of which, Response Cluster was to coordinate all the efforts of the NDRRMC Response Cluster and to assist in the preparation of the NEOC Situation Report from 17 to 23 June 2017.
- Task Force Bangon Marawi (TFBM) conducted a meeting with members of the Sub-Committee on Housing, Regional Government of ARMM, Provincial Government of Lanao del Sur Mindanao, and the Mindanao State University (MSU) President at MSU Ground.
- Members of Task Force Bangon Marawi, specifically the Sub- Committee on housing conducted a site visit at Sagunsungan Transitional Housing.
- Conducted a ceremonial turn-over of authority and responsibility of the National Response Cluster to the TFBM.
- On 10 September 2017, OCD-ARMM along with TFBM organized the launching of the Moral Recovery and Psychosocial Intervention Program for the IDPs at Sta. Elena Evacuation Center, Iligan City.
- On 13 September 2017, OCD-ARMM and TFBM in collaboration with the Marawi Sultanates League, Philippine Army, and the Mindanao State University - Marawi conducted a Moral Recovery and Psychosocial Program, at Buru-un School of Fisheries, Iligan City.
- On 16 September 2017, Task Force Bangon Marawi together with the Office of Civil Defense took part in the program of the Internal Organization for Migration (IOM): 'Inauguration of the Alternative Dwelling Spaces'.

A. COST OF ASSISTANCE (TAB D)

A total of **P436,058,158.65** worth of assistance from DSWD, ARMM-HEART, OCD, LGUs, I/NGOs and DOH was provided to the affected families.

Armed Conflict in Marawi City DISASTER PREPAREDNESS FOR RESPONSE 23 May 2017

A. National Disaster Risk Reduction and Management Council (NDRRMC)

1. NDRRM Operations Center (NDRRMOC)

- a. The alert status at the National Disaster Risk Reduction and Management Operations Center (NDRRMOC), Camp Aguinaldo, Quezon City was raised to BLUE ALERT effective 3:00 PM, 24 May 2017 (Wednesday) to closely monitor the situation and maintain continuous coordination with the concerned member-agencies and offices.
- b. Issued NDRRMC Memo No. 071, s. 2017 regarding Alert Activation and directive to all OCD Regional Offices and RDRRMCs in Mindanao to raise their alert status to RED ALERT effective 24 May 2017.
- c. On 24 May 2017, 12:00 PM, an Emergency Meeting was held and was presided by Asec. Kristoffer James Purisima, Officer-in-Charge of OCD and was co-chaired by Asec. R. Demosthenes C. Santillan, Civil Defense Deputy Administrator for Operations. It was attended by representatives from OCD, DILG, DSWD, DOH, DFA, and AFP.
- d. On 25 May 2017, 10:00 AM, a Coordination Meeting was held and presided by Asec. Kristoffer James Purisima, Officer-in-Charge of OCD. Updates regarding situation in Marawi City and assessment of response actions of member agencies were discussed. It was attended by representatives from OCD and Select NDRRMC Member-Agencies.
- e. Conducted coordination meeting of the National Response Cluster re the Marawi Crisis on 14 June 2017, 2:00 PM at the NDRRMC Conference Room, CGEA, Quezon City.
- f. Activated NDRRMC Response Cluster for the Marawi Crisis effective 5:00 PM, 14 June 2017.

2. Department of National Defense (DND)

a. Issued DND Guidance on Presidential Declaration of Martial Law in the Entire Island of Mindanao.

3. National Incident Management Team (NIMT)

- a. Conducted NIMT meeting and was facilitated by the Incident Commander.
- b. Conducted briefing for the Executive Director and Office of Civil Defense, Administrator regarding the situation.
- c. IC participated in the Coordination Meeting with the Presidential Management Staff (PMS) and other concerned agencies and field validation regarding the visit of the President on 20 June 2017.
- d. Facilitated a meeting with the LDRRMOs of Lanao del Norte on the rising needs and concerns with regard to the management of both home-based and inside-camp IDPs.
- e. Conducted meeting with USEC RICARDO B JALAD, OCD X RD Liza Mazo, OCD ARMM OIC Myrna Angot, and DPWH Lanao del Norte Provincial Director regarding the distribution and putting up of tents in Pantar, Lanao del

- f. Norte on 21 June 2017.
- g. Conducted inspection and validation in Pantar, Lanao del Norte to check the possible tent city to be put up in the municipality.
- h. Coordinated with MDRRMC Pantar for the construction of the tent city in their municipality.
- i. Conducted a coordination meeting on 28 June 2017 with Emergency Telecommunications (ETC), National Telecommunications Commission (NTC), and Amateur Civic Radio Group (ACRC) for the establishment of a communication group for the municipalities of Balo- I, Pantar and Saguiaran, Lanao Del Norte.
- j. Conducted a coordination meeting on 28 June 2017 with Balay Mindanao and MSWO-Tamparan regarding the set up of Sky Hydrant.
- k. Visited the Tent City in Pantar, Lanao del Norte with DSWD and NIMT.
- I. Facilitated the following:
 - Procurement of necessary logistical materials such as light bulbs, PVC pipes, and power cords for the Tent City in Pantar, Lanao del Norte amounting to ₱140,000.00.
 - DSWD request for transportation of 10 sacks of dried goods and used clothing delivered to Saguiaran Municipal Hall in Lanao del Sur; and 800 Ramadan packs delivered to Iligan City Central Elementary School in Mahayahay, Iligan City.
 - Availability of one (1) grader and two (2) dump trucks from DPWH X; the Grader will be available upon the request of the Pantar Municipal Engineer for the development of the Tent City in Pantar, Lanao del Norte.
 - Request of the Education Cluster for the availability of one (1) L300 van used for the transportation of 28 boxes and 15 trolly bags on 29 June 2017 from Xavier University High School in Cagayan de Oro City to Iligan City Central Elementary School; and one (1) transport vehicle for field work in different schools in Iligan City starting 29 June 2017.
- m. Coordinated with LGU to identify site for the transfer of IDPs in Abdul Asiz Evacuation Center of Baloi EC.
- n. BFP and Balay Mindanaw refilled 1,000 liters of water to the water container donated by Human Rights Commission
- o. BFP and Balay Mindanaw refilled 4,000 liters of water to the (water container donated by Action Against Hunger) 59 families of Tongcopan Panama at Pantao Ragat and refilled two drums of water for toilet use.
- p. On 28 July 2017 OCD-ARMM, Balay Mindanaw, and BFP conducted water rationing at the following ECs within Balo-I, Lanao Del Norte:
 - 2600 liters of water to 214 families of Abdul Azis EC serving
 - 1,800 liters of water to ECs of Landa Madrasa and Panama, Balo-I
 - 1,000 liters of water to 50 families of Momungan Learning Center
