I. SITUATION OVERVIEW

New Year's Day is one of the important celebrations in the Philippines. It is the time of the year where Filipino families get together and welcome a brand new year with the hope of an even better year.

The celebration highlights the fireworks display and loud noise to drive away evil spirits and partake of the first midnight meal or Media Noche.

II. EFFECTS

A. Incidents Monitored (TAB A)

- A total of 34 incidents were monitored covering the period of 31 December 2016 – 02 January 2017 in Regions MIMAROPA, VII, and NCR:
 - Firecracker-related incidents 29
 - Fire-related incidents 3
 - Vehicular Accident 1
 - Stray Bullet incident 1

III. PREPAREDNESS MEASURES AND RESPONSE ACTIONS

A. National Disaster Risk Reduction and Management Council (NDRRMC)

1. NDRRM Operations Center (NDRRMOC)

- a. Issued Memorandum No. 85 s. 2016 on 29 December 2016 regarding the Alert Status at the NDRRMOC.
- b. Maintained its Blue Alert Status for continuous monitoring and coordination of all efforts relative to the Observance of the Year-End Celebration and ensure dissemination of Weather Advisories, 24-hour Public Weather Forecasts, Gale Warnings, and General Flood Advisories to all RDRRMCs/OCDRCs through SMS, facsimile, and websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs)

2. Department of Science and Technology – Philippine Atmospheric, Geophysical, Astronomical Services Administration (DOST-PAGASA)

Provided weather advisories, bulletins, flood advisories, and gale warnings.

3. Department of Health (DOH)

- a. Raised Code White Alert in all DOH Government Hospitals and Regional Offices.
- b. Issued Department Memorandum to all DOH Regional Offices, specialty hospitals, and medical centers to submit daily firework and firecracker-related injury cases during the Aksyon Paputok Injury Reduction (APIR) from 21 December 2016 to 05 January 2017.
- c. Prepared and aired a 30-second TV infomercial for "Iwas Paputok" campaign that focuses on promoting community fireworks display and disseminating information about the prohibition of individual and residential use of possession of firecrackers nationwide.
- d. Conducted hospital visits in Rizal Medical Center, Amang Rodriguez Memorial Medical Center, Valenzuela Medical Center, National Childrens Hospital, and East Avenue Medical Center on 28-30 December 2016.
- e. Coordinated with the Epidemiology Bureau (EB), Knowledge Management Information Technology System (KMITS), and Disease Prevention and Control Bureau (DPCB) for any updates on casualties.
- f. Monitored firecracker-related injuries in DOH Regional Offices and hospitals.
- g. Provided Emergency Contact Numbers for easy reference.

4. Philippine National Police (PNP)

Issued National Headquarters PNP Command Memorandum Circular No. 52-2016 re "Ligtas Paskuhan 2016" to ensure the security and safety of the people and the community during the Yuletide Season celebration from 16 December 2016 to 04 January 2017.

5. Bureau of Fire Protection (BFP)

Issued and implemented Memorandum re Observance of the "OPLAN PAALALA: Iwas Paputok 2016" dated 25 November 2016 with a theme "Kaalaman sa Kaligtasan sa Sunog Tungo sa Masayang Pagdiriwang ng Pasko at Pagsalubong sa Bagong Taon" for the public safety against fire emergencies during the year-end celebration.

6. Philippine Coast Guard (PCG)

Issued and implemented Headquarters Philippine Coast Guard (HPCG) Letter of Instruction Nr. 45-2016 re "OPLAN LIGTAS BIYAHE: KRISMAS 2016" to ensure safe maritime transportation to address the expected volume of passengers, conduct safety inspection of transport vehicles/vessels, and to ensure orderly processing of passengers and traffic management to provide help desks for passenger assistance; and to provide additional terminal facilities for passenger comfort in coordination with ship-owners/terminal operators.

B. Regional / Local Disaster Risk Reduction and Management Councils (R/LDRRMCs)

RDRRMCs I, III, MIMAROPA, VI, VII, VIII, NIR, IX, X, XII, CAR, ARMM, and CARAGA disseminated weather advisories to RDRRMC member-agencies, P/C/MDRRMCs, and local media (radio stations) through OCD InfoBoard Text Blast System, and uploaded the same to social media accounts to effectively ensure public safety and achieve zero-casualty; alerted and closely coordinated with all PDRRMCs and RDRRMC member-agencies for possible rescue, relief, and other response operations relative to the weather disturbance; and monitored the situation within its respective AORs.

1. RDRRMCI

Office of Civil Defense (OCD) I

- a. Facilitated the conduct of a special Meeting re RDRRMC I Preparedness Measures for the Holiday Season.
- b. Disseminated a memorandum dated 20 December 2016 to RDRRMC I member-agencies and PDRRMOs to raise the alert status of its respective Operations Center to Blue effective 23 December 2016 and to regularly submit Situational Reports.
- c. Forwarded contact information of RDRRMC I member-agencies and PDRRMOs to key stakeholders for faster coordination and communication during the Holiday Season.

Department of the Interior and Local Government (DILG) I

- a. Monitored the LGUs for the regulation of distribution and sale of pyrotechnic devices and designation of areas for pyrotechnic show.
- Mobilized law enforcers including Barangay Peace Action Teams (BPATs) and Tanods for motorist assistance and ensuring security of the people.

Department of Social Welfare and Development (DSWD) I

- a. Prepositioned logistics/resources within the Region.
- b. Strengthened partnerships with GOs, NGOs, and LGUs.
- c. Updated the pool of Quick Response Teams (QRTs).
- d. All Field Offices (FOs) maintained standby funds amounting to ₱3,000,000.00 to replenish the required volume of 30,000 family food packs (FFPs) at any given time.
- e. Released an amount of ₱2,000,000.00 to high risks FOs and ₱1,000,000.00 to low-risks FOs for operational and administrative support required for disaster relief operations at any given time.
- f. Ensured replenishment of stockpile and operational support of food and non-food items depending on the magnitude/extent of devastation.

National Economic Development Authority (NEDA) I

Provided necessary assistance to RDRRMC I member-agencies and PDRRMOs for the Holiday Season.

DOH I

a. Placed DOH RO I RESU-HEMS OpCen and the four (4) Provincial DOH Offices' OpCen on "Code White" Alert from 21 December 206 to 05 January 2017 and on 8:00 AM – 5:00 PM duty to monitor fireworks-related injury and in close coordination with respective DRRMCs.

- b. RESU HEMS closely coordinated with the three (3) DOH Retained Hospitals.
- c. Launched "Iwas Paputok 2016" Campaign in Dagupan City on 12 December 2016.
- d. Distributed "Iwas Paputok 2016" posters/flyers.
- e. Aired radio plugging on Firecracker Prevention via Bombo Radyo Stations region-wide and other local radio stations from 20 December 2016 until 02 January 2017.
- f. RESU HEMS provided safety tips during an interview with Bombo Radyo La Union.

Department of Public Works and Highways (DPWH) I

- a. Activated the Regional DRRM Team and Motorist Assistance Team.
- b. Distributed Information, Education, and Communication Campaign (IEC) materials.
- c. Placed equipment on standby for possible deployment.
- d. Ensured all national roads were accessible and had a smooth flow of traffic.
- e. Advised all contractors to install warning devices and be on standby during the holiday season.
- f. Established motorist assistance hubs in strategic areas within the region.
- g. District Maintenance Engineers and Maintenance Point Persons with crew conducted roving activities to monitor traffic situations and any untoward incidents within its AOR.

DENR MGB I

- a. Distributed IEC materials.
- b. Operationalized the MGB Disaster Operations Center.

BFP I

- a. Placed all BFP stations and personnel to CODE RED (Full Alert Status).
- b. Implemented strategic deployment of fire engines and crews.
- c. Activated OPLAN PAALALLA "Iwas Sunog, Iwas Paputok sa Pasko at Bagong Taon 2016".
- d. Conducted massive information campaign through dialogues and lectures, distributed information materials.
- e. Conducted fire disaster emergency evacuation planning.
- f. Conducted monitoring of all hazardous operations, structures, and premises.
- g. Identified fire-prone areas and conducted pre-fire planning activities to identified areas.
- h. Conducted roving inspection around their AOR from 16 December 2016 until 01 January 2017.
- i. Conducted fire safety inspection on fireworks manufacturing plants and processing stations; display centers and similar establishments; identified high-risk buildings/compounds of public assembly and residential occupancy; and transportation facilities such as air, land, marine/naval, and rail transport terminals and stations.

NAVAL FORCES NORTHERN LUZON

a. Placed DRR Team and equipment on standby ready for deployment.

b. Monitored and coordinated with RDRRMC I member-agencies and PDRRMOs.

National Telecommunications Commission (NTC) I

- a. Implemented Memorandum Order No. 12-13-2016, ensuring uninterrupted telecommunication services during the Christmas and New Year Season.
- b. Ensured that all types of services offering including internet/broadband access were available especially on 25 December 2016 and 01 January 2017.
- c. Ensured that all necessary network adjustments and maintenance were undertaken to warrant that the network were ready to accommodate the expected increase in traffic during the Christmas and New Year season.
- d. Deployed sufficient number of operations and maintenance personnel, equipment and materials to ensure 99.99% network's availability and reliability.

Philippine Air Force - Tactical Operations Group (PAF-TOG) I

- a. Placed search and rescue assets including K9 dog units on standby.
- b. Provided necessary assistance to RDRRMC I member-agencies.

PCG I

- a. Heightened alert status from 17 December 2016 to 09 January 2017.
- b. Placed DRG teams of all stations on standby status, especially DRG teams of CGSS Lucap, CGSS Dagupan, and CGSS Bolinao where heavy influx of passengers is expected.
- c. Organized and activated Passenger Assistance Center (PAC) from 17 December 2016 to 09 January 2017 in Picucubuan Fishport, Brgy. Luciente, Bolinao; Lucap Wharf, Brgy. Lucap, Alaminos City; and Magsaysay Fishport, Brgy. Pantal, Dagupan City all in Pangasinan.
- d. Ensured the presence of information help, complaint, and medical assistance helpd desks where passengers and other seafaring public could easily seek assistance.
- e. Conducted Pre-departure Inspection (PDI)
- f. Submitted PAC Daily Accomplishment Report and SitReps to Headquarters every six (6) hours or as the need arises.

Philippine Information Agency (PIA) I

- a. Ensured continuous monitoring within its AOR.
- b. Provided assistance to RDRRMC I member-agencies in disseminating important information to the public such as detour roads, weather condition, and announcements.
- c. Provided information and coordination with RDRRMC I memberagencies and LGUs.

Philippine Red Cross (PRC) I

- a. Placed personnel and equipment on standby and ready for deployment for any emergency.
- b. Provided public assistance and coordinated with agencies and LGUs.

Police Regional Office (PRO) I

a. Ensured police presence and law enforcement operations within the AOR.

- b. Intensified intelligence driven and managed patrols in areas most needed.
- c. Established Police Assistance Desks (PADs)/Community Assistance and Referral Team (POLICE C.A.R.T).
- d. Strategic deployment of Road Safety Marshalls in major thoroughfares and Public Safety Forces (PSF) in control points/areas.
- e. Ensured aggressive operations against suspected terror groups and criminal gangs.
- f. Conducted manhunt operations against wanted persons.
- g. Conducted Target Hardening Measures.
- h. Strengthened security of PNP camps/stations, vital installations, equipment, and economic points.
- i. Ensured cooperation and interoperability with the armed services.
- j. Utilized Force Multipliers to assist in maintaining peace and security within the AOR.
- k. Provided community or public awareness and support.
- I. Intensified timely information gathering.
- m. Disseminated information on security measures, anti-criminality tips, public safety services, and hotlines thru quad media.
- n. Observed gender sensitivity and human rights in all undertakings.
- o. All Provincial Directors (PDs) provided situation reports to RTOIC SMS platform starting 16 December 216 at 4:00 AM and every 3 hours thereafter until 05 January 2017, 4:00 AM.

PDRRMC Ilocos Sur

- a. Ensured safety and security of residents and visitors/tourists/motorist and establishments during the Yuletide Season in coordination with PNP, BFP, PA, PAF, Coast Guard, National Government Agencies (NGAs), LGUs, Public and Private Hospitals, and volunteer groups.
- b. Organized the Task Group for Peace and Order.
- c. Deployed personnel in strategic locations.
- d. Deployed PNP Tourist Police Units in various tourist destinations.
- e. Provided security to vital installations.
- f. Established Police Assistance Desks in all LGUs.
- g. Provided directions and assistance to tourists and motorists together with volunteer groups,
- h. Conducted patrols to enhance security forces visibility to prevent lawlessness.

- Implemented Oplan Kapaskuhan 2016 starting 24 December 2016 until 03 January 2017.
- c. Activated PDRRMC WASAR and Hospital Alert response teams.
- d. Ensured the provision of emergency actions for beachgoers in cases of drowning incidents.
- e. C/MDRRMCs implemented its respective contingency plans for the observance of Yuletide Season.
- f. Organized Radio Groups, accredited NGOs, and other Communitybased volunteer groups as force multipliers in all strategic locations within AOR.
- g. Placed PA, PCG, PNP Maritime and BFP on standby.
- h. Strictly monitored beachgoers in Lingayen Beach.
- i. Informed BDRRMCs to monitor and not allow its residents especially minors to swim along the river systems.

OCD III

- a. Activated Regional OpCen on 31 December 2016, 8:00 AM.
- b. Alerted all LDRRMCs to closely monitor the situation within their AOR.
- c. Monitored and disseminated alert and weather advisories.

DILG III

- a. Activated EOC to ensure peace and order within AOR.
- b. Directed LGus to activate and implement its respective Operations Plan for any fire-cracker incidents.

DOH-HEMS/DRRMH III

- a. Activated the OpCen to closely monitor firework-related incidents in the Region.
- b. Prepositioned Medical Teams ready for any eventualities.

3. RDRRMC MIMAROPA

OCD MIMAROPA

- a. Placed OpCen on Blue Alert Status.
- b. Disseminated Weather Bulletein, Flood Advisory, and Gale Warning to P/M/CDRRMCs, Local Radio Stations, and line member agencies through SMS infoboard, facsimile, and uploaded the same to OCD-RDRRMC MIMAROPA social media accounts.
- c. Advised all concerned agencies, P/M/CDRRMCs Chairpersons to activated all local DRRMCs OpCen and closely monitor its AOR for any untoward incident.
- d. Coordinated with response agencies and monitored its respective AOR.

DILG MIMAROPA

- a. Directed Local Chief Executives to convene their local Peace and Order Council to formulate a contingency plan on peace and order and public safety to prevent untoward incidents.
- b. Directed local officials to mobilize and deploy law enforcers, barangay tanods, and medical personnel to national and local roads, and identified critical areas.

Coast Guard District Southern Tagalog

- a. Activated all CGS/CGSS Passenger Assistance Centers (PACs) Help Desk in strategic locations within ports, harbors, and appropriate areas within the AOR.
- b. Placed all Operating Units on heightened alert.

Coast Guard District Palawan

- a. Ordered all CGD Palawan Stations and sub-stations to observe heightened alert and strict compliance with the existing safety and security measures on ports, harbors, and passenger terminals within respective AORs.
- b. Advised all CGS and CGSS to ensure that all maritime activities within their respective areas were monitored and personnel and assets were readily available and prepared to respond to any untoward maritime incident that may happen.
- c. Increased personnel visibility in all critical ports to ensure orderly, safe, convenient, and secure sea travel.
- d. Directed all Coast Guard k9 teams and respective inspectors to exercise extra vigilance in ports and passenger terminals by implementing random inspections on passengers and luggage.

PRO MIMAROPA

- a. Implemented strict security coverage and public safety operations to ensure an orderly and peaceful celebration of New Year in coordination with concerned law enforcement agencies, LGUs, private security providers, and other volunteer organizations.
- b. Initiated operational and administrative activities to increase public awareness on crime prevention as well as provide public safety tips to the community.
- c. Provided pertinent information on different criminal elements, its activities, modus operandi, emerging crime problems, and other peace and order concerns to all tasked units.
- d. Monitored the implementation of the security plan through the Regional OpCen.
- e. Coordinated with AFP for the deployment of augmentation units within the region and undertake necessary preparations and coordination with other concerned government and law enforcement agencies.
- f. Orchestrated the active participation of accredited NGOs, radio groups, transportation and petroleum companies, and community based volunteers as force multipliers in providing traffic management, road safety, and community watch.
- g. Coordinated with community-based volunteers and other multipliers deployed during security operations.

DOH MIMAROPA

- a. Coordinated with and monitored all Provincial Department of Health Office (PDOHO) and HEMS point persons for any untoward incidents.
- Coordinated with DOH Retained Hospitals and other attached agencies including entry and exit points and inventory of all available drugs, medicines and medical supplies including vaccines and transportation assets.
- c. Coordinated with other Regional agencies including PCG, PPA, RDRRMC, OCD, LGUs, BFP, PNP station, and other stakeholders.

- d. Advised PDOHO to coordinate with HEMS-PHO for any health emergencies monitored and to coordinate with Ports Authority and advised nearby port health facilities to be on standby for possible health assistance in relation to the surge of passengers with medical needs.
- e. Advised PDOHO to conduct roving in all areas of concern with potential risk for mass casualty incident.
- f. Coordinated with Ospital ng Palawan and Culion Sanitarium and General Hospital and advised to submit inventory of human resources during the monitoring period.
- g. Coordinated with Logistics Management Units re the availability of essential drugs/medicines and medical supplies including anti tetanus vaccines.
- h. Coordinated with all Hospital HEMS coordinators in the region and advised to proactively coordinate with RO HERO OpCen for their submission of Situational Reports.
- i. Coordinated with PA 505th SAR for the utilization of Air Medical Services within the region.
- j. Coordinated with Health Education and Promotion Services re the distribution of Advocacy Material for Aksyon Paputok Injury Reduction and other preparedness activities.
- k. Coordinated with PHO and advised to educate the public about the dangers of fireworks and further recommend to children and their families to attend public fireworks display rather than purchase fireworks for home use.

BFP MIMAROPA

- a. Placed all fire stations and its personnel on heightened alert status, undertaking proper precautions in responding to any eventualities.
- b. Intensified Community Awareness Campaign.
- c. Distributed fire safety materials and announced on public address systems fire safety precautions for the season.

PPA MIMAROPA

- a. Implemented existing security measures, access regulations, and policy of cargo and vehicle movements within the region.
- b. Activated Public Assistance Center.
- c. Gathered all intelligence reports pertaining to any unlawful activities and submitted to the PPA Port Manager for evaluation, collation, and action.
- d. Conducted random inspection of both conventional and RORO cargoes with PPA Port Police and Arrastre Security Personnel at the Marshalling Area prior to boarding of any vessel.
- e. Conducted baggage inspection of departing passengers via xray machine and walk thru a detector by Port Police and by its PPA hired guards assisted by other law enforcement agencies prior to boarding any vessels.

PRC MIMAROPA

Established First Aid Station with ambulance manned by trained personnel and volunteers in strategic areas.

PDRRMOs

Coordinated with concerned member-agencies and monitored respective AORs.

C/MDRRMCs

- a. Established MDRRMOs and Medical Assistance Desks in coordination with PNP, BFP, MPS, TMO, RHU personnel, MHO, PRC, volunteers, Task Force, Bantay Bayan, Brgy. Officials, and other concerned agencies.
- b. Deployed PNP personnel for security and medical teams with standby ambulance in case of emergency in coordination with concerned agencies within its AOR.
- c. Placed LDRRM OpCen on Alert Status for prompt coordination and monitoring of AOR for any untoward incident that may occur.
- d. Prepositioned standby fire tanker for water needs sand in preparation for any fire incidents.

- a. Placed all fire stations on heightened alert and fire trucks on standby.
- b. Deployed personnel and firefighting apparatus, ambulance, and EMS to visible points of public gathering.
- c. Informed the general public of "OPLAN PAALALA, IWAS PAPUTOK 2016" through the fire truck's public address system.

PNP VI

- a. Placed the station on full alert and deployed personnel for augmentation.
- b. Directed all municipal police stations to be on full alert status and coordinate with their LDRRMCs.
- c. Deployed Police Assistance Hubs in terminals, tourist destinations, and places of convergence.

DOH VI

- a. Alerted all medical teams in all government hospitals.
- b. Disseminated/distributed flyers re "IWAS PAPUTOK 2016".
- c. DOH-HEMB OpCen monitored all health emergencies and coordinated with other key agencies.

PDRRMCs Antique, Guimaras, Iloilo, Capiz, and CDRRMC Iloilo

- a. Activated Operations Center.
- b. Placed responders on standby alert status.

PDRRMC Aklan

- a. Placed PHO, Aklan PPOs, and PCG on heightened alert status.
- b. Placed all MDRRMOs on alert and standby status.

5. RDRRMC VII

- a. Raised its alert status to BLUE on 22 December 2016.
- b. Disseminated information/bulletin from warning agencies to all relevant agencies.
- c. Monitored issuances of warning bulletin by all LDRRMCs and other stakeholders.
- d. Coordinate with RDRRMC member agencies relative to the Year-end celebration.

6. RDRRMC VIII

OCD VIII

- a. Raised the RDRRMOC alert status to BLUE from 30 December 2016 to 02 January 2017.
- b. Monitored the activities and incidents relative to the year-end celebration.

DSWD VIII

- a. Placed Municipal Action Teams, Social Welfare and Development Teams, and Regional QRT on standby for possible augmentation and provision of emergency assistance.
- b. Prepositioned standby funds amounting to ₱3,000,000.00.
- c. Prepositioned family food packs at the municipal level.
- d. Purchased 2,000 sacks of NFA rice and with authority, withdrawed 6,000 sacks of rice for stockpile.
- e. Ensured availability of 13,540 family food packs.

DOH VIII

- a. Placed on Code White Alert from 16 December 2016 until 05 January 2017.
- b. Placed response teams on standby.
- c. Activated and established Operations Center assignments and Information Management System.
- d. Prepositioned medicines and medical supplies to the 6 PDOs.
- e. Conducted Public Service announcements of the "IWAS PAPUTOK" campaign through quad media including dissemination of streamers and posters.
- f. Conducted press conference and hospital rounds for further disseminate the campaign.

PCG CGDEV

- a. Activated the PAC at the different ports in the region from 21 December 2016 to 03 January 2017.

- c. Placed 21 deployable response groups on standby.
- d. Deployed personnel from CGS Tacloban to render duty at the RDRRMOC.

8th Infantry Division, PA

- a. Sent directive to subordinate units on the President's guidance relative to the recent bombing incidents.
- b. Coordinated with PNP counterparts to increase joint patrols and checkpoints in urban centers, ports, churches, and other critical infrastructure.
- c. Deployed personnel from 78th Infantry Battalion to render duty at the RDRRMOC.

- a. Prohibited any firecracker inside camps and intensified proactive efforts to enforce said prohibition in public areas.
