SUBJECT: Cascading of RTF COVID-19 Report Templates for Regional

**Response Clusters** 

With reference to the Memorandum from the National Incident Command (NIC) Emergency Operations Center (EOC) dated 18 April 2020, the Office of Civil Defense (OCD) has cascaded the new reporting templates for the Regional Disaster Risk Reduction and Management Councils (RDRRMCs) as Regional Task Forces (RTFs) for Coronavirus Disease 2019 (COVID-19). For this purpose, the National Disaster Risk Reduction and Management Council (NDRRMC) EOC will reflect in its periodic Situation Report the actual data that are gathered by the RTFs.

However, among the recurring concerns are some inconsistencies in data based on the regional reports received by the OCD. Such can be attributed to the variations in the report templates at the ground level.

In view thereof, the following national government agencies, as members of the NDRRMC, are hereby directed to instruct the counterpart regional offices to adhere to the report templates of the RTFs through the OCD Regional Offices, as prescribed by the NIC EOC. This will ensure the harmonization of reports, validation of data, and alignment to the data requirements of the NIC and the Task Groups.
