I. SITUATION OVERVIEW

13 May 2021

At 2:00 AM, the Low Pressure Area (LPA) over the Philippine Sea east of Davao City has developed into Tropical Depression (TD) "CRISING".

At 4:00 AM, the center of Tropical Depression "CRISING" was estimated at 420 km East of Davao City with maximum sustained winds of 45 km/h near the center and gustiness of up to 55 km/h moving westward at 15 km/h. Tropical Cyclone Wind Signal (TCWS) No. 1 was raised in Surigao del Sur, Davao Oriental, Davao de Oro, and the eastern portion of Agusan del Sur.

At 7:00 AM, "CRISING" maintained its strength and slightly slows down while moving westward. TCWS No. 1 was also raised in Davao del Norte, Davao City, and Agusan del Sur.

At 10:00 AM, "CRISING" intensified into a Tropical Storm while moving west-northwestward towards the Davao Oriental-Surigao del Sur area. TCWS No. 2 was hoisted in the southern portion of Surigao del Sur, the southeastern portion of Agusan del Sur, the northern portion of Davao Oriental, and the northeastern portion of Davao de Oro. TCWS No. 1 was also raised in the rest of Surigao del Sur, the rest of Agusan del Sur, the rest of Davao Oriental, the rest of Davao de Oro, Davao del Norte, Davao City, and the eastern portion of Bukidnon.

At 1:00 PM, TCWS No. 2 was also raised in the northern portion of Davao de Oro and the northern portion of Davao del Norte; and TCWS No. 1 in Agusan del Norte, the rest of Davao del Norte, Bukidnon, Lanao del Sur, Lanao del Norte, Misamis Occidental, Misamis Oriental, Camiguin, and the eastern portion of Zamboanga del Sur.

At 4:00 PM, TS "CRISING" maintained its strength as it moves closer towards Davao Oriental-Surigao del Sur area. The center was estimated at 150 km Southeast of Hinatuan, Surigao del Sur with maximum sustained winds of 65 km/h near the center and gustiness of up to 80 km/h moving West Northwestward at 25 km/h. Areas with TCWS No. 2 was still in

effect while TCWS No. 1 was raised in the Visayas at the southeastern portion of Negros Oriental and Siquijor; and in Mindanao in Surigao del Norte including Bucas Grande and Siargao Islands, the northeastern portion of Zamboanga del Sur, and northeastern portion of Zamboanga del Norte.

At 7:00 PM, TCWS No. 2 was still in effect while the northern portion of Cotabato and the northern portion of Maguindanao were included under TCWS No. 1.

At 8:00 PM, "CRISING" weakened into a Tropical Depression and made its landfall in the vicinity of Baganga, Davao Oriental at 8:20 PM.

At 10:00 PM, the center of TD "CRISING" was estimated in the vicinity of New Bataan, Davao de Oro with maximum sustained winds of 55 km/h near the center and gustiness of up to 90 km/h moving Westward at 20 km/h. TCWS No. 1 was hoisted in the Visayas at the southeastern portion of Negros Oriental and Siquijor; and in Mindanao at the southern portion of Surigao del Sur, the central and southern portions of Agusan del Sur, Davao Oriental, Davao de Oro, Davao del Norte, Davao City, the northern portion of Cotabato, the northern portion of Maguindanao, Lanao del Norte, Lanao del Sur, Misamis Occidental, Bukidnon, the central and western portions of Misamis Oriental, the northeastern portion of Zamboanga del Sur, and the northeastern portion of Zamboanga del Norte. TCWS in other areas were lifted.

14 May 2021

At 1:00 AM, TD "CRISING" maintained its strength as it continues to move generally westward and is now over Davao del Norte. The center was estimated in the vicinity of New Corella, Davao del Norte with maximum sustained winds of 55 km/h near the center and gustiness of up to 90 km/h. Areas with TCWS No.1 was still in effect.

At 4:00 AM, "CRISING" slightly weakens as it continues to approach the Pantaron Mountain Range. The center of TD "CRISING" was estimated based on all available data in the vicinity of Kapalong, Davao del Norte with maximum sustained winds of 45 km/h near the center and gustiness of up to 75 km/h. TCWS No.1 over the southern portion of Davao Oriental was lifted while TCWS in other areas were retained.

At 7:00 AM, "CRISING" accelerated West-Northwestward and was in the vicinity of Lanao del Sur while maintaining its strength. The center of the eye of TD "CRISING" was estimated based on all available data in the vicinity of Marawi City, Lanao del Sur. Areas with TCWS No.1 was still in effect.

At 8:00 AM "CRISING" weakened into a Low Pressure Area. All TCWS were lifted.

At 10:00 AM, the center of the Low Pressure Area (formerly "CRISING") was estimated in the vicinity of Piagapo, Lanao del Sur.

II. EFFECTS

A. Related Incidents

Flooding Incident - 2

1. On 14 May 2021, at 8:30 AM, a flooding incident occurred in Sitio Dumpao, Brgy. Timabangan, Maguindanao (BARMM) due to continuous light to moderate rainfall. Ongoing validation as to the extent of the effects of flooding is being conducted.
2. On 14 May 2021, a flooding incident occurred in Sitio Banabasan, Brgy. Kakal, Ampatuan, Maguindanao (BARMM) due to continuous light to moderate rainfall thus, resulted in the overflowing of Kabulnan River.

B. Affected Population

A total of **12,019 families** or **59,597 persons** were affected in **63 barangays** in **Regions IX and XI**. Of which, **33 families** or **165 persons** are currently taking temporary shelter in **one (1) evacuation center**. Meanwhile, a total of **1,644 families** or **8,220 persons** in Region IX opted to stay with their relatives and/or friends.

III. DISASTER PREPAREDNESS and RESPONSE

A. NATIONAL DRRM COUNCIL (NDRRMC)

1. NDRRM Operations Center (NDRRMOC)

- Maintained RED ALERT Status since COVID-19 response operations.
- Continuous monitoring and ensure dissemination of Weather Advisories, and General Flood Advisories to all concerned RDRRMCs/OCDROs through SMS, NDRRMC website, and official social media websites for further dissemination to their respective Local Disaster Risk Reduction and Management Councils (LDRRMCs).

2. Philippine Atmospheric Geophysical Services Administration (PAGASA)

- Ensured that all transport logistics assets are ready for handling/hauling of relief resources.
- Ensured that the DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) have stockpiles and standby funds amounting to ₱1,258,822,330.15 with details below:

Standby Funds

A total of ₱485,309,574.60 standby funds in the CO and FOs. Of the said amount, ₱441,887,531.80 is the available Quick Response Fund (QRF) in the CO.

Stockpiles

A total of 268,382 family food packs (FFPs) amounting to ₱135,541,982.63, other food items and non-food items amounting to ₱747,351,491.81.

4. Department of Health (DOH)

- Raised Code Alert

- b. Sent weather alert memorandum to all Centers for Health Development and BARMM Ministry of Health and DOH-retained hospitals.
- c. Ensured availability of commodities worth ₱33,478,220.95 is available at the DOH Central Office warehouse.
- d. Reiterated DC No. 2020-0167 re “Continuous provision of Essential Health Services during the COVID-19 Epidemic”.

DOH Regional Offices

- Alerted concerned Provincial DOH Offices to actively monitor and report untoward incidents in their respective areas of responsibility.
- Continuous monitoring of the situation of TTMFs in their respective Regions.
- Continuous coordination with concerned Provincial DOH Offices (PDOHO), Provincial Health Offices (PHOs), Office of the Civil Defense (OCD), and Regional and Local Disaster Risk Reduction Management Council.

- a. Provided a list of cities and municipalities susceptible to landslide and flood to the NDRRMOC and other concerned offices for information, reference, and redundancy of information.
- b. Attended the NDRRMC Emergency Meetings and PDRA Meetings and presented and recommended the following:
 - Vigilant monitoring of areas showing signs of landslides such as tension cracks, seepages, terracettes, and tilting of trees.
 - Avoid areas affected by repeated flooding, meandering with riverbank erosion, floodplain with shifting and braiding streams, coastal areas, affected by storm surge, flashflood areas, and river deltas with many distributary channels.
 - Be aware of the geohazard in your area. MGB Geohazard maps are available in the barangay, municipal, and provincial LGUs nationwide as well as your respective MGB Regional Offices. Visit the MGB Web portal and other platforms like Hazard Hunter (GeoRiskPH).

B. REGIONAL DRRM COUNCILS (RDRRMC)

RDRRMCs are continuously monitoring their areas of responsibility. Further, said RDRRMCs are in coordination with their respective member agencies to ensure the widest dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories through SMS, facsimile, and official social media websites.

- d. Disseminated to LGUs the MGBs Updated List of LGUs Prone to Landslide and Flood, GSM & WRF Daily Forecast Rainfall and “CRISING” Potential Risk Area.
- e. Advised LGUs thru DILG field officers to monitor the PAG-ASA weather advisories and typhoon bulletins.
- f. Continuous updating of the provinces by sending weather bulletin through email and social media.
- g. Enjoined LGUs actively carry out actions as recommended in Operation LISTO and DILG Memo Circular No. 2020-125-LISTO SA TAG-ULAN AT COVID-19: Preparedness Measures of LGUs for the Rainy Season CY 2020.
- h. Reminded LGUs to assess the structural integrity of the structures that will be used for evacuation and other related purposes and ensured that they can withstand the strong winds brought about by “CRISING”.
- i. Monitored new tool that can be used to generate indicative hazard assessment on the user's specified location.
- j. Established critical preparedness actions based on the operation LISTO protocols, and prioritize preemptive evacuations and repositioning of supplies and equipment for a response.
- k. Submitted Critical Preparedness Actions of LGUs to DILG CODIX and OCD.
- l. Conducted information-dissemination by MLGOOs of the Province of Marinduque on their respective LGUs and all Barangays were informed on the current weather advisories. Evacuation Centers were also prepared in compliance with DILG MC 2021-201.
