# I. SITUATION OVERVIEW

# A. CHRONOLOGY (TAB A)

03 June 2021

As of 8:00 AM, TS "DANTE" continues to move north northwestward over the coastal waters west of Pangasinan. At 7:00 AM, the center of TS "DANTE" (CHOI-WAN) was estimated based on all available data 145 km West Northwest of Dagupan City, Pangasinan, with maximum sustained winds at 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 998 hPa, moving north northwestward at 35 km/h, and with gale-force winds extend outward up to 50 km from the center.

TCWS No. 2 was raised over the western portion of Pangasinan. TCWS No. 1 was raised over the central portion of Pangasinan, the northwestern portion of Tarlac, and the northern portion of Zambales.

As of 02 June 2021, 8:00 PM, TS "DANTE" made a total of 8 landfalls since 01 June 2021:

- e. Conducted PDRA Core Group Meeting together with RDRRMCs NCR, CAR, II, III, CALABARZON, MIMAROPA, V, VI, VII, VIII, IX, X, XI, XII, and BARMM on 31 May 2021, 4:00 PM via video teleconferencing.
- f. Disseminated a total of 27 Emergency Alert and Warning Messages (EAWM).
- g. Established and activated the Virtual Emergency Operations Center (EOC) on 01 June 2021.

# B. REGIONAL DRRM COUNCILS (RDRRMC)

RDRRMCs I, II, III, CALABARZON, MIMAROPA, V, VI, VII, VIII, XI, CARAGA, CAR, and NCR are continuously monitoring its areas of responsibility. Further, said RDRRMCs are in coordination with their respective member agencies to ensure the widest dissemination of Weather Advisories, 24-hour Public Weather Forecasts, Gale Warning, Severe Weather Bulletins, and General Flood Advisories through SMS, facsimile, and official social media websites.

# C. PRE-EMPTIVE EVACUATION

A total of 280 families / 1,043 persons were pre-emptively evacuated in Regions V and VII.

# Preparedness Measures and Effects of TS "DANTE" (I.N. CHOI-WAN) CHRONOLOGY TROPICAL CYCLONE BULLETIN

As of 03 June 2021, 8:00 AM

# 30 May 2021

At 5:00 AM, Tropical Depression east of Mindanao entered the Philippine Area of Responsibility (PAR) and was named "DANTE". At 4:00 AM, the center of TD "DANTE" was estimated at 1,000 km east of Mindanao with maximum sustained winds of 45 km/h near the center, gustiness up to 55 km/h, the central pressure of 1,004 hPa, and moving West Northwestward at 15 km/h.

At 5:00 PM, TD "DANTE" decelerated and moved west-northwestward over the Philippine Sea east of Mindanao. At 4:00 PM, it was estimated at 835 km east of Mindanao with maximum sustained winds of 55 km/h near the center, gustiness up to 70 km/h, the central pressure of 1,002 hPa, and moving west Northwestward at 15 km/h.

At 11:00 PM, TD "DANTE" maintained its strength while moving northwestward. At 10:00 PM, it was estimated at 685 km east of Davao City with maximum sustained winds of 55 km/h near the center, gustiness up to 70 km/h, the central pressure of 1,000 hPa, and moving Northwestward at 15 km/h.

# 31 May 2021

At 5:00 AM, TD "DANTE" intensified into a Tropical Storm (TS). At 10:00 AM, the center of TS "DANTE" was estimated at 625 km East of Davao City, with maximum sustained winds of 65 km/h near the center, gustiness up to 80 km/h, the central pressure of 998 hPa, and moved North Northwestward at 15 km/h. Gale-force winds extend outward up to 50 km from the center.

At 11:00 AM, TS "DANTE" slightly intensified while moving northwestward over the Philippine Sea.

At 5:00 PM, TS "DANTE" maintained its strength as it continued to move Northwestward over the Philippine Sea. At 4:00 PM, it was estimated at 375 km East Northeast of Hinatuan, Surigao del Sur or 455 km East of Surigao City, Surigao del Norte, with maximum sustained winds of 75 km/h near the center, gustiness up to 90 km/h, the central pressure of 996 hPa, moving Northwestward at 20 km/h, and gale-force winds extend outward up to 80 km from the center.

TCWS No. 1 was raised in the eastern portion of Northern Samar (Mapanas, Gamay, Lapinig, Palapag, Laoang) and the northeastern portion of Eastern Samar (Arteche, San Policarpio).

At 11:00 PM, TS "DANTE" maintained its strength as it continued to move Northwestward over the Philippine Sea. At 10:00 PM, it was estimated at 375 km East of Surigao City, Surigao del Norte, with maximum sustained winds of 75 km/h near the center, gustiness up to 90 km/h, the central pressure of 996 hPa, moving Northwestward at 20 km/h, and gale-force winds extend outward up to 100 km from the center.

TCWS No. 1 was raised in LUZON: the eastern portion of Sorsogon, Northern Samar, Samar, Eastern Samar, Biliran, the eastern portion of Leyte, the eastern portion of

Southern Leyte (Sogod, Libagon, Saint Bernard, San Juan, Anahawan, Hinundayan, Silago, Hinunangan), Dinagat Islands, and Siargao, and Bucas Grande Islands.

# 01 June 2021

As of 5:00 AM, the center of Tropical Storm "DANTE" (CHOI-WAN) was estimated at 310 km East of Surigao City, Surigao del Norte or 380 km East of Maasin City, Southern Leyte (10.2°N, 128.3°E), with maximum sustained winds of 75 km/h near the center, gustiness up to 90 km/h, and a central pressure of 996 hPa.

As of 8:00 AM, TS "DANTE" turns west-northwestward while over the Philippines Sea East of Dinagat-Siargao Island. At 7:00 AM, the center of TS "DANTE" (CHOI-WAN) was estimated based on all available data at 270 km East of Maasin City, Southern Leyte, with maximum sustained winds of 75 km/h near the center, gustiness up to 90 km/h, the central pressure of 996 hPa, moving west-northwestward at 20 km/h, and gale-force winds extend outward up to 100 km from the center.

As of 11:00 AM, TS "DANTE" maintains its strength while moving westward over the Philippine Sea east of the Dinagat-Siargao Islands area. At 10:00 AM, the center of TS "DANTE" (CHOI-WAN) was estimated based on all available data at 235 km east of Maasin City, Southern Leyte, with maximum sustained winds of 75 km/h near the center, gustiness up to 90 km/h, the central pressure of 996 hPa, moving westward at 25 km/h, and gale-force winds extend outward up to 100 km from the center.

As of 2:00 PM, TS "DANTE" is now moving north-northwestward towards the southern portion of Eastern Visayas. At 1:00 PM the center of TS "DANTE" (CHOI-WAN) was estimated on all available data at 220 km East Northeast of Maasin City, Southern Leyte, or 125 km east southeast of Guiuan, Eastern Samar, with maximum sustained winds of 75 km/h near the center, gustiness up to 90 km/h, the central pressure of 996 hPa. Moving North Northwestward at 15 km/h, and gale-force winds extend outward up to 100 km from the center.

As of 5:00 PM, TS "DANTE" slightly weakens as it continues to move north-northwestward closer towards Eastern Samar. At 4:00 PM, the center of TS "DANTE" (CHOI-WAN) was estimated based on all available data at 85 km East Northeast of Guiuan, Eastern Samar or 110 km East Southeast of Borongan City, Eastern Samar, with maximum sustained winds of 65 km/h near the center, gustiness up to 80 km/h, the central pressure of 998 hPa, moving North Northwestward at 25 km/h, and gale-force winds extend outward up to 100 km from the center.

TCWS No. 2 was raised over Catanduanes, Camarines Sur, the southern portion of Camarines Norte, Masbate including Ticao and Burias Island, Albay and Sorsogon, Eastern Samar, Samar, Northern Samar, Biliran, and the northeastern portion of Leyte.

Meanwhile, TCWS No. 1 was raised over Rizal, Laguna, the southeastern portion of Batangas, Quezon including Polillo Islands, the rest of Camarines Norte, Marinduque, and Romblon, the northeastern portion of Aklan, the northeastern portion of Capiz, the northeastern portion of Iloilo, the northeastern portion of Negros Occidental, the northern portion of Cebu, the northeastern potion of Bohol, the rest of Leyte and Southern Leyte, Surigao del Norte including Siargao and Bucas Grande Islands, Dinagat Island, the northern portion of Agusan del Norte, the northern portion of Agusan del Sur, and the northern portion of Surigao del Sur

As of 8:00 PM, TS "DANTE" maintains its strength and is about to make landfall over the northern portion of Eastern Samar. At 7:00 PM the center of TS "DANTE" was estimated based on all available data at 55 km East Northeast of Borongan City, Eastern Samar, with maximum sustained winds of 65 km/h near the center, gustiness up to 80 km/h, and a central pressure of 998 hPa, moving northwestward at 30 km/h, and galefore winds extend outward up to 100 km from the center.

At 8:30 PM, the center of TS "DANTE" made its landfall in the vicinity of Sulat, Eastern Samar.

# 02 June 2021

As of 2:00 AM, TS "DANTE" made another landfall in the vicinity of Cataingan, Masbate. At 1:00 AM the center of TS "DANTE" was estimated based on all available data in the vicinity of Cataingan, Masbate, with maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and a central pressure of 998 hPa, moving west-northwestward at 20 km/h, and gale-force winds extend outward up to 80 km from the center.

As of 5:00 AM, TS "DANTE" is now off the southwestern coast of Masbate and is heading towards the vicinity of Romblon. At 4:00 AM the center of Tropical Storm "DANTE" (CHOI-WAN) was estimated based on all available data including those from Mactan and Iloilo Doppler Weather Radars over the western coastal waters of Balud, Masbate, with maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 1000 hPa, moving west at 25 km/h, and gale-force winds extend outward up to 50 km from the center.

As of 8:00 AM, TS "DANTE" is about to make landfall in the vicinity of Romblon. At 7:00 AM, The center of Tropical Storm "DANTE" (CHOI-WAN) was estimated based on all available data including those from Iloilo Doppler Weather Radar over the southern coastal waters of Romblon, Romblon, with maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 1000 hPa, moving west at 25 km/h, and Gale-force winds extend outward up to 50 km from the center.

As of 11:00 AM, TS "DANTE" is now moving Northwestward and is approaching the eastern coast of Oriental Mindoro, with maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 1000 hPa, moving west at 25 km/h, and gale-force winds extend outward up to 50 km from the center.

As of 2:00 PM, TS "DANTE" continues to move northwestward towards the southwestern portion of Batangas - northeastern portion of Oriental Mindoro. At 1:00 PM, the center of Tropical Storm "DANTE" (CHOI-WAN) was estimated based on all available data over the over the coastal waters of Pola, Oriental Mindoro or 45 km East Southeast of Calapan City, Oriental Mindoro, with maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 1000 hPa, moving northwestward at 25 km/h, and gale-force winds extend outward up to 50 km from the center.

As of 5:00 PM, TS "DANTE" is now moving west northwestward ang is heading towards the Southwestern coast of Batangas. At 4:00 PM the center of Tropical Storm "DANTE" (CHOI-WAN) was estimated based on all available data over the coastal waters of Calapan, Oriental Mindoro, with maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 998 hPa, moving West

Northwestward at 15 km/h, and gale-force winds extend outward up to 50 km from the center.

As of 8:00 PM, TS "DANTE" is now over the Verde Island passage and is moving towards the southwestern coast of Batangas. At 7:00 PM, the center of Tropical Storm "DANTE" (CHOI-WAN) was estimated based on all available data over the coastal waters of Calapan, Oriental Mindoro, maximum sustained winds of 65 km/h near the center, gustiness up to 90 km/h, and central pressure of 998 hPa, moving Northwestward at 20 km/h, and gale-force winds extend outward up to 50 km from the center.

As of 11:00 PM, TS "DANTE" has crossed the southwestern portion of Batangas and is now heading towards the Bataan Peninsula-Southern Zambales area. - Emergency Operations Center (EOC) has been placed on heightened alert status to monitor the possible effects of Tropical Cyclone "Dante".
- EOC has constant communication with the Local Social Welfare and Development Offices (LSWDOs) with pre-disaster assessments being conducted.
- DSWD-FO CALABARZON DRMD conducted close coordination with the Local Government Units (LGUs) with regards to the preparedness efforts undertaken in the Flood, Landslide and Storm Surge prone areas.
- Coordinated with SWAD Team Leaders and Provincial Action Team of the CALABARZON and advised them to monitor and coordinate with the LGUs to gather reports on the possible effects of Tropical Cyclone "Dante".
- Coordinated with LSWDOs and LDRRMOs and advised them to be on standby alert and prepare their respective evacuation centers, and family food packs should need arises.
- Coordinated with RDRRMC IV-A OpCen for updates on the preparedness level of the members of the Response Cluster of the region.
- Informed member agencies of the response cluster to be on-stand-by alert status and ready for mobilization in case situation arises.

#### DSWD V

- DSWD-FO V shall continuously monitor weather updates and information.
- Resource Operation Section ensures the availability of family food packs and non-food items, as need arises.
- DSWD-FO V Quick Response Team (QRTs) are alerted.

- PAT and MAT members in the six (6) provinces are activated and instructed to coordinate with the P/MDRRMOs and C/MSWDOs for weather reports and updates.
- DRMD team are activated and are now on duty at DSWD 5 Operation Center.
- Resource Operation Section ensures the availability of family food packs and non-food items, as need arises.
- DSWD-FO V Quick Response Team (QRTs) are alerted ready for augmentation.
- PAT and MAT members in the six (6) provinces are activated and instructed to coordinate with the P/MDRRMOs and C/MSWDOs for weather reports and updates.

#### **DSWD MIMAROPA**

- Alerted SWADT Offices to monitor daily local weather condition and related eventualities, and ensure provision of information to all concerned offices, divisions, sections, and units.
- On-call status of the expanded R/P/C/M QRTs together with special projects staff on a 24/7 basis for possible activation of Operation Center to respond in case any untoward incident and eventualities are reported.
- Standby logistical equipment and workforce through coordination with SWADT Offices and concerned LGUs on the management of stranded passengers, if any, in ports and terminals.
- Information and Communication Technology Management Unit (ICTMU) is on standby status to ensure robust communication system.
- Cordinated with the Office of Civil Defense (OCD) and RDRRMC MIMAROPA for any updates for monitoring purposes and response mechanism for areas that will be affected.
- Coordinated with the Local SWDOs on the implementation of minimum health protocols related to Camp Coordination and Camp Management to prevent and mitigate the possible transmission of COVID19 and other illnesses during evacuation.

#### **DSWD VI**

- Close Coordinated with Provincial DROMIC Counterpart on the submission of DROMIC report.
- Real time Monitoring of weather report and information dissemination.
- QRT Isabela, Negros Occidental augmented last June 01, 2021 in the MSWDO since MSWDO staff are currently under quarantine.
- The Disaster Response Management Division coordinated with PSWDO for significant reports on the status of affected families, assistance, and relief efforts.
- Provided technical assistance on DROMIC Report Writing.

#### **DSWD VII**

- Regional/Provincial/City/Municipal Quick Response Team is on standby alert and ready for mobilization for any assistance and augmentation support needed from the LGUs.
- City and Municipal Action Team and SWAD Offices were alerted and already requested to closely coordinate with their local counterparts and their respective LDRRMCs. Field staff requested to monitor AOR and provide reports and updates to the Regional DROMIC Focal for any

- impacts/effects.
- Monitored the DSWD Regional DROMIC Focal for the latest weather updates from PAGASA and cascading the same for widest dissemination to Provincial /City/Municipal Action Teams.
- Regional Disaster Division coordinated with OCD-7 and other members of the RDRRMC for any response mobilization activities/strategies. Regional QRT members on standby alert.

#### **DSWD VIII**

- Communicated with SWAD Teams and City/Municipal Actions Teams to be alerted on the weather disturbance.
- Monitored the weather situation through watching the live updates of PAGASA regarding the weather disturbances.
- Activated QRT of DSWD in preparation for the possible impact of the tropical storm.
- SFO Northern Samar attended their PDRA Meeting last May 31, 2021.
- Coordinated with DRMD PDOs regarding updates on the weather status in different provinces of Eastern Visayas.
- Established DROMIC Tool for Tropical Storm Dante in the live spreadsheet for monitoring and reporting.

#### **DSWD** X

- A total of 14 families or 57 persons have pre-emptively evacuated in Mahinog, Camiguin. All of these families have returned home.
- Monitored the current weather disturbance brought about by TS Dante.

#### DSWD XI

Coordinated with CDRRMO and CSWDO for any significant updates.

#### **DSWD XII**

 DSWD-FO XII DRMD staff monitored the incident through phone call in close coordination with the MSWDO of Banga for possible Technical Assistance and Resource Augmentation.

# **DSWD CARAGA**

- Continuously monitored the weather updates.
- Activated its Quick Response Team (QRT) to render duty in the Emergency Operation Center (EOC) in a 24/7 basis.
- Coordinated with SWADTLs and LSWDOs to monitor the situation in their respective area of responsibility.
