## SitRep No. 5 for Year-End Celebration 2021

December 30, 2021 08:00 am

SPECIAL WEATHER OUTLOOK DURING THE CHRISTMAS HOLIDAYS (issued 21 December 2021)

### (24 DECEMBER 2021 - 02 JANUARY 2022)

-The Northeast Monsoon, Tail-end of Cold Front (Shear Line), and the approach of a Low Pressure Area (LPA) will be the dominant weather systems to affect the entire archipelago this coming holiday season.

-On Friday, until Saturday (24-25 December): the eastern section of Luzon, Visayas and Mindanao will be mostly cloudy skies with scattered light rains while the rest of Luzon will be partly cloudy with isolated light rains.

-By Sunday until Tuesday (26-28 December): occasional rains are expected over the eastern section of Luzon and Mindanao and Eastern Visayas due to the southward migration of the Shear Line. The rest of the country will be cloudy with light rains.

-By Wednesday until Friday (29-31 December 2021): frequent rains over southern Luzon, Visayas, and Mindanao caused by the approach of Low Pressure Area (LPA). The rest of Luzon will have partly cloudy with isolated light rains, particularly the eastern section.

-On New Year's Day (Saturday) until Sunday (01-02 January): southern Luzon, Visayas and Mindanao will be cloudy with scattered rainshowers while the rest of Luzon will have fair weather conditions apart from isolated passing light rains. -Flood and landslides are expected over prone areas of Visayas and Mindanao and the provinces over the eastern section of Luzon.

-Sea travelers over the seaboards of the country especially on the eastern section should exercise extra caution due to strong winds that could generate big waves.

? Post "OPLAN BIYAHENG AYOS: IMPLEMENTATION OF HEIGHTENED ALERT STATUS DURING THE PASKO 2021 MALASAKIT HELP DESK", tarpaulins in conspicuous areas in your jurisdiction. Tarpaulins should include the DOTr official logo, PPA agency logo and hotline numbers.

? Require ship agents to provide and regularly update the passengers of their ships' arrival and departure schedules.

? Strict implementation of security measures and regulations.

? Ensure enough manpower complement to man the ports during the period.

- Informed the Punong barangays of weather advisories and other relevant information.
- Placed all heavy equipment and emergency response equipment on standby.

#### ALAMINOS

• Alaminos City DRRM Command center is in constant monitor of weather updates. Updates and reminders are sent via quad media to CDRRM council members, member agencies, punong barangays, BDRT's and general public.

• All personnel of the Alaminos City Response team and Response Cluster member agencies were alerted and are resdy to report upon notification.

- Close and constant coordination with CDRRM council members being conducted.
- Dispatched Roving team at Tourist Hotspot areas.
- Conducted inspection of market area for hot meats and fire crackers selling area.
- First aid teams on standby.

## **ILOCOS SUR**

• Activate 24/7 PDRRMC llocos Sur Emergency Operations Center.

• PDRRMO Staff headed by PDRRM Officer Mr. Michael C. Chan are 24/7 on duty monitoring the weather disturbance.

• Information dissemination to the C/MDRRMOs as well as the public through text blast and social media about up-to-date weather information and warnings through Office of Civil Defense, PAGASA and PHILVOCS especially during the Season of Christmas and New Year.

• Prepositioned the PDRRMC Rescue Vehicles: Ambulance 1, Ambulance 2, Ambulance Truck, Ural-Next Truck, Rescue 1, 6x6 Truck, Hummer, Kalsada Task Force1, Kalsada Task Force 2, Hummer 1, Rescue Bike 1, Rescue Bike 2, Rescue Truck and 3 OBM Fiber Boats at the Provincial Capitol for possible emergency response.

• All C/MDRRM will be manning their own respective Areas of Responsibility (AOR)

• Enforced timely and accurate situational reports from the C/MDRRMCs, as needed.

## **ILOCOS NORTE**

• Inform all Barangay Chairmen and Officials in your City/Municipality of the prevailing weather condition which might bring heavy rainfall, landslides and storm surges and for them to immediately disseminate the same to all residents and take all necessary precautions, preparations and monitor weather updates.

• Regularly monitor the health condition of vulnerable groups; senior citizen, PWDs, pregnant women and children.

• Coordinate with the PNP, BFP, Coast Guard, Air Force, MARITIME, Army and other uniformed Personnel in your respective area together with Barangay Officials to regularly monitor areas.

• Ready equipment- dump trucks, rubber boats, evacuation centers, ambulances, food packs, relief goods, medicines, SAR Teams, personnel and other resources and constantly monitor flood, landslide and storm surge risk areas.

• Implement Pre-emptive and or forced evacuation of residents if needed in highly vulnerable areas to flooding, storm surges and landlines.

• Advise all residents to limit outside exposure (only when necessary) and stay indoors especially when there are strong winds, storm surges, heavy rainfall, thunderstorms accompanied by lightning.

\_ On Code White on December 21, 2021 to January 5, 2022.

The Regional Emergency Incident Command System is hereby activated;

\_ The members of the Disaster Risk Reduction Management in Health - Operation Center will continue to be on 24/7 operations;

\_ All DOH-Retained Hospitals in the region are ordered to be on same code status and must activate and prepare their personnel and provide standby emergency teams ready for deployment. Also, they must ensure availability of adequate emergency medicines and supplies and submit flash report for any untoward incident to the DRRM-H OpCen. They must also ensure availability of adequate emergency medicines and supplies and submit daily report or "Zero Reporting" using the HEARS reporting form to the DRRM-H OpCen at 4PM and 10PM.

\_ Follow roles and responsibilities under the ICS, all emergency response teams shall be on standby ready for development;

\_ The Development Management Officer V will conduct active monitoring of health-related events and will conduct "Zero Reporting" to be submitted in the DRRM-H OpCen at 3PM and 10 PM every day. The Development Management Officer IV will be in the field to conduct active monitoring and will report to their respective DMO Vs;

\_ The Regional DRRM-H-OPCEN shall conduct active monitoring for any health-related emergencies in the region that have an impact on the region's public health and safety and be ready to provide material, human resource and logistical support to Local Government Units (LGUs). In addition, coordination with Health Emergency Management Bureau (HEMB), Office of the Civil Defense (OCD), and Regional Disaster Risk Reduction Management Council (RDRRMC) will be conducted until the alerts have been lifted.

### BFP

- \_ On Heightened Alert.
- \_ Activate all communication hotlines 24/7 for a quick and immediate responses and coordination.
- \_ Special Rescue Unit Personnel on standby.

## DPWH

\_ Activated all District Disaster Operations Center.

- \_ Prepositioned heavy equipment.
- \_ Established Motorist Assistance Center in strategic areas in the Region.

## PNP

\_ On Heightened Alert.

\_ Provide information for public awareness;

\_ Confiscate and destroy prohibited fireworks and pyrotechnic devices (FCs/PDs) described under Rule II of the Revised IRR of RA 7183 to include firecrackers being used outside community fireworks display.

\_ Enforce applicable laws and directives pertaining to the manufacture, use, sale, distribution and transport of firecrackers and pyrotechnic devices to ensure public safety.

\_ Ensure that firecracker zones and firecracker display zones are properly managed in coordination with appropriate agencies/stakeholders;

\_ Conduct inventory of firearms and ammunition dealers.

\_ Established Police Assistance Desks (PADs) along major highways, airports, seaports, bus terminals, malls, resorts and other places of convergence in coordination with other concerned law enforcement agencies, LGUs and volunteer groups.

\_ Organize and alert Quick Response Teams (QRTs) and be ready for deployment as the need arises.

\_ Conducted inspection on the deployment of personnel to ensure their presence and alertness in their respective areas of responsibilities.

\_ Intensified intelligence, counter intelligence, and police operations to preempt terrorist and criminal activities;

 Ensure that all established checkpoints shall comply with the guidelines provided in the Revised PNP Operational Procedures;

\_ Activated community defense system against lawless armed groups and undertake active security patrols to residential and commercial areas to prevent intrusion to dwelling, theft, and robbery;

\_ Deployed Road Safety/Security Marshalls where most needed (gridlock areas, under construction highways security and safety operations);

\_ Enforced applicable laws and directives pertaining to the manufacture, use, sale, distribution and transport of firecrackers and pyrotechnic devices to ensure public safety.

\_ Ensured that firecracker zones and firecracker display zones are properly managed in coordination with appropriate agencies/stakeholders;

\_ Conducted inspection on establishments dealing with firecrackers and pyrotechnic materials.

\_ Deploy resources based on your historical data where incidents happened in the past in order to have a more focused police operations.

\_ All CGDNELZN units shall be on Heightened Alert from 16 December 2021

\_ All CGDNELZN Units shall intensify VSEI/MPDI and safety inspections to all vessels, water crafts, recreational facilities to ensure safety and security of the riding public;

\_ The help desk shall act as facilitators on the requests and complaints of the public, and shall refer the matter on hand to the office and/or shipping/boat operators concerned. The safety and security of the
