DEACTIVATION OF RESPONSE CLUSTERS ICOW

EARTHQUAKE IN ABRA AND ACTIVATION AND STANDBY STATUS ICOW TROPICAL DEPRESSION (TD) "PAENG" ON

27 OCTOBER 2022

In view of the virtual EOC meeting ICOW M6.4 earthquake in Abra held on 27 October 2022, whereas the affected regions cited minimal effects and request for augmentation, the then activated Response Clusters are hereby deactivated effective 27 October 2022, 5:00 PM.

However, due to the further intensification of TD "PAENG" and as agreed during the PDRA Core Group Meeting, the following Response Clusters are hereby activated effective 27 October 2022, 5:00 PM to monitor and facilitate emergency response and humanitarian assistance in response to the effects of the said TD:

Activated

- 1. Logistics (OCD)
- 2. Food and Non-Food Items (DSWD)
- 3. Camp Coordination and Camp Management (DSWD)
- 4.Internally Displaced Persons Protection (DSWD)
- 5. Health (DOH)
- 6. Shelter (DHSUD)
- 7. Education (DepEd)
- 8. Law and Order (PNP)
- 9. Search, Rescue and Retrieval (AFP)
- 10. Emergency Telecommunications (DICT)

On Standby / As Need Arises

- 1. Management of the Dead and Missing (DILG)
- 2. Philippine International Humanitarian Assistance (DFA)
- 3. Early Recovery (OCD)

In light of the ongoing COVID-19 pandemic, Response Clusters are not required to render duty at the NDRRMC Emergency Operations Center. However, to facilitate easier coordination in relation to search and rescue and monitoring of casualties one (1) representative each from the AFP and DILG, respectively, is required to render duty at the NDRRMOC, Camp General Emilio Aguinaldo, Quezon City.

Furthermore, all Cluster Leads are directed to submit their cluster situation reports using the standard report template not later than 8:00 PM daily to the Vice-Chairperson for Response, DSWD at drmb@dswd.gov.ph copy furnished the dromd-group@dswd.gov.ph and OCD at rocd@ocd.gov.ph.
