Creation of NDRRMC Technical Working Group on

Reporting of Affected Population and Pre-emptive

Evacuation

I. BACKGROUND AND PURPOSE:

During the disaster operations for Severe Tropical Storm PAENG in October 2022, challenges and gaps in report development, specifically on the Affected Population and Pre-emptive Evacuation, were identified resulting in disparities in figures reported by the National and Regional Government Agencies, and Local Government Units.

Relative to this, a Round-Table Discussion was conducted on 16 November 2022 to discuss the observations noted in reporting for Affected Population and Pre-emptive Evacuation. During the plenary session, it was recommended to review and revisit the existing guidelines concerning the responsible agencies/offices who will serve as the official source of data/information.

In recognition of the need to come-up with a clear guideline in reporting Affected Population and Pre-emptive Evacuation, a NDRRMC Technical Working Group (NDRRMC-TWG) for Reporting Affected Population and Pre-emptive Evacuation is hereby created to act and perform the following roles and responsibilities:

- a. Identify the gaps and disconnect on the data collection and report development.
- b. Identify parameters/indicators and technical definitions for affected population and pre-emptive evacuation.
- c. Provide recommendations on how to harmonize reporting timelines.
- d. Present the outputs and agreements to ROs and other concerned agencies for further development and finalization.
