#### I. SITUATION OVERVIEW

The synchronized fully automated National and Local Elections (NLE) was scheduled on 13 May 2019 as mandated in Section 2 of RA 7166. Likewise, per RA 10153, the ARMM elections was synchronized with the 2019 NLE.

A total of 389,686 established precincts were used to accommodate 61,843,750 voters all over the country. Over 18,000 seats ranging from local councils to the senate were expected to be contested for this election. Those elected therein will take office on 30 June 2019.

Further, "Gun Ban" was implemented from 13 January to 12 June 2019. The law states that "no person shall bear, carry or transport firearms or other deadly weapons in public places, including in any building, street, park, private vehicle or public conveyance, even if licensed to possess or carry the same, unless authorized in writing by the Commission.

On 13 May 2019, Inter Tropical Convergence Zone (ITCZ) affected Visayas and Mindanao, bringing cloudy skies with scattered rainshowers and thunderstorms. Meanwhile, Luzon experienced partly cloudy to cloudy skies with afternoon rainshowers or thunderstorms especially over the CAR.

#### II. EFFECTS

#### A. Incidents Monitored

- The following incidents related to National and Local Election 2019 were monitored in some parts of the country:
  - Malfunctioned Vote Counting Machine (VCM's)
  - Protest Rally
- 2. Shooting Incident in Victoria, Oriental Mindoro (MIMAROPA)
  - On 11 May 2019, 10:15 AM, a shooting incident occurred in Brgy. Villa Cerveza, Victoria, Oriental Mindoro involving a personal body guard of a Vice-Mayor candidate. The victim was shot to death by six (6) unidentified suspects and was declared dead on the spot.

Note: Casualty is still subject for verification and validation of DILG-MDM.

# **III. PREPAREDNESS MEASURES**

# C. National Disaster Risk Reduction and Management Council (NDRRMC)

# 1. NDRRM Operations Center

- a. Raised its alert status to BLUE effective at 12 May 2019, 8:00 AM (Sunday).
- b. NDRRMOC disseminated updates and advisories through text messages, facsimile, email and other means of communication to NDRRMC Member Agencies and RDRRMCs/OCDRCs to that effect. Consequently, representatives from BFP and PNP rendered duty at the NDRRMOC as Detailed Duty Officers (DDOs) to ensure prompt coordination.
- c. Coordinated with all Chairpersons, RDRRMCs/OCD Regional Directors to gather reports on preparedness measures and related incidents with various activities and actions taken by its respective agency and local offices.

# 2. DOST – Philippine Atmospheric, Geophysical and Astronomical Services Administration (DOST-PAGASA)

- a. Provided a Special Weather Outlook for Election 2019 on 10 May 2019.
- b. Monitored the weather situation and provided updates and advisories to NDRRMC Member-Agencies and other stakeholders.

# 3. Department of Health (DOH)

- Monitored and coordinated with DOH Centers for Health Development and attached agencies for any eventuality that occured during the entire election period.
- b. Deployed HEMB personnel to render duty at the COMELEC Command Center in Parañaque City.
- c. Provided first aid kits worth ₱240,894.00 to CHDs CALABARZON, MIMAROPA, and VII.

# 4. Department of Energy (DOE)

- a. Activated the Energy Task Force Election (ETFE) on 04 February 2019 through Department Circular No. DC2018-05-0014 entitled "Creating the Energy Task Force Election to Ensure Adequate and Reliable Energy Supply Before, During, and after Elections".
- b. Conducted 2<sup>nd</sup> Preparedness Meeting in coordination with COMELEC of the ETFE on 22 March 2019.
- c. Conducted final coordination meeting together with COMELEC on 02 May 2019 to discuss the specific contingency plans to critical energy facilities and COMELEC's servers, and actions taken and final preparations.

# 5. National Electrification Administration (NEA)

Established the NEA Power Task Force Election (NPTE) 2019 to ensure that the Electric Cooperatives (ECs) will provide adequate and reliable power in respective areas before, during, and after elections.

# 6. National Grid Corporation of the Philippines (NGCP)

Coordinated with power plants under going commissioning to expedite testing prior to the election period to augment power supply.

# 7. Philippine National Police (PNP)

Deployed a total of 145,502 personnel to provide security in various locations such as Voting centers, canvassing centers, warehouse and hubs, and election monitoring action centers.
