I. SITUATION OVERVIEW

A. CHRONOLOGY OF EVENTS

01 July 2019

At 4:00 AM, the center of Tropical Depression (TD) "EGAY" was located at 195 km East Northeast of Aparri, Cagayan or 205 km East of Calayan, Cagayan (18.90°N, 123.4°E) with maximum sustained winds of 45 km/h near the center and gustiness of up to 60 km/h. It moved Northwest at 40 km/h. Southwest Monsoon affected Luzon and Visayas.

Rains with gusty winds due to TD EGAY was experienced over Batanes and Babuyan group of Islands. Cloudy skies with scattered



rainshowers and thunderstorms was expected over the provinces of Aurora, Ilocos Norte, Ilocos Sur, La Union, Pangasinan, Apayao, Abra, Benguet, Mt. Province, Ifugao, Kalinga, Isabela, Quirino, Nueva Vizcaya, and the rest of Cagayan caused by Southwest monsoon.

Moderate to strong winds coming from the Southwest prevailed over Northern Luzon and in Aurora Province. The coastal waters were forecasted to be moderate to rough.

02 July 2019

Monsoon rains was experienced over Zambales, Bataan, Occidental Mindoro and Northern Palawan due to Southwest Monsoon while light to moderate rains prevailed over Metro Manila, Cavite, Batangas, Pampanga, rest of Mindoro and of Palawan.

03 July 2019

The effect of Southwest Monsoon (HABAGAT) weakened. However, light to moderate rains and isolated thunderstorms still prevailed over Pangasinan, Zambales, Bataan, and Palawan.

II. EFFECTS

B. Affected Population

A total of **68 families / 270 persons** were affected in Bulacan and Zambales of which, **38 families / 120 persons** were served inside and outside the evacuation centers (ECs).

C. Incidents Monitored

1. Rock Fall Incident

- One (1) rock fall incident was reported in Sitio Dugo, Brgy. Gonogon, Bontoc, Mountain Province on 24 June 2019, at around 11:00 AM.
- The incident resulted in the obstruction of the national road.
- No casualties were reported and the road was totally cleared of debris as of 25 June 2019, 1:00 PM.

2. Landslide / Soil Erosion

- Four (4) incidents of landslide / soil erosion were reported in Region VI on 01 July 2019.
- Three (3) landslides affected some portions of national roads in Bugasong, Antique and Igbaras, Iloilo while the other incident had caused damaged to a building and temporarily suspended the construction at Moscoso Rios National High School.
- No reported individuals were affected in all reported incidents.

D. Suspension of Classes (TAB A)

Classes in 124 cities/municipalities in Regions II, III, CALABARZON, and VI were suspended due to TD "EGAY".

E. Status of Lifeline

1. Airport

Two (2) domestic flights were cancelled on 01 July 2019 due to the bad weather.

III. DISASTER PREPAREDNESS

A. NATIONAL DRRM COUNCIL (NDRRMC)

1. NDRRM Operations Center (NDRRMOC)

Conducted continuous monitoring and ensured dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories to all concerned RDRRMCs/OCDROs through SMS, facsimile, and official social media websites for further dissemination to its respective Local Disaster Risk Reduction and Management Councils (LDRRMCs).

2. DOST-PAGASA

Conducted continuous weather monitoring and provision of weather updates.

3. Department of Social Welfare and Development (DSWD)

- a. Placed the Disaster Response Management Bureau (DRMB) on BLUE Alert Status and coordinated with the concerned DSWD-Field Offices for significant disaster preparedness for response updates.
- b. Placed all QRT members and emergency equipment on standby and ready for deployment
- c. DSWD Central Office (CO), Field Offices (FOs), and National Resource Operations Center (NROC) ensured the availability of stockpiles and standby funds amounting to ₱1,974,755,075.16 with breakdown as follows:

• Standby Funds

A total of ₱1,174,771,923.28 standby funds in the CO and FOs. Of the said amount, ₱1,128,751,613.00 is the available Quick Response Fund (QRF) in the CO.

• Stockpiles

A total of **319,478 Family Food Packs (FFPs)** amounting to **₱122,137,558.80** and available **Food and Non-food Items (FNIs)** amounting to **₱677,845,593.08**.

4. Department of the Interior and Local Government (DILG)

- a. Recommended pre-emptive evacuation in areas with high to very high susceptibility to flooding and landslide as identified by PAGASA and DENR-MGB.
- b. Recommended that all LGUs which are not in the list of MGB's high to very high susceptibility to floods and rain-induced landslides but have recently experienced landslides, thunderstorms and heavy rainfalls be advised to take extra precautionary measures in conducting critical preparedness actions in anticipation for possible flooding, especially areas prone to landslide.
- c. CODIX continuously provided advisories and updates re TD "EGAY" to all DILG regional and field offices and to relay same to all concerned LGUs.
- d. DILG Regional and Field Offices recommended to all concerned LGUs the following actions:
 - Establish critical preparedness actions based on the Operation LISTO protocols and prioritized prepositioning of supplies and equipment for response.
 - Activate the Barangay DRRMCs for early warning measures and vigilant monitoring of areas with settlements at the base of sliding slopes or ridges with manifestations of rockslide/landslide, tension cracks, and areas identified as very high/critical landslide zones.
 - Monitor and report the impending weather disturbances and other incidents.
 - Inform/advise all communities through but not limited to the local television channels and radio stations of the updates of the situation and preparedness actions of the localities.
 - Monitor the levels of river water and settlements in low-lying areas or near riverbanks which experienced recent and repeated flooding.
 - Monitor the possible riverbank erosion and shift of river flow direction.
 - Monitor and prepare the necessary preparedness actions for possible dam overflow and release of water that may affect the communities.
 - Prepare and implement pre-emptive evacuation and forced evacuation protocols, if necessary, in areas with high to very high susceptibility to storm surges, landslide, and flood.
 - Ensure communication lines are working.
 - Restrict or ban tourist activities such as, but not limited to,

mountaineering/hiking, surfing, and diving within its areas of jurisdiction during the period.

- Warn small-scale miners to stay in safer grounds and avoid any mining activities.
- Advise coastal barangays re Storm Surge Watch as well as barangays included in the list of high-to-very high susceptibility to landslides and floods to consider pre-emptive evacuation.
- e. Conducted pre-emptive evacuation in Castillejos, Zambales of which, a total of 20 families / 47 persons were evacuated from Sitio Pagong, Brgy. Balaybay to Balaybay Evacuation Center on 01 July 2019, 3:00 PM.

5. Department of Health (DOH)

- a. Attended the Pre-Disaster Risk Assessment at the NDRRMC.
- b. Raised Code White Alert.
- c. Issued alert Memorandum to all Centers for Health Development (CHDs) and hospitals on the following:
 - Weather Disturbance
 - Activation of Code Alert and 24/7 Operations Center
 - Health Emergency Response Teams are on standby and ready for deployment
- d. Monitored and coordinated with affected CHDs and NDRRMOC on any healthrelated incidents that were monitored and responded accordingly.

Center for Health Development (CHD)

- Alerted all provincial DOH Offices to actively monitor and report untoward incidents in its respective area of responsibility.
- Prepositioned assorted medicines in the provinces through the Provincial DOH Offices.
- Alerted all DOH Regional Hospitals for possible augmentation.
- Coordinated with the Provincial DOH Offices (PDOHOs), Provincial Health Offices (PHOs), Office of Civil Defense (OCD), Regional and Local Disaster Risk Reduction Management Councils.
- Monitored any untoward incidents related to the effects of TD "EGAY" and Southwest Monsoon Rains.

B. REGIONAL DRRM COUNCILS (RDRRMC)

RDRRMCs CAR, NCR, II, III, CALABARZON, and VI continuously monitored its respective areas of responsibility. Further, said RDRRMCs coordinated with its member agencies to ensure the widest dissemination of Weather Advisories, 24-hour Public Weather Forecasts, and General Flood Advisories through SMS, facsimile, and official social media websites.

1. RDRRMC CAR

OCD CAR

- a. Issued Cordillera RDRRMC Memo No. 31, s. 2019 to maintain the BLUE alert status of the Emergency Operations Center.
- b. Issued Cordillera RDRRMC Memo No. 27, s. 2019 alerting all P/MDRRMOs regarding the possible threats of the weather disturbance specifically to:
 - Utilize all Early Warning Systems (EWS) such as the use of Public Address Systems, SMS, social media, radio stations, and text blast systems to ensure the widest dissemination of timely weather and safety advisories.

- Ensure the implementation of pre-emptive evacuation in identified high risk areas.
- c. Issued an advisory for the public to refrain from doing outdoor activities such as caving, spelunking, surfing, mountaineering and other similar activities; and avoid going to landslide and flood-prone areas.
- d. Revisit its respective Contingency Plans for Hydromet hazards for possible activation and implementation.
- e. Coordinated with PAGASA Baguio Synoptic Station and sent weather advisories to the public, LDRRMCs, and member agencies of the Cordillera RDRRMC.
- f. Coordinated with the Local Disaster Risk Reduction and Management Councils (LDRRMCs) within the region relative to the weather status, road conditions, and reported incidents.
- g. Sent weather advisories and warning alerts through text blasts, social media accounts and in all available means of communication in partnership with PIA-CAR and local media outlets to all stakeholders through all means of communication.
- h. Issued preparedness tips to prevent any possible eventualities due to the enhanced southwest monsoon and localized thunderstorms.
- Conducted blasting operations on 26 June 2019 at Kennon Road, Camp 7, Baguio City as a preventive measure to breakdown boulders posing dangers to the public during typhoon season with the assistance of DENR – CAR, Regional Office Cordillera, Baguio City DRRMO, and Philex Mining Corporation.
- j. Conducted PDRA meeting on 30 June 2019 to assess the possible effects of TD "EGAY" and the Southwest Monsoon in the region.

Department of Science and Technology CAR

Installed, monitored, and maintained 30 Community-Based Flood Early Warning Systems (CBFEWS) stations in coordination with LGUs and DOST-ASTI.

PAGASA Baguio Synoptic Station

Monitored the AOR and provided weather updates or forecast for dissemination.

Department of Social Welfare and Development Cordillera

- a. Coordinated with the Armed Forces of the Philippines (AFP) relative to the utilization of its warehouses for prepositioning of various food and non-food items (F/NFIs) in the various provinces of CAR.
- b. Coordinated with the PNP-PROCOR for mobility support and for the utilization of police stations as warehouses for the NFIs.
- c. Ensured the availability of standby funds, and prepositioned Food and Non-Food Items (F/NFIs) for possible response/augmentation.

Department of Public Works and Highways

- a. Issued Situational Reports on national roads and bridges.
- b. Prepositioned a total of 57 heavy equipment and 93 tools/light equipment owned by DPWH-CAR at the regional/ district engineering offices.
- c. Prepositioned 95 privately-owned heavy equipment all over CAR ready for possible augmentation.
- d. DPWH-CAR maintained its 24/7 monitoring of road status through the Maintenance Division.

Department Environment and Natural Resources CAR

a. Monitored trees (dead or alive) that poses danger for possible pruning/cutting.

b. Coordinated with its local counterparts, electric cooperatives, and other stakeholder for monitoring and possible augmentation.

Commission on Higher Education CAR

- a. Advised delegated safety officers in different colleges or universities to conduct safety inspection.
- b. Placed on stand by for possible monitoring of class suspensions.

Armed Forces of the Philippines

Placed 503rd IBde, 5th ID, PA; TOG 1-PAF; PMA-DRTG, and 14th CAR RCDG ARESCOM manpower and capabilities/resources on standby for possible deployment.

Police Regional Office Cordillera

- a. Placed on heightened alert and monitored the AOR.
- b. Placed the PNP-PROCOR personnel and capabilities/resources on standby for possible response augmentation.

Bureau of Fire Protection Cordillera

- a. Placed on heightened alert and monitored the AOR.
- b. Placed the BFP-CAR personnel and capabilities/resources on standby and oncall to extend assistance or response in case of emergencies and other eventualities.

Philippine Information Agency Cordillera

Disseminated public advisories and warning alerts to the public through text blasts, social media accounts, and various media.

Disseminated public advisories and warning alerts to the public through text blasts, social media accounts, and various media.

- a. Raised the alert status to BLUE for the Matagaoan Festival.
- b. Monitored the AOR and coordinated with various agencies and stakeholders.

2. MMDRRMC NCR

OCD NCR

- a. Facilitated the conduct of PDRA Meeting on 26 June 2019 at the Metro Manila Crisis Management and Monitoring Center (MMCMMC) presided by the Regional Director, OCD-NCR.
- b. Monitored the situation relative to the event.

DILG NCR

Issued a Memorandum to all DILG NCR City Directors for the submission of preparedness measures within the AOR.

DSWD NCR

a. Prepositioned stockpile of commodities consists of 6,084 family food packs, 700 sacks of NFA rice, 8,653 plastic mats, 6,044 blankets, 12,608 mosquito nets,

5,072 family kits, 5,221 dignity kits, 7,759 hygiene kits, and 5,345 malong in Legarda and NROC.

- b. Ensured the availability of standby funds amounting to ₱3,292,543.50 for emergency purchase.
- c. Conducted regular monitoring of weather conditions.
- d. Consolidated monitored reports gathered 24/7.
- e. Provided disaster assistance to LGUs.
- f. Placed four (4) standby vehicles for response operations.
- g. Placed the Quick Response Teams and riders on standby and ready for deployment.

Metro Manila Development Authority (MMDA)

Conducted continuous monitoring of the flooding situations in Metro Manila.

CDRRMC Mandaluyong

- a. Conducted a council meeting on 20 June 2019 and discussed the rainy season and its effects in Mandaluyong City.
- b. Placed the CDRRM Office Operations Center to continue monitoring the weather situation and disseminate information re weather updates and flooded areas through various channels as necessary.
- c. Placed all Barangay and City responders on standby alert due to the enhanced Southwest Monsoon.
- d. REACT Mandaluyong Tiger Group provided situation reports.
- e. Placed the Barangay Volunteer Groups on standby alert for possible deployment.

CDRRMC Navotas

- a. Conducted trainings and workshop to volunteers and the community.
- b. Developed comprehensive planning processes between the public and private sectors.
- c. Ensured complete interoperable communications capabilities between all responders and the barangays.
- d. Provided relevant weather information to the barangay level.
- e. Placed CDRRMO on 24/7 monitoring and response team on standby.

CDRRMC Parañaque

- a. Placed the EOC on White status / normal operations to monitor the AOR, raised the alert status whenever necessary.
- b. Coordinated with the 16 Barangay DRRM Committees and CDRRM Council member agencies, and disseminated information about current situation and possible flooding secondary to heavy rain through all communication platforms.
- c. Prepared water rescue assets for possible WaSAR operations.
- d. BFP Parañaque prepared standby teams to augment possible WaSAR operations.
- e. DILG Parañaque coordinated with DRRMO regarding preparedness measures ICOW Habagat and monitored the situation within the AOR.
- f. CENRO / DPWH conducted declogging of drainages in the main thoroughfare and major roads to mitigate flooding in some areas within the AOR, desilting and dredging of water ways, and clean-up drive in the coastal area.

CDRRMC Pasig

- a. Placed on 24/7 monitoring through the City Command Center.
- b. Monitored the weather forecast relative to the event.
- c. Coordinated with barangays and school on the status of its AOR.
- d. Disseminated weather advisories via quad-media.

MDRRMC Pateros

- a. Placed the Pateros DRRM Office Rescue Unit on Code White status and raised whenever necessary.
- b. Placed on 24/7 continuous weather monitoring.
- c. Prepositioned the Emergency First Responders personnel of Pateros Rescue Unit on standby and on- call status.
- d. Instructed the Pateros Business District Administration Office and Traffic Enforcement Unit personnel to augment on the monitoring of flooded areas and response operations.
- e. Ensured that two (2) wooden boats and one (1) fiber plastic Urban Search and Rescue boats and personal protective gears are readily available, and placed trained flood rescuers and volunteer groups on standby.
- f. Prepositioned the Emergency Response Teams ready to be deployed accordingly for assistance purposes.
- g. Municipal Social Welfare and Development Office (MSWDO) and Pateros Health Department – Health Emergency Management Staff on standby in case of eventualities.

CDRRMC San Juan

- a. Disseminated alert notices, warnings, and advisories.
- b. Placed San Juan DRRM Office on Blue alert on 25 June 2019 and disseminated advisories to all BDRRMCs.

CDRRMC Taguig

- a. Prepositioned response/rescue teams, EMS, transport and response vehicles ready for deployment.
