STANDBY STATUS OF RESPONSE CLUSTERS ICOW ASIA-PACIFIC MINISTERIAL CONFERENCE ON DISASTER RISK REDUCTION

(APMCDRR)

This refers to the approved National Emergency Preparedness and Response Plan for the Asia-Pacific Ministerial Conference on Disaster Risk Reduction (APMCDRR) to be conducted on 14-18 October 2024 at the Philippine International Convention Center in Manila. The APMCDRR serves as the primary platform for Asia-Pacific nations to review, monitor, and enhance the implementation of the Sendai Framework for Disaster Risk Reduction 2015-2030.

With this, all NDRRMC Response Clusters are placed on standby status from October 14, 2024 (Monday) to October 18, 2024 (Friday) to monitor and facilitate needed response and humanitarian assistance in case of emergency.
