
The RTF/IACC Kanlaon shall establish its Emergency Operations Center (EOC) in Bago City, Negros Occidental. All member agencies are required to send in-person representatives to the EOC to ensure effective coordination and response.

OCDROs VI and VII shall allocate the necessary personnel to support and sustain the Task Force/IACC operations. Moreover, ensure that necessary horizontal and vertical coordination is being undertaken.

This Memorandum Order surpercedes and rescinds the previously issued NDRRMC Memorandum No. 304 dated 11 November 2024.
