# SitRep No. 3 for TC MARCE (2024)

# November 08, 2024 08:00 am

On 04 November 2024, 2:00 AM, the Tropical Depression intensified into a Tropical Storm as it entered the Philippine Area of Responsibility (PAR) and was assigned the domestic name MARCE. At 11:00 AM, MARCE slightly intensified as it moves West Northwestward over the Philippine Sea. At 5:00 PM, MARCE further intensified over the Philippine Sea east of Bicol Region. By 11:00 PM, MARCE intensified into Severe Tropical Storm as it undergoes rapid intensification. Tropical Cyclone Wind Signal No. 1 was hoisted in Batanes, the northern and eastern portions of Cagayan including Babuyan Islands, the eastern portion of Isabela, the northern portion of Apayao, and the northern portion of Ilocos Norte.

On 05 November 2024, 5:00 AM, MARCE slightly intensified and was nearing Typhoon category. By 11:00 AM, MARCE intensified into a Typhoon. At 5:00 PM, MARCE slightly intensified over the Philippine Sea East of Isabela. At 11:00 PM, MARCE further intensified as it moves West Northwestward over the Philippine Sea. Tropical Cyclone Wind Signal No. 2 was hoisted over the northeastern portion of mainland Cagayan.

On 06 November 2024, 5:00 AM, MARCE maintained its strength as it moves Northwestward over the Philippine Sea. At 8:00 AM, MARCE decelerated over the Philippine Sea East of Northern Luzon. At 11:00 AM, Typhoon MARCE threatened Babuyan Islands and Northern Mainland Luzon as it further intensifies. Tropical Cyclone Wind Signal No. 3 was raised over the northeastern portion of mainland Cagayan. At 11:00 PM, MARCE further intensified as it moves West Northwestward toward the Northern Mainland Cagayan-Babuyan Islands area. At 5:00 PM, MARCE is started to become almost stationary over the waters East of Northern Cagayan. At 8:00 PM, MARCE continued to threaten the Northern Mainland Cagayan-Babuyan Islands area. At 5:00 PM, MARCE is Northwestward toward the Northern Bands area. At 11:00 PM, MARCE further intensified as it moves West Northwestward to the Northern Babuyan Islands area. At 11:00 PM, MARCE further intensified as it moves West Northwestward the Northern Babuyan Islands area. At 11:00 PM, MARCE further intensified as it moves West Northwestward toward the Northern Babuyan Islands area.

On 07 November 2024, 2:00 AM, MARCE maintained its strength as it accelerates toward the Northern Mainland Cagayan-Babuyan Islands area. At 5:00 AM, MARCE continued to threaten the Northern Mainland Cagayan-Babuyan Islands area. Tropical Cyclone Wind Signal No. 4 was hoisted over Cagayan, Babuyan Islands, and Apayao. At 11:00 AM, MARCE continued to intensify and was dangerously approaching Northeastern Cagayan. At 2:00 PM, MARCE was about to make landfall in Santa Ana, Cagayan and was near Super Typhoon strength.

At 3:40 PM, the center of the eye of Typhoon MARCE made landfall in the vicinity of Santa Ana, Cagayan as it nears Super Typhoon strength. Life-threatening conditions persisted over northeastern Cagayan. At 8:00 PM, life-threatening conditions continued over the northern portions of Cagayan, Apayao, and Ilocos Norte as MARCE moves over the Babuyan Channel.

At 9:00 PM, the center of the eye of Typhoon MARCE made its second landfall in the vicinity of Sanchez-Mira, Cagayan. Life-threatening conditions continued over the northern portions of Cagayan, Apayao, and Ilocos Norte.

On 08 November 2024, 2:00 AM, life-threatening conditions persist over the northern portions of Cagayan, Apayao, and Ilocos Norte as MARCE moves generally Westward over Ilocos Norte. At 5:00 AM, MARCE continues to weaken and is now over the sea West of Ilocos Norte.

Luzon: The southern and western portion of Babuyan Islands (Fuga Is., Dalupiri Is., Calayan Is., Camiguin Is.), the northern and western portions of Cagayan (Piat, Santo Niño, Rizal, Aparri, Lasam, Camalaniugan, Buguey, Santa

Teresita, Allacapan, Pamplona, Abulug, Ballesteros), the rest of Apayao, the central portion of Abra (Lacub, San Juan, La Paz, Bangued, Langiden, San Quintin, Pidigan, Malibcong, Peñarrubia, Bucay, Licuan-Baay, Lagangilang, Dolores, Tayum, Sallapadan, San Isidro), and the northern portion of Ilocos Sur (Santo Domingo, San Vicente, Santa Catalina, Bantay, San Ildefonso, City of Vigan, Caoayan, Santa, Narvacan, Nagbukel, Magsingal, San Juan)

#### TCWS No. 2 Wind threat: Gale-force winds

Luzon: The southern portion of Batanes (Mahatao, Uyugan, Basco, Ivana, Sabtang), the rest of Babuyan Islands, the rest of mainland Cagayan, the northern and western portions of Isabela (San Pablo, Santa Maria, Tumauini, Maconacon, Cabagan, Santo Tomas, Quezon, Mallig, Delfin Albano, Quirino, Gamu, Roxas, Burgos, Reina Mercedes, Luna, Aurora, San Manuel, San Mateo, Cabatuan), the rest of Abra, Kalinga, Mountain Province, the northern portion of Ifugao (Alfonso Lista, Aguinaldo, Mayoyao, Banaue, Hungduan), the northern portion of Benguet (Bakun, Mankayan), the rest of Ilocos Sur, and the northern portion of La Union (Sudipen, Bangar, Balaoan, Luna, Santol, Bacnotan)

# TCWS No. 1 Wind threat: Strong winds

Luzon: The rest of Batanes, The rest of La Union, Pangasinan, the rest of Ifugao, the rest of Benguet, the rest of Isabela, Quirino, Nueva Vizcaya, the northern and central portions of Aurora (Dilasag, Casiguran, Dinalungan, Dipaculao), the northern portion of Nueva Ecija (Carranglan), and the northern portion of Zambales (Santa Cruz, Candelaria)

3. Monitor with vigilance the level of river waters and settlements in low-lying areas, such as rice lands or near riverbanks, which have experienced recent and repeated flooding, and vigilant monitoring for possible riverbank erosion and shift of river flow direction;

4. Implement PREEMPTIVE EVACUATION in areas with moderate to very high susceptibility to floods and landslides, especially residents whose dwellings are susceptible to damage due to strong winds;

5. Conduct pruning of trees/vegetation and clearing of waterways (canals, drainages, etc.);

6. Ensure that physical distancing is always observed in the evacuation centers and constantly remind evacuees to always properly wear their face masks inside evacuation centers;

7. Ensure that communication lines are working properly;

8. Restrict or ban tourist activities such as, but not limited to, mountaineering, hiking, surfing, diving, etc., within their areas of jurisdiction during this period;

9. Warn small-scale miners to stay on safer grounds and stop all mining activities; and

10. Enforce a No-Fishing policy and ensure that sea travel and small-scale fishing activities are closely monitored and prohibited if gale warnings are issued.

-Continuous close coordination with the concerned DILG Regional Offices and other concerned stakeholders. -Continuously provided all available information (i.e., PAGASA's Global Spectral Model/Weather Research Forecasting Model Forecast Rainfall, Severe Weather Bulletins, and Tropical Cyclone Warning for Shipping; and MGB's Updated Barangay List of LGUs Prone to Landslide, Debris Flow and Flood) to all DILG Regional and Field Offices and other concerned stakeholders regarding the possible effects of TC MARCE thru social media and emails.

-Issued DA Bulletin No. 1, 2, 3 on TC "MARCE" advising farmers and fisherfolks to perform the following preparedness measures:

1. Regularly monitor the latest local weather information;

2. Harvest mature crops and mobilize post-harvest equipment and facilities;

3. Secure seed reserves, planting materials and other farm inputs in safe and proper storage areas;

4. Relocate farm machineries, equipment and other farm tools to higher ground;

5. Secure sufficient feeds and water for relocated animals;

6. Clear drainage in irrigation and rice paddies from obstructions to prevent flooding and promote fast drainage of water.

7. Perform early harvest and mobilize post-harvest equipment and facilities;

8. Secure fishing vessels in higher ground; and

9. Plan or dismiss sea travel as potentially rough conditions may prevail over the next days over affected seaboards.

The DA RFOs that may be affected by Typhoon MARCE have undertaken the following:

1. Activation of Red Alert Status on DA Regional DRRM Operations Centers;

2. Positioning of seeds for rice, corn and high value crops; drugs and biologics for livestock and poultry; fish stocks and paraphernalia on fisheries;

3. Close coordination with RDRRMCs, LGUs and other concerned agencies in implementing preparedness measures on the impact of TY Marce

4. Monitoring of prices and movement of agricultural commodities; and

5. Allocation of funds for insurance and credit by the Philippine Crop Insurance Corporation (PCIC) and Agricultural Credit Policy Council (ACPC), respectively.
