Kanlaon Volcano Eruption (2024)

SitRep No. 63 for Kanlaon Volcano Eruption (2024)

May 23, 2025 08:00 am

On 09 December 2024, an explosive eruption occurred at the summit vent of Kanlaon Volcano from 3:03 PM to 3:10 PM. The eruption produced a voluminous plume that rapidly rose to 4,000 meters above the vent and was bent and drifted by strong winds to the west-southwest. Pyroclastic density currents or PDCs descended the slopes on the general southeastern edifice based on IP and thermal camera monitors.

Ashfall was reported over a wide area west of the volcano while pyroclastic density currents or PDCs, hazardous mixtures of hot volcanic gas, ash, and fragmented rock, were generated at the base of the eruption column and descended the south-southeastern sides of the edifice based on camera monitors. The longest descent of the PDCs from the summit crater was estimated to be approximately 2 to 3.4 kilometers in Masolog, La Castellana, still within the four kilometer radius of the Permanent Danger Zone (PDZ).

In view thereof, DOST-PHIVOLCS raised the Alert Level of Kanlaon Volcano from Alert Level 2 (increasing unrest) to Alert Level 3 (magmatic unrest). This means magmatic eruption have begun that may progress to further explosive eruptions. All local government units are advised to evacuate the 6-km radius from the summit of the volcano and must be prepared for additional evacuation if activity warrants.

On 08 April 2025, 5:51 AM, a moderately explosive eruption occurred at the summit crater of Kanlaon Volcano. This lasted for 56 minutes based on seismic and visual recordings and generated a gray voluminous plume that slowly rose to 4,000 meters above the vent before bending and drifting west and southwest. Audible rumbling sounds of the eruption was reported. PDCs descended the southern slopes within a kilometer of the crater, in the jurisdiction of La Castellana, based on visual and thermal camera monitoring. Large ballistic fragments were also observed to have been thrown around the crater within a few hundred meters and caused burning of vegetation near the volcano summit. Thin ashfall has been reported in some areas of Negros Occidental and Negros Oriental.

Alert Level 3 (magmatic unrest) still remains over Kanlaon Volcano. This means that the explosive eruption may be followed by similar short-lived explosive eruptions in the short term or even progress to lava eruptions that generate lav flows and lava fountaining activity.

- Suspension of Classes and Work: Classes and work in local government offices have been suspended to reduce exposure to ash-fall and other volcanic hazards
- Health Advisories: The LGU has issued health advisories, including the distribution of masks, to protect residents from respiratory issues caused by ash inhalation.
- Resource Allocation: Efforts are underway to provide food, water, and medical assistance to evacuees, ensuring their well-being during displacement.
- Evacuation Orders: Communities within a 6-kilometer (3.7-mile) radius of Kanlaon Volcano have been evacuated to prevent harm from pyroclastic flows, ashfall, and other volcanic hazards.
- Alert Level: The Philippine Institute of Volcanology and Seismology (PHIVOLCS) has issued an Alert Level 3, which indicates a heightened possibility of a hazardous eruption. Local authorities are preparing for the potential escalation to Alert Level 4.
- Safety Zones: The Permanent Danger Zone (PDZ) is strictly off-limits. Entry into the Extended Danger Zone (EDZ) has also been restricted.
- Community Support: Emergency shelters have been established for evacuees. Relief goods and medical assistance are being distributed.
- Air Travel Advisories: Flights near Kanlaon Volcano have been advised to avoid the area due to ash plumes that may cause engine damage.
- Information Dissemination: Continuous monitoring updates are being provided by PHIVOLCS and local authorities. Residents are advised to monitor radio, television, and online platforms for the latest announcements.
- Preparation Measures: Stockpiling of food, water, and medical supplies in case of prolonged Evacuation. Local authorities have conducted emergency drills and are coordinating with disaster response teams.
- Volcanic Ash Precautions: Residents in nearby areas have been advised to:
- Wear masks and goggles to protect against ashfall.

- Keep doors and windows closed to prevent ash from entering homes.
- Avoid outdoor activities unless necessary.
- Evacuations: Residents within the six-kilometer Permanent Danger Zone (PDZ) have been evacuated to ensure their safety. As of December 23, 2024, approximately 1,787 families, totaling 5,794 individuals, are housed in ten evacuation centers in Canlaon City.

- -In Camp 7, QRT camp personnel led the Getting to Know You activity and Psychosocial Processing sessions were conducted with 32 participants aged 19-59 years and 8 participants aged 60 and above. QRT camp personnel in Camp 2 facilitated a Child Friendly Space activity for children aged 5-10 years, in collaboration with the Child Development Workers.
- -- The QRT Team in Camp 7 conducted Child-Friendly Spaces (CFS) activities, which included dance and coloring sessions, as well as sports activities for the IDPS.
- -In Camp 6, QRT personnel assisted in the conduct of the CFS Team Building with 42 participants (14 toddlers and 28 school-age children), featuring activities such as team-building games, problem-solving relays, and creative expression for toddlers.
- -The DSWD Camp Personnel from Team 1 conducted a brief turnover of roles and responsibilities to the Team 2 Camp personnel ensuring a smooth transition for continued operations.
- -The DSWD 7 QRT led by the Action Officer with the PSWDO-Negros Oriental QRT gathered to review and prioritize the deliverables from the turnover briefing. It was agreed that PLGU staff would shadow DSWD 7 camp personnel to gain practical experience in Camp Coordination and Camp Management.
